In committee, the bill can be ignored or amended.

This is where most bills die.

Few go on to the full body for debate.

During debate, the bill may be amended again.

IF A MAJORITY THEN VOTES IN FAVOR

Once both houses have voted in favor of a bill

they send it to the president.

If the president signs the bill, it becomes law.

It takes a 2/3 majority vote in both houses
