Enforcing laws and agency regulations to protect the public, the environment, businesses, and other entities against harmful practices, threats, and dangers.

The product of an evidentiary hearing is an order.

The structure and process of agency evidentiary adjudication is broadly controlled by procedural due process under the US Constitution's Fifth and Fourteenth amendments, as well as by administrative law provisions.

Unlike notice and comment rulemaking, where the model seeks to replicate an idealized version of how legislatures in the United States make law, administrative evidentiary adjudication is not intended to match courtroom procedure.

Rather, the objectives are fourfold: to achieve fairness, to adjudicate competently, to resolve conflicts efficiently, and to accomplish all while enhancing, or at least not impeding, organizational performance.

Fairness is usually gauged in terms of how the parties to an adjudication believe they were treated. Competence is measured by the extent to which hearing examiners and agencies' decisions are upheld on appeal.

Organizational performance can involve any number of factors, including the impact of adjudication on resources, coherent decision making, and personnel systems.

In practice, it is difficult for adjudicatory systems to excel in all four dimensions simultaneously.

Evidentiary adjudication also differs from formal rulemaking in that it is retrospective rather than prospective.
