Dose-Response In a typical dose-response bioassay, lab rats are fed a single concentration of the chemical being tested Some rats get a really high dose, others get doses that range from moderate to low Exposure is given on the first day (via food, water, air, intravenously, etc.) . At the end of the study, scientists count the number of dead rats

Most dose-response studies only last for 7-14 days • These studies are called acute studies because they are short in duration • Dose-response studies that last for longer are called chronic studies The end result of most dose-response experiments is mostly death Count how many individuals die after exposure to each concentration When you graph the data, the data usually S-shaped curve • At low dosages, almost none die At medium dosages, a few die

Dose-Response Studies The dosage at which you can first observe an effect is called the threshold The dosage that kills 50% of the individuals is called the LD or the lethal

The lower the LD, the more lethal the chemical is.. •LD values are measured in milligrams of chemical per kilogram of body weight The chart below shows toxicity certain chemicals

Botulin is an extremely toxin compound formed by bacteria in improperly canned foods; causes botulism, a sometimes fatal form of food poisoning Aflatoxin is a cancer-causing chemical created by

mold on grains and nuts and can be found in some peanut butter and other grain products Cyanide is a highly poisonous substance found in apricots and cherry pits and used in industrial processes such as making plastics, electroplating and pro chemicals -Vitamin D is an essential part of the h toxic in doses higher than those found in normal human
