Mirrors of Destruction

By 1944, the overwhelming majority of the German Army had participated in the German war of annihilation in the Soviet Union and historians continue to debate the motivations behind the violence unleashed in the east. Jeff Rutherford offers an important new contribution to this debate through a study of combat and the occupation policies of three frontline infantry divisions. He shows that while Nazi racial ideology provided a legitimizing context in which violence was not only accepted but encouraged, it was the Wehrmacht's adherence to a doctrine of military necessity which is critical in explaining why German soldiers fought as they did. Periods of brutality were intermixed with conciliation as the army's view and treatment of the civilian population evolved based on its appreciation of the larger context of war in the east.

The Wehrmacht

Those German forces that survived the artillery barrages, the onslaught of the tank armadas, and mass infantry assaults, streamed back from the battlefield and fought vicious battles through the Baltic States, Byelorussia, and built up new defense along the Vistula River in Poland. As the final months of the war were played out on the Eastern Front, the army and Waffen-SS, with diminishing resources, withdrew across a devastated Reich and fought out their last battle with party militia forces around a devastated Berlin.

First Winter on the Eastern Front

In the final year of the Second World War, as bitter defensive fighting moved to German soil, a wave of intra-ethnic violence engulfed the country. Bastiaan Willems offers the first study into the impact and behaviour of the Wehrmacht on its own territory, focusing on the German units fighting in East Prussia and its capital Königsberg. He shows that the Wehrmacht's retreat into Germany, after three years of brutal fighting on the Eastern Front, contributed significantly to the spike of violence which occurred throughout the country immediately prior to defeat. Soldiers arriving with an ingrained barbarised mindset, developed on the Eastern Front, shaped the immediate environment of the area of operations, and of Nazi Germany as a whole. Willems establishes how the norms of the Wehrmacht as a retreating army impacted behavioural patterns on the home front, arguing that its presence increased the propensity to carry out violence in Germany.

Violence in Defeat

Beginning towards the end of the Battle of Kursk, Retribution explores the massive Soviet offensive that followed Operation Zitadelle, which saw depleted and desperate German troops forced out of Central Ukraine. In this title, Buttar describes in detail the little-known series of

near-constant battles that saw a weakened German army confronted by a tactically sophisticated force of over six million Soviet troops. As a result, the Wehrmacht was driven back to the Dnepr and German forces remaining in the Taman Peninsula south of Rostov withdrew into the Crimea, a retreat which would become one of many in the months that followed.

Exhausted and demoralized skeletal units must have been aware of the impending defeat. Yet the German General Staff was still resolved to fight at all costs. By late March 1945, less than 100 miles east of Berlin, some 250,000 German troops had slowly withdrawn to the Oder, and what followed was a series of fierce and determined defensive actions that would finally see the Germans encircled and fighting the last desperate battle within Berlin itself against overwhelming odds.

Battleground Prussia

Between 1933 and 1939, the strength and influence of the SS grew considerably with thousands of men being recruited into the new ideological armed formation, many into units known as the SS-Verfgungstruppe (Special Disposal Troop). These troops saw action in Poland before switching to the Western Front in 1940. Out of this organisation the SS Das Reich Division was created. This book, with its extensive text and over 250 rare and unpublished photographs with detailed captions describes the fighting tactics, the uniforms, the battles and the different elements that went into making the Das Reich Division such a formidable fighting force. Facing scarce supplies and enormous casualties, the average soldier sank to ta a primitive level of existence, re-experiencing the trench warfare of World War I under the most extreme weather conditions imaginable; the fighting itself was savage, and massacres of prisoners were common. Troops looted food and supplies from civilians with wild abandon; they mercilessly wiped out villages suspected of aiding partisans. Incredible losses led to recruits being thrown together in units that once had been filled with men from the same communities, making Nazi ideology even more important as a binding force. And they were further brutalized by a military justice system that executed almost 15,000 German soldiers during the war. Bartov goes on to explore letters, diaries, military reports, and other sources, showing how widespread Hitler's views became among common fighting men--men who grew up, he reminds us, under the Nazi regime. In the end, they truly became Hitler's army. In six years of warfare, the vast majority of German men passed through the Wehrmacht and almost every family had a relative who fought in the East. Bartov's powerful new account of how deeply Nazi ideology penetrated the army sheds new light on how deeply it penetrated the nation. SS Grenadiers on The Russian Front
