The African and Chinese battles of the First World War Historian Edmund Dane wrote some excellent concise histories of various theatres of the First World War and the first work in this unique volume from Leonaur is one of them. There is much interest among students of the period in the campaigns fought in Africa which drew into conflict the regular troops of the principal protagonists together with a colourful array of colonial and imperial troops on both sides. This book covers Botha's campaign in South-West Africa, the East African Campaign which pitted Smuts against the exemplary generalship of von Lettow-Vorbeck and the campaigns in Togoland and the Cameroons. Dane includes in his book's title the campaign in the Pacific and although the single chapter dedicated to this topic is of undeniable interest the contemporary reader may judge the piece too short. To remedy this we have included an in depth work on the siege and fall of Tsingtau in China by an American journalist who was an eye-witness. This was a vital outpost for the Germans in the region. East Africa Volume 1. August 1914-September 1916. Official History of the Great War Other Theatres

This book is a collection of essays on neglected aspects of the Great War. It begins by asking what exactly was so "Great" about it, before turning to individual studies of various aspects of the war. These fall broadly into two categories. Firstly personal, micro-narratives that deal directly with the experience of war, often derived from contemporary interest in diaries and oral histories. Presenting both a close-up view of the viscerality, and the tedium and powerlessness of personal situations, these same narratives also address the effects of the war on hitherto under-regarded groups such as children and animals. The war for colonial Africa This very substantial book, written by the two South African official correspondents on the campaign, narrates the expedition in 1914-15 which led to the conquest of German South-West Africa (the region now known as Namibia). One author accompanied the Northern

Army and the other, the Southern Army. During the 19th century the great powers of Europe raced to establish themselves in all corners of the globe for colonisation, trade and political influence. In the 'great scramble for Africa, ' the British and German empires had established themselves, by degrees, in the east and west of the continent. In the years before the outbreak of the First World War these colonies existed, more or less, in harmony but once hostilities erupted German and British settlers found themselves living in very close proximity to hostile forces. The British had the advantage of numbers since colonisation had long been a policy, though the Germans compensated for this measure with the abilities of their military commanders and the expertise and quality of their European and locally raised troops. (South Africa itself entered the fray, its forces led by commanders who a little over a decade earlier had led the Boer burghers in their attempts to form a nation independent of the British Empire.) This campaign of mobility was fought in the searing heat of a desert region and was often a 'tip and run affair' as mounted troops traversed huge tracts of inhospitable terrain. Those interested in the First World War often find it's 'side-show' theatres fascinating because they differed so completely from the war of stalemate and attrition on the Western Front. This is a very thorough and comprehensive book written by competent authors who experienced the campaign at first hand and were well qualified to record both their personal impressions and an informed overview of the events they witnessed. Fighting for Britain

The S African part in the Great War began with operations to secure objectives in German South West Africa, but these had to be hastily abandoned when armed rebellion broke out back home, led by General Beyers, De Wet and others involving some 11,500 pro-German rebels. The rebellion lasted five months from September 1914 to February 1915 when they surrendered to General Botha and his force of 30,000, two thirds of whom were of Dutch descent. With the rebellion over the S Africans resumed the campaign for the conquest of German SW Africa. As the official historian points out, whereas the other Dominions' efforts were more or less centralized - Canadian Corps, Australian Corps, New Zealand Division - the S African activities were directed into diiverse operations that bore little relations to each other, and this is reflected in the structure of this history which is divided into several parts. The first part covers the initial operations in German SW Africa and the rebellion at home. Part II deals with the resumed operations, after the rebellion, in SW Africa. Parts III and IV are concerned with the German East African campaign in which S African troops played a large part. Perhaps the best known of the S African forces of the Great War is the S African Infantry Brigade which operated first out of Egypt against the Senussi tribesmen (Part V) and then on the Western Front (Part VI) where they earned the reputation of being among the finest troops in the BEF, and their action in Delville Wood during the Somme offensive is legendary. This Part VI takes up the main part of the book coverering almost one hundred pages. But they weren't the only S African troops in France. Five siege batteries, 71st to 75th each equipped with 6" Howitzers, arrived in France in April 1916 followed by a sixth (125th Battery) in July, but it wasn't till January 1918 that they were brought together forming two Heavy Artillery Groups, 44th and 50th. In Part VII the doings of each battery are treated separately. Also covered in this Part is a divisional signal company which became XV Corps Signal Company, the S African Medical Services in France, two railway companies and eight horse transport companies manned by Cape Coloured drivers. The final part, Part VIII, is given over to administration. The book concludes with the list of S African VCs with their citations, and the casualty (deaths) figures, shown by unit; they amounted to 12,452 of whom 8,551were combat troops. In all 220,196 S Africans served of whom 92,837 were Cape Coloured and S African Native personnel of the Labour Battalion and Corps.

The Union of South Africa and the Great War 1914-1918 Official History

The Great War is a landmark history that firmly places the First World War in the context of imperialism. Set to overturn conventional accounts of what happened during this, the first truly international conflict, it extends the study of the First World War beyond the confines of Europe and the Western Front. By recounting the experiences of people from the colonies especially those brought into the war effort either as volunteers or through conscription, John Morrow's magisterial work also unveils the impact of the war in Asia, India and Africa. From the origins of World War One to its bloody (and largely unknown) aftermath, The Great War is distinguished by its long chronological coverage, first person battle and home front accounts, its pan European and global emphasis and the integration of cultural considerations with political.

Africa and the First World War

This, the fourth in the eight volumes of the 18-volume official British History of the Second World War describing the war in the Mediterranean and Middle Eastern theatres, narrates the defeat of the Axis forces in North Africa in 1942-43. The survival of Malta against determined Axis assaults enabled the Allies to cripple supplies to Rommel's Afrika Korps, while building up their own land, air and sea forces. The entry of America to the war in December 1941 had allowed the allies to co-ordinate a grand strategy for the Mediterranean and Middle Eastern theatre. In October 1942, after careful preparation and a massive artillery bombardment, General Montgomery launched the Eighth Army against the Afrika Korps in the Battle of El Alamein, while in November, 'Operation Torch' the Anglo-American amphibious landings in French-ruled North Africa, scored an almost bloodless success and proved a dry run for D-Day in 1944. Squeezed between the Allied nutcrackers to the west and east, the Germans offered stubborn resistance in the Tunisia campaign of 1943, at the battles of Kasserine Pass and the Mareth Line, but after suffering severe casualties, the Allies broke through and the Axis forces in North Africa surrendered in May 1943. The text is supported by 12 appendices, 40 maps and diagrams and 44 photographs.

Legacy of Valour

This is a regimental history with a difference, one that is bound up with the history of the British Empire in Africa and the extension and development of British rule in the territories of Somaliland, British East Africa (redesignated Kenya from July 1920), Uganda, Nyasaland and, after 1918, Tanganyika (previously German East Africa). These were the territories that were the recruiting grounds for the KAR to which officers from the British Army were seconded - there were no permanent commissions in the KAR unlike the Indian Army which had its own officer structure. No regiment has ever been more intimately connected with the territory through which it marched and fought, or with the peoples from which it was recruited. It was a unique regiment. The author has arranged the book in five parts: The Campaigns of the Early Regiments: The Consolidation of the Regiment, 1901-1914; The East Africa Campaign, 1914-1918; Internal Security and Reorganization 1914-1939; and The War of 1939-1945. The story begins with the political background to the British administration in East and Central Africa up to the close of the nineteenth century. During the last decade of that century three regiments were formed which were the forerunners of the K.A.R - The Central African Regiment, The Uganda Rifles and the East African Rifles. These saw action in various expeditions and campaigns, in Mauritius, Somaliland, The Ashanti War, The Gambia Expedition, Expeditions against the Nandi and others. On 1 January 1902 the King's African Rifles came into being, incorporating the original regiments as battalions, six battalions: 1st and 2nd (Central Africa); 3rd (East Africa); 4th and 5th (Uganda) and 6th (Somaliland) Battalions. The total strength was returned as 4,683 officers and men, including 104

British officers. For the new regiment the main operations before WWI were the campaigns against the Mad Mullah of Somaliland involving four expeditions; he wasn t finally seen off until 1920. During the Great War there were 21 battalions and at peak strength in July 1918 the K.A.R. numbered 1,193 officers, 1,497 British NCOs and 30,658 Africans; casualties amounted to 5,117 with a further 3,039 died of disease. The regiment s part in the campaign against von Lettow-Vorbeck in East Africa is fully described. The regiment was again in action during WWII taking part in three separate campaigns: the defeat of the Italians in Somalia and Abyssinia; the occupation of Madagascar against the opposition of the Vichy French; and the reconquest of Burma when, for the first time, K.A.R. battalions fought outside the continent of Africa. This must be one of the best regimental histories ever written.
