Zeckhauser and Horn apply principal-agent theory to identify the key factors underlying the performance of state-owned enterprises.

Captain Krug served in U-boats in that theatre and in the Far East, and with the assistance of scholars of both nations has produced an account of German-Japanese naval interaction, providing an insight into the faulty mechanism of an alliance between totalitarian powers characterised by suspicion and an unwillingness to share information and assets freely. This book sets out to be a useful addition to the history of World War II and is designed for those interested in naval operations, global strategy and international diplomacy during this period.

Japanese-German Relations, 1895-1945

Focusing on the post war reconstruction of the education systems in Japan and Germany under U.S. military occupation after World War II, this book offers a comparative historical investigation of education reform policies in these two war ravaged and ideologically compromised countries. German-Japanese Relations, 1936-1940

The end of the Cold War and the bipolar era constituted a significant change in Germany's and Japan's foreign policy settings, granting both countries greater leeway to pursue policies divergent from Washington's strategy. This important book fills a gap in the existing literature by employing an explicitly comparative framework for analyzing and evaluating Germany's and Japan's post-Cold War regional foreign policy trajectories. In order to compare the two countries it is indispensable that the reader knows some facts about the countries. Japan and Germany Under the U.S. Occupation

Alliances between sovereign states are among the least stable political associations. Despite professions of fidelity and common purpose, most are effective for only short periods, and only as long as it suits their interests. The German-Japanese alliance of World War II was not so much a marriage of convenience as a long and uneasy engagement. It was maintained because breaking the engagement would have reduced the prestige of each nation-state. Germany and Japan each found the existence and policies of the other convenient. From 1933-1945, both powers challenged the international order; other than this, nothing else united Germany and Japan. Even while they shared some of the same opponents, German and Japanese antagonism toward the Allies involved different objects of contention and questions of timing. Consequently, coordination of German and Japanese policies did not follow. Johanna Menzel Meskill argues that the German-Japanese alliance failed, not only because each power failed separately to attain its goals, but because as allies the powers failed to take advantage of their association. The failure resulted to a large extent from the discordance between their political goals and the means necessary to attain them. This work in diplomatic history is a careful analysis of presuming identities in a world of diplomatic differences. In a new introduction to the book, Thomas Nowotny looks back on the alliance from a historical perspective. He concludes that both parties overestimated the potency and effectiveness of their military power. Like many before and some after, they more generally subscribed to the offensive use of military power and effectiveness that the history of the twentieth century has proven unwarranted.

The book covers an extensive range of economic issues: (1) macro-economic factors: capital, labor, technology; (2) macro-economic policies: financial, monetary, industrial; (3) external shocks to both economies: oil crises, exchange rate fluctuations, environmental problems; (4) development processes of major industries: steel, chemicals, and automobiles. The analyses with this systematic and comprehensive approach provide useful insights for the general reader as well as guidelines for developing countries and for Eastern European countries in transition.

Economies under Occupation

A comparison of politics and administration in Japan and Germany seems at first to be a comparison between similar highly industrialized states. This volume provides the first in-depth study about the two countries - the differences in their administrative and political party systems, the differences in the international environment which they faced after World War Two and during the Cold War.

Divided Nations and Transitional Justice

Between the early 1930s and 1945, Germany and Japan both embarked on extremely destructive colonial adventures. This book looks at the ways in which the Germans and the Japanese have come to terms with the past and investigates the painful realities of living with guilt - and of denying it. Ian Buruma encounters people whose honesty in confronting the past is brave, and others who astonish by the ingenuity of their evasion of responsibility. In Auschwitz, Berlin, Hiroshima and Tokyo he explores the contradictory attitudes of scholars, politicians and survivors, and visits some grotesque monuments, such as the Japanese Shinto museum commemorating the kamikaze pilots.

Global Governance

"We Americans have the dangerous tendency in our international thinking to take a holier-than-thou attitude toward other nations. We consider ourselves to be more noble and decent than other peoples, and consequently in a better position to decide what is right and wrong in the world. What kind of war do civilians suppose we fought, anyway? We shot prisoners in cold blood, wiped out hospitals, strafed lifeboats, killed or mistreated enemy civilians, finished off the enemy wounded, tossed the dying into a hole with the dead, and in the Pacific boiled the flesh off enemy skulls to make table ornaments for sweethearts, or carved their bones into letter openers.... [W]e mutilated the bodies of enemy dead, cutting off their ears and kicking out their gold teeth for souvenirs, and buried them with their testicles in their mouths.... We topped off our saturation bombing and burning of enemy civilians by dropping atomic bombs on two nearly defenseless cities, thereby setting an all-time record for instantaneous mass slaughter. As victors we are privileged to try our defeated opponents for their crimes against humanity; but we should be realistic enough to appreciate that if we were on trial for breaking international laws, we should be found guilty on a dozen counts. We fought a dishonorable war, because morality had a low priority in battle. The tougher the fighting, the less room for decency, and in Pacific contests we saw mankind reach the blackest depths of bestiality." ---- Edgar Jones, WWII Veteran

A Comparative Analysis of Japanese and German Economic Success

How did East and West Germany and Japan reconstitute national identity after World War II? Did all three experience parallel reactions to national trauma and reconstruction? History education shaped how these nations reconceived their national identities. Because the content of history education was controlled by different actors, history education materials framed national identity in very different ways. In Japan, where the curriculum was controlled by bureaucrats bent on maintaining their purported neutrality, materials focused on the empirical building blocks of history (who? where? what?) at the expense of discussions of historical responsibility. In East Germany, where party cadres controlled the curriculum, students were taught that World War II was a capitalist aberration. In (West) Germany, where teachers controlled the curriculum, students were taught the lessons of shame and then regeneration after historians turned away from grand national narratives. This book shows that constructions of national identity are not easily malleable on the basis of moral and political concerns only, but that they are subject to institutional constraints and opportunities. In an age when post-conflict reconstruction and reconciliation has become a major focus of international policies, the analysis offers important implications for the parallel revision of portrayals of national history and the institutional reconstruction of policy-making regimes.

Germany and Japan
