#### Power-Sharing in Conflict-Ridden Societies

What can be learned from these cases? Each country has it unique history but they are faced with comparable challenges and dilemmas in building a democratic future. Which solutions seem to contribute to democratic stability and which do not? These questions are discussed in light of theoretical literature, case studies, and field interviews with the authors concluding that systems based on proportional representation offered the best prospects for including diverse and conflicting identities and building unified political systems. The book is of particular interest to students of democracy and peace-building; academics as well as decision-makers and practitioners in the field.

Power-sharing

This edited collection aims to enhance our understanding of the utility of power-sharing in deeply divided societies by subjecting power-sharing theory and practice to empirical and normative analysis and critique. This text will be of key interest to students, scholars and practitioners of power-sharing, ethnic politics, democracy and democratization, peacebuilding, comparative constitutional design, and more broadly Comparative Politics, International Relations and Constitutional and Comparative Law.

# Post-Conflict Power-Sharing Agreements

The book surveys comparative power sharing models implemented in societies that have faced identity-conflicts, with attention given to post-conflict design. It analyzes the success and pitfalls of international experiences before proposing a model for Syria. Contributors address the central question: which among the set of power-sharing agreements that have helped settle protracted identity-driven armed conflict can provide Syria with a platform for dialogue, negotiation, and conflict mitigation? The comparative analysis advanced in this book extracts lessons from countries such as Bosnia-Herzegovina, India, Iraq, Lebanon, Mali, Northern Ireland, the Philippines and Sudan. The prospect of a post-conflict distribution of power in Syria is then unraveled from different sectarian, ethnic and regional perspectives. The authors also address challenges of peacebuilding such as violent extremism, gender participation, resettlements, retributions, transitional justice, integration of armed groups and regional and international sponsorship.

# South Sudan's Fateful Struggle

The Comprehensive Peace Agreement marked the end of Sudan's second civil war between the North and South. But in creating an autonomous southern region and a pathway toward statehood, it failed to resolve the effects of rebel factionalism, party infighting, and corruption in the South. In South Sudan's Fateful Struggle, Steven C. Roach analyzes these persistent effects of the South-South war, showing how they disrupted the transition to statehood and divided the transitional government of national unity in South Sudan. Throughout, he stresses the centrality of elite mismanagement and the durable dynamics of war which have shaped the country's troubled political destiny. The government, plagued by patronage-fueled corruption and patrimonialism, continues to rely on the threat of violence to govern the country and to delay the transition to a new government of national unity. Roach argues that in naturally sowing division and distrust, government elites must ultimately learn to engage civil society to achieve long-term peace, accountability, and justice. Along with providing an overview of the country's trajectory in this century, Roach traces its state of war to colonial times and uses the notion of militarized patronage to describe the distinct nature of South Sudan's patronage networks. He shows how the Sudan People's Liberation Movement came to dominate the country's affairs to become a powerful deterrent to democracy, security, justice, and national unity. He then discusses the promising efforts by civil society actors to advance hybrid justice by pressuring the government to implement a truth commission, a war crimes court, and reparations commission. Comprehensive in scope, the book represents the first systematic examination of South Sudan's quandary both before and after its civil war.

### The Struggle for Redress

This book explores pathways to redress for main groups of victims/survivors of the 1992-5 Bosnian war —families of missing persons, victims of torture, survivors of sexual violence, and victims suffering physical disabilities and harm. The author traces the history of redress-making for each of these groups and shows how differently they have been treated by Bosnian authorities at the state and subnational level. In Bosnia and Herzegovina, thousands of war victims have had to suffer re-traumatising ordeals in order to secure partial redress for their suffering during 1992–1995 and after. While some, such as victims of sexual violence, have been legally recognised and offered financial and service-based compensation, others, such as victims of torture, have been recognized only recently with a clear geographical limitation. The main aim of the book is to explore the politics behind recognizing victim-hood and awarding redress in a country that has been divided by instrumentalized identity cleavages, widespread patronage and debilitating war legacies. It shows how war victims/survivors navigate such fragmented and challenging public landscape in order to secure their rights.

By analyzing the changes and continuities in federalism building, the book charts the dynamic pathway toward Myanmar's current federalization, revealing how periods of progress and stagnation reflect varying world views and the individual strategies of prominent political actors. Offering a systematic conceptual framework on federalism in Myanmar, this will be a useful resource for students and scholars of Political Science, Comparative Politics, and Southeast Asian Politics.

#### The Middle East in Transition

The violent transitions that have dominated developments since the Arab Uprisings demonstrate deep-seated divisions in the conceptions of state authority and citizen rights and responsibilities. Analysing the Middle East through the lens of the 'citizenship approach', this book argues that the current diversity of crisis in the region can be ascribed primarily to the crisis in the relations between state and citizen. ### The Decline of Nation-States after the Arab Spring

Surveying the causes of the Arab Spring, and revealing the governing trends arising from it, this book examines various international relation theories through the lens of the experiences of the countries in the Middle East and North Africa region. It takes the events of the Arab Spring as an outcome of globalization's double movement whose integrative cultural, political and security frameworks devastated nationally controlled economies, undermining the nation-state system and propagating a decentralized and communitarian-based governance structure. The consequences for many plural, diverse societies were two-fold: autocratic nationalism was discarded while decentralized regimes representing communitarian-based politics came to the fore. The author reveals how the formulation of a new communitocratic order rests on the accommodation of this newly emerging communitarianism and explores the major drivers of political transformation, describing the emerging communities, forecasting their governing options and the possible repercussions for the post-Arab Spring states.

# Transformative Transitional Justice and the Malleability of Post-Conflict States

Despite the growing focus on issues of socio-economic transformation in contemporary transitional justice, the path dependencies imposed by the political economy of war-to-peace transitions and the limitations imposed by weak statehood are seldom considered. This book explores transitional justice's prospects for seeking economic justice and reform of structures of poverty in the specific context of post-conflict states.

# Democracy on the Precipice

#### The 'Local Turn' in Peacebuilding

In spite of this, 'the local' is rarely a key factor in peacebuilding, hence 'everyday peace' is hardly achieved. The aim of this volume is threefold: firstly it illuminates the substantial reasons for working with a more localised approach in politically volatile contexts. Secondly it consolidates a growing debate on the significance of the local in these contexts. Thirdly, it problematizes the often too swiftly used concept, 'the local', and critically discuss to what extent it is at all feasible to integrate this into macro-oriented and securitized contexts. This is a unique volume, tackling the 'local turn' of peacebuilding in a comprehensive and critical way. This book was published as a special issue of Third World Quarterly.

#### **Education and Conflict**

#### African Conflicts and Informal Power

In reality, African economies and polities are very much informal in character, with informal actors, including so-called Big Men, often using their positions in the formal structure as a means to reach their own goals. Through a variety of in-depth case studies, including the DRC, Sierra Leone and Liberia, this comprehensive volume shows how important informal political and economic networks are in many of the continent's conflict areas. Moreover, it demonstrates that without a proper understanding of the impact of these networks, attempts to formalize African states, particularly those emerging from wars, will be in vain.

# **Human Security**

In a globalizing world, in which threats become trans-national and states lose power, security can no longer be studied in a one-dimensional fashion. Written by authors who are experts in this field and with case studies from different regions (Afghanistan, Central Asia and South Asia) presented throughout, this book - now available in paperback - contributes to this new multidimensional conception of security, analyzes its strengths and weaknesses, and focuses on its implications for analysis and action.

### **Regions and Powers**

This book develops the idea that since decolonisation, regional patterns of security have become more prominent in international politics. The authors combine an operational theory of regional security with an empirical application across the whole of the international system. Individual chapters cover Africa, the Balkans, CIS Europe, East Asia, EU Europe, the Middle East, North America, South America, and South Asia. The main focus is on the post-Cold War period, but the history of each regional security complex is traced back to its beginnings. By relating the regional dynamics of security to current debates about the global power structure, the authors unfold a distinctive interpretation of post-Cold War international security, avoiding both the extreme oversimplifications of the unipolar view, and the extreme deterritorialisations of many globalist visions of a new world disorder. Their framework brings out the radical diversity of security dynamics in different parts of the world.

Accepting diversity, respecting all human beings, and understanding the richness of perspectives that people have are of great relevance for all Commonwealth countries, and for its 1.8 billion people. They are also importance for the rest of the world. The civil paths to peace are presented here for use both inside the Commonwealth and beyond its boundaries. The Commonwealth has survived and flourished, despite the hostilities associated with past colonial history, through the use of a number of far-sighted guiding principles. The Commission argues that those principles have continuing relevance today for the future of the Commonwealth--and also for the world at large.

The Challenges of Restoring Governance in Crisis and Post-conflict Countries

# Systems of Internal Control and Risk Management of G7

The goal of the research is a comparison of the G7 Countries and their different systems of Internal Control and systems of Risk Management, using the current standards of the United States of America as a benchmark. The research focuses on the frameworks for Internal Control, e.g. COSO I; for Enterprise Risk Management, e.g. COSO II; on country-specific standards as well as on the all-embracing country-specific Corporate Governance Codes. The United States of America took an important step with the implementation of the Sarbanes-Oxley Act (SOX) and other countries were forced to react to this landmark regulation with the implementation of operative and efficient Internal Control and Risk Management Systems. Commentary and critiques by the academic research community will be presented and might bear an influence on the comparison of the different frameworks - all with a focus on the auditor's perspective. The requirements of an effective Internal Control and/or ERM are defined and compared with the systems of the respective G7 countries. With the support of a utility function, the most effective system is selected.

### Intelligent Internal Control and Risk Management

Many people in organizations resent internal control and risk management; these two processes representing unwelcome tasks to be completed for the benefit of auditors and regulators. Over the last few years this perception has been heightened by the disastrous implementation of section 404 of the Sarbanes-Oxley Act of 2002, which is generally regarded as having been too expensive for the benefits it has brought. This important book offers a way of improving this prevailing perception and increasing the value of control and risk management by bringing creativity and design skills to the fore. The value of risk and control activities is often limited by the value of the control ideas available and so Matthew Leitch provides an arsenal of 60 high performance control mechanisms. These include several alternative ways to design controls and control systems, as well as providing controls for monitoring and audit, controls for accelerated learning, and techniques for finding and recovering cash. This design material is combined with insights into the psychology of risk control, strategies for encouraging helpful behaviour and enabling change, and a surprisingly simple integration of internal control with risk management. The book is realistic, practical, original, and easier reading than most in the field. The material is not specific to any one country and has international appeal for internal auditors and all those concerned with risk management, corporate governance and security.

# Internal Control

The concept of internal control has developed along with audit practice. As demands have been made for greater accountability in corporate governance, the significance of internal control systems in companies has increased. Traditionally internal control has had a fairly direct relationship to financial reporting quality but wider approaches to internal control have expanded those boundaries much further. Stakeholders are increasingly concerned with the effectiveness of internal controls, and disclosure requirements are making firms to go public with regard to their internal control systems. From a design perspective, current research suggests that internal control designs are contingent upon variables such as company strategies, risk appetite, regulatory characteristics, and organizational

size. Also there is much to learn about internal control quality, and the way internal control quality is associated with overall corporate governance quality. This book fills that gap.
