The purpose of this report is to summarize the findings of a Democracy, Human Rights, and Governance (DRG) Assessment carried out in Indonesia from October 1-19, 2012. The main objectives of the assessment are to identify the key problems of democracy, human rights, and governance in the country; analyze the structure of opportunities and constraints different actors and institutions face in advancing democratic reform; and provide a set of programmatic recommendations for the United States Agency for International Development's Indonesia Mission (USAID/Indonesia) as the Agency prepares its next five-year strategy. Recommendations are based on a realistic evaluation of the most important opportunities for reform in the country and an assessment of the types of interventions that are within USAID's manageable interests and have the potential for achieving the greatest impact. # 7. Freedom of expression

## Indonesia's Search for Democracy

Since 1998, the transformation of Indonesia has led to far-reaching political and economic change: The democratization process introduced an amended constitution, multi-party and factional organization as well as participative procedures and administrative decentralization. A new understanding of the

Indonesian civil society has evolved, the relationship between security forces (military and police) has been redefined, and focal topics have shifted to dealing with separatist movements, solving interethnic conflicts, and promoting good governance. Ongoing violations of human and minority rights, rather low anti-corruption performance and restrictions inhibiting the freedom of the press call for governmental action. This book investigates the opportunities and challenges of Indonesian reform initiatives in the many policy fields from various perspectives. The authors examine the obstacles faced by the government and the resulting challenges to implementing specific policies.

#### Decentralization and Governance in Indonesia

Indonesia over the past two decades has embarked on a process of decentralization as part of a broader process of democratization, which followed earlier periods of centralized governance and authoritarian rule across the archipelago. The purpose of this book is to begin to explore the connections between governance and sustainable society in a wide variety of policy fields in Indonesia, and how reforming governance structures may contribute to societal benefits and the creation of a long-term sustainable society. This book bridges important theoretical debates related to governance and sustainable society and provides empirical research from Indonesia in important policy areas related to this debate. By placing research in different policy areas in a single volume, the link to the broader concepts of governance, decentralization, and societal outcomes is strengthened. The book builds on the recent interest that has focused on Indonesia and the continued development of democracy in the country. The chapters in the book show a rich variety of decentralized governance arrangements and capacity building at the local level in particular. Central standards (for example for social sustainability, anti-corruption arrangements, or for dealing with direct foreign investment), combined with local innovation (for example for municipal coordination of primary health care or metropolitan transport), are key to Indonesia as a country in a continuing process of transformation. We identify three key trends in the on-going process of decentralization and governance in Indonesia. First, we find that formal governance, the relation between the national and local government, is characterized by a system of 'variable geometry multi-level governance' depending on the policy area. The challenge ahead is strengthening accountability mechanisms to assure national standards while preserving and encouraging local innovation. Secondly, informal governance mechanisms are evolving to move from 'hierarchical to network' forms of governance. Here the challenge is to insure democratic input by citizens and civil society organizations. Finally, we identify a trend toward 'shared value creation and sustainable cooperation.' Indonesia is beginning to move from a rather singular policy focus on economic growth to a more complex and developing notion of policymaking for inclusive growth and the creation of a sustainable society for present and future generations. Here the challenge is sound implementation and to increase the effectiveness of governance mechanisms. There is also a noted diffusion of goals, to focus beyond the Jakarta metropolitan area to smaller regional cities, as urbanization continues and rural areas are changing. This book will be of interest for use in advanced undergraduate and graduate courses related to Southeast Asia in the fields of international relations, political science, public administration, economics, law, sociology, education, public health, and the spatial sciences. It will also be of interest to policymakers and government officials at the national and local level in Southeast Asia and middle-income developing countries, officials and policymakers in institutions of regional governance such as the Association of Southeast Asian Nations (ASEAN), and of global governance such as the United Nations and World Bank. It will also be of interest to civil society organizations and other actors focused on policy development and economic development, health, education, the environment, sustainable transport, etc. The book will also be of interest to business people interested in economic and governance issues, such as the management and governance of in-bound foreign investment, inclusive growth, and corporate governance. Finally, the book should be of interest to citizens in advanced, middle-income, and developing countries motivated to learn more about the links between governance and the creation of a sustainable society for current and future generations.

## Making Sense of Governance

How did democracy became entrenched in the world's largest Muslim-majority country? After the fall of its authoritarian regime in 1998, Indonesia pursued an unusual course of democratization. It was insider-dominated and gradualist and it involved free elections before a lengthy process of constitutional reform. At the end of the process, Indonesia's amended constitution was essentially a new and thoroughly democratic document. By proceeding as they did, the Indonesians averted the conflict that would have arisen between adherents of the old constitution and proponents of radical, immediate reform. Donald L. Horowitz documents the decisions that gave rise to this distinctive constitutional process. He then traces the effects of the new institutions on Indonesian politics and discusses their

shortcomings and their achievements in steering Indonesia away from the dangers of polarization and violence. He also examines the Indonesian story in the context of comparative experience with constitutional design and intergroup conflict.

The Land Governance Assessment Framework (LGAF) makes a substantive contribution to the land sector by providing a guick and innovative tool to monitor land governance at the country level. The LGAF offers a comprehensive diagnostic tool that covers five main areas for policy intervention: Legal and institutional framework; Land use planning, management and taxation; Management of public land; Public provision of land information; and Dispute resolution and conflict management. The LGAF assesses these areas through a set of detailed indicators that are rated on a scale of pre-coded statements (from lack of good governance to good practice). While land governance can be highly technical in nature and tends to be addressed in a partial and sporadic manner, the LGAF posits a tool for a comprehensive assessment, taking into account the broad range of issues that land governance encompasses, while enabling those unfamiliar with land to grasp its full complexity. The LGAF will make it possible for policymakers to make sense of the technical levels of the land sector, benchmark governance, identify areas that require further attention and monitor progress. It is intended to assist countries in prioritizing reforms in the land sector by providing a holistic diagnostic review that can inform policy dialogue in a clear and targeted manner. In addition to presenting the LGAF tool, this book includes detailed case studies on its implementation in five selected countries: Peru, the Kyrgyz Republic, Ethiopia, Indonesia and Tanzania.

#### Strategic Narratives

Karim examines the changes and continuity of Indonesia's foreign policy in the post-authoritarian era, under presidents Susilo Bambang Yudhoyono and Joko Widodo. Indonesia conceptualised and aimed to adopt four principle roles after 2004 – being a voice for developing countries; being a regional leader; being an advocate for democratic and human rights; and being a bridge-builder. These roles, however, were by no means stable and were constantly being negotiated and contested. Karim analyses the contested nature of Indonesian foreign policy and the limits this places on consistency in enacting these roles. He highlights two drivers for such limitations – conflicting role conceptions and state fragmentation. He develops this argument based on four case studies of Indonesia's engagement in human rights governance and trade governance at both regional and global levels. Essential reading for students and scholars of Indonesia's foreign policy, that will also be of substantial value to those studying policy in Southeast Asia more broadly.

# Constitutionalism and the Rule of Law

European Convention on Human Rights – Article 10 – Freedom of expression 1. Everyone has the right to freedom of expression. This right shall include freedom to hold opinions and to receive and impart information and ideas without interference by public authority and regardless of frontiers. This article shall not prevent States from requiring the licensing of broadcasting, television or cinema enterprises. 2. The exercise of these freedoms, since it carries with it duties and responsibilities, may be subject to such formalities, conditions, restrictions or penalties as are prescribed by law and are necessary in a democratic society, in the interests of national security, territorial integrity or public safety, for the prevention of disorder or crime, for the protection of health or morals, for the protection of the reputation or rights of others, for preventing the disclosure of information received in confidence, or for maintaining the authority and impartiality of the judiciary. In the context of an effective democracy and respect for

human rights mentioned in the Preamble to the European Convention on Human Rights, freedom of expression is not only important in its own right, but it also plays a central part in the protection of other rights under the Convention. Without a broad guarantee of the right to freedom of expression protected by independent and impartial courts, there is no free country, there is no democracy. This general proposition is undeniable. This handbook is a practical tool for legal professionals from Council of Europe member states who wish to strengthen their skills in applying the European Convention on Human Rights and the case law of the European Court of Human Rights in their daily work.

# Internal Security Services in Liberalizing States

Illiberal Democracy in Indonesia charts the origins and development of organicist ideologies in Indonesia from the early 20th century to the present. In doing so, it provides a background to the theories and ideology that informed organicist thought, traces key themes in Indonesian history, examines the Soeharto regime and his 'New Order' in detail, and looks at contemporary Indonesia to question the possibility of past ideologies making a resurgence in the country. Beginning with an exploration of the origins of the theory of the organic state in Europe, this book explores how this influenced many young Indonesian scholars and 'secular' nationalists. It also looks in detail at the case of Japan, and identifies the parallels between the process by which Japanese and Indonesian nationalist scholars drew on European romantic organicist ideas to forge 'anti-Western' national identities and ideologies. The book then turns to Indonesia's tumultuous history from the revolution to 1965, the rise of Soeharto, and how his regime used organicist ideology, together with law and terror, to shape the political landscape consolidate control. In turn, it shows how the social and economic changes wrought by the government's policies, such as the rise of a cosmopolitan middle class and a rapidly growing urban proletariat led to the failure of the corporatist political infrastructure and the eventual collapse of the New Order in 1998. Finally, the epilogue surveys the post Soeharto years to 2014, and how growing disquiet about the inability of the government to contain religious intolerance, violence and corruption, has led to an increased readiness to re-embrace not only more authoritarian styles of rule but also ideological formulas from the past. This book will be welcomed by students and scholars of Southeast Asia, politics and political theory, as well as by those interested in authoritarian regimes, democracy and human rights.

COMMON GOOD Hand in hand with the authority to make decisions Is the obligation a leader has to use their authority for the common good.

POWER Because the leader usually has more power and control than followers have, leaders have

to be particularly sensitive to how their leadership affects the well-being of others.

COMMON GOOD Put another way, ethical leadership is a process by which a good person rightly influences others to accomplish a common good: to make the world better, fairer, and more humane. VALUES Ethics is concerned with the kind of values and morals an individual or society finds desirable or appropriate.

SIX DIMENSIONS A model for many of these programs was developed by the Josephson Institute in California, which frames instruction around six dimensions of character: trustworthiness, respect, responsibility, fairness, caring, and citizenship

CORE VALUES Based on these and similar character dimensions, schools are emphasizing the importance of character and how core values influence an individual's ethical decision making. DEVELOPMENT Although character is clearly at the core of who you are as a person, It is also something you can learn to strengthen and develop. When practiced over time, good values become habitual.

GOALS Actions refer to the ways a leader goes about accomplishing goals. Ethical leaders use moral means to achieve their goals.

ACTIONS The actions a leader takes to accomplish a goal need to be ethical. They cannot be justified by the necessity or importance of the leader's goals. Ethical leadership involves using morally appropriate actions to achieve goals.

SERVING OTHERS Serving others is an example of altruism, an approach that suggests that actions are ethical if their primary purpose is to promote the best interest of others.

SHOWING JUSTICE Justice demands that a leader place the issue of fairness at the center of decision making. As a rule, no one should receive special treatment or special consideration except when a particular situation demands it.

GOLDEN RULE In addition, justice is concerned with the Golden Rule: Treat others as you would like to be treated. If you expect fair treatment from others, then you should treat others fairly.

RESOURCES Because of the real or perceived scarcity of resources, conflicts often occur between individuals about fair methods of distribution. It is important for a leader to establish clearly the rules for distributing rewards.

GOALS Leaders play a significant in determining whether leadership is ethical. The goals a leader selects are a reflection of the leader's ethics.

VALUE Identifying and pursuing just and worthy goals are the most important steps an ethical leader will undertake. In choosing goals, an ethical leader must assess the relative value and worth of their goals.

COMMUNITY In the process, it is important for the leader to take into account the interests of others in the group or organization and, in some cases, the interests of the community and larger culture in which they work.

The challenge for a leader is to strike a balance between being open and candid and at the same time monitoring what is appropriate to disclose.

EFFECT CHANGE When they use their potential, they are using their power as a resource to effect change in others.

BASES OF POWER The most widely cited research on power is French and Raven's work on the bases of social power. They identified five common and important bases of power: referent power, expert power, legitimate power, reward power, and coercive power.

USING POWER Since power can be used in positive ways to benefit others or in destructive ways to hurt others, a leader needs to be aware of how they use power. Power is not inherently bad, but it can be used in negative ways.

PERSONAL ENDS There is a dark side of leadership where a leader uses their influence or power for personal ends. Unfortunately, there are many examples in the world of such leaders.

VALUES Values are the ideas, beliefs, and modes of action that people find worthwhile or desirable. Some examples of values are peace, justice, integrity, fairness, and community. A leader's ethical values are demonstrated in everyday leadership.

END VALUES End values describe the outcomes or goals a leader seeks to achieve. End values are present when a person addresses broad issues such as liberty and justice.

Different cultures have different rules of conduct, and as a result, leadership behaviors that one culture deems ethical and another does not

Naturally, these perspectives originate from a poor understanding of the evolution of British administration. Therefore they tend to be based on wrong and biased interpretations. On the contrary, Great Britain offers a fascinating case, as the hidden secrets of its public administration provide a wide and stimulating research agenda. Motivated by the entrenched misunderstanding of the British administration, I researched the topic extensively and published a book entitled La Administración Pública en Gran Bretaña (Public Administration in Great Britain) in 2012. This book draws together historical evidence about the compelling trajectory of administrative thought in Great Britain, and provides a novel perspective to understanding public administration in the country. I believe that this book fills an important gap in the literature, and does justice to the eminent British thinkers that have been ignored or forgotten, even in the English literature.

# Public Administration and Policy in Korea

Public Administration Evolving: From Foundations to the Future demonstrates how the theory and practice of public administration has evolved since the early decades of the twentieth century. This book presents major trends in theory and practice in the field, provides an overview of its intellectual development, and demonstrates how it has professionalized. ## **Understanding Public Administration**

After the New Public Management had evolved in English speaking countries, it became a role model for the reform of public administration all throughout the world. Although there were obvious similarities in terminology used in different countries, the model was usually adapted to the cultural and political context in which it had to be embedded. This also resulted in significant conceptual differences, so

that nowadays, there is no one single NPM in the world. In contrast to the original NPM model, this version puts emphasis on responsibility rather than accountability of public managers; it is strictly focused on the outcomes of public services rather than the output level; and it is grounded on the Rechtsstaat tradition of Continental European countries. Thus, the label that has been used in German ever since, Wirkungsorientierte Verwaltungsführung, is consequently translated into 'outcome-oriented public management' (OPM). This book is an English version of a German classic teaching book. In its original form, it was first published in 2000 and constantly revised according to latest developments in practice. Currently, it's 4th edition is selling in German speaking countries. Written for students and practitioners in public administration, the book describes the OPM model and its roots, and it discusses benefits and drawbacks of this model in practice. It is a perfect introduction into the new thinking of outcome orientation in the public sector.

#### Public Administration and Public Affairs

This is a complete and up-to-date revision of the classic text for public administration which presented public administration as a tension between the necessary exercise of power and the search for accountability by public servants. In this revision, the authors have initiated a new approach to the study of public administration by focusing on middle- and lower-level managers. These are positions that most students will occupy for the bulk of their professional careers. The book recognizes that most of the administration is in field offices, in state and local government, and in cooperation with the private sector. It then focuses on power and its potential for influencing the behavior of the bureaucracy. This leads to the relationship between theories about administration and the actual practice.
