The Brilliance of Black Boys

Described by Robert Lipsyte as ‘the high point of American sports journalism’, John McPhee’s *Levels of the Game*, nominally about a tennis match between two of the greats of tennis history, redefined what it meant to be a sports writer. Written by four-times finalist for the Pulitzer Prize for non-fiction, *Levels of the Game* is the best tennis book ever written, dealing with human behaviour, race, politics and the divisions of the country, all told through a single game of tennis. *Levels of the Game* is a narrative of a tennis match played by Arthur Ashe and Clark Graebner at Forest Hills in 1968, beginning with the ball rising into the air for the initial serve and ending with the final point. In between, McPhee provides a brilliant, stroke-by-stroke description, while examining the backgrounds and attitudes which have molded the players’ games. Arthur Ashe thinks that Clark Graebner, a middle-class white conservative dentist’s son from Cleveland, plays stiff and compact Republican tennis. Graebner acknowledges that this is true, and for his part thinks that, because Ashe is black and from Richmond, Ashe’s tennis game is bold, loose, liberal, flat-out Democratic. When physical assets are about equal, psychology is paramount to any game.

Levels of the Game

This book of matrices with Black boys as the main character is designed to help gifted and talented education teachers leverage Black boys’ identities to inform and shape how they plan and deliver curriculum and instruction and manage the multicultural, democratic, and culturally responsive classroom. Ford and colleagues (2005) spoke to the notion of and need for ‘self-reflective instruction.’ We argue that all teachers must want to and learn how to legitimize the “everyday” experiences that are learned and cultivated in the homes and communities of Black boys, and how these experiences shape their self-identities and contribute to agency (Wright, Counsell, & Tate 2015). We, therefore, advocate for the rethinking of literacies by repositioning White-centered texts that often reflect and represent power and privilege toward centering the brilliance of Black identities of Black children in general, Black boys in particular. Black boys (of all ages) want to and need to physically see positive images of themselves in books reflected at them. This representation, we argue, has the potential to become an example of a compelling counter-narrative to the history of the “all-White world” (Larrick, 1965) of children’s books that only presented Black characters as “objects of ridicule and generally inferior beings” (Sims Bishop 2012, p. 6). When Black boys see themselves portrayed visually, textually, and realistically in children’s books, vital messages of recognition, value, affirmation, and validation are conveyed. Recognition of the sociocultural contexts in which they live is celebrated. Books for and about Black boys must be rigorous, authentic, multicultural, and developmentally appropriate to allow them to synthesize what they have read, heard, and seen during literacy instruction in authentic and meaningful ways. Multicultural books must introduce children to information about the values of justice, fairness, and equity. Developmentally

appropriate books should vary with and adapt to the age, experience, and interests of gifted and talented Black boys to allow them the opportunity to demonstrate critical thinking, textual analysis skills and convey conceptual knowledge. These stories must expose Black boys to culturally relevant counter stories -- stories that counteract the dominant discourse that has primarily depicted Black boys as “at risk” versus placed at risk; “without hope” versus hopeful; or “out of control and dangerous” (Tatum, 2005, p. 28) versus developing self-control like all other children (Wright et al., 2018).

Black Boys are Lit

Born in Richmond, Virginia, in 1943, by the age of eleven, Arthur Ashe was one of the state’s most talented black tennis players. He became the first African American to play for the US Davis Cup team in 1963, and two years later he won the NCAA singles championship. In 1968, he rose to a number one national ranking. Turning professional in 1969, he soon became one of the world’s most successful tennis stars, winning the Australian Open in 1970 and Wimbledon in 1975. After retiring in 1980, he served four years as the US Davis Cup captain and was inducted into the International Tennis Hall of Fame in 1985. In this “deep, detailed, thoughtful chronicle” (The New York Times Book Review), Raymond Arsenault chronicles Ashe’s rise to stardom on the court. But much of the book explores his off-court career as a human rights activist, philanthropist, broadcaster, writer, businessman, and celebrity. In the 1970s and 1980s, Ashe gained renown as an advocate for sportsmanship, education, racial equality, and the elimination of apartheid in South Africa. But from 1979 on, he was forced to deal with a serious heart condition that led to multiple surgeries and blood transfusions, one of which left him HIV-positive. After devoting the last ten months of his life to AIDS activism, Ashe died in February 1993 at the age of forty-nine, leaving an inspiring legacy of dignity, integrity, and active citizenship. Based on prodigious research, including more than one hundred interviews, Arthur Ashe puts Ashe in the context of both his time and the long struggle of African-American athletes seeking equal opportunity and respect, and “will serve as the standard work on Ashe for some time” (Library Journal, starred review).

Arthur Ashe

When Andy Murray finally overcame Novak Djokovic in a five-set thriller to secure the 2012 US Open, it was a dream fulfilled for the man from Dunblane. After four previous defeats in Grand Slam finals, Murray had finally achieved what no British man had managed since the 1930s. But the story of how he got there was just as compelling as the final itself, with as many twists and turns along the way. Catching the Moon

This book explores how American sports, especially basketball, baseball and American football, have projected the US into the world, and brought the world into America. Taking a chronological approach it traces the development of American sports from the turn of the 20th century, highlighting how international forces such as immigration, geopolitics and war have influenced the trajectory of sport in the US, and thus the American experience. DuBois also considers the globalization of American sport and how this soft power shaped international relations throughout the American century. The days of tennis as a country club sport for the aristocracy have long passed, as have the pre–Open era days when black players faced long odds just to be invited to the four Grand Slam events. An entire generation of sports fans has grown up seeing Venus and Serena Williams as the gold standard in American professional tennis. Although the Williams sisters have done more than any other players to make tennis accessible to a diverse population, it's not as if the tennis revolution is over. When you watch tennis next, take a close look at the umpire, the person sitting in the high chair of authority at court-side. Look at the tournament referee and the tournament director, the officials who run the tournament. Arthur Ashe

A childhood biography of a groundbreaking African-American athlete. Arthur Ashe (1943-1993) was the first African American man to win a major tennis tournament. He did not start out with a love of the game--his favorite sport was actually baseball--but growing up in the racist south, Arthur decided he would one day play sports on courts that did not allow black athletes. After proving himself a natural on the tennis court, and struggling with committing to the game, Arthur enjoyed many years of championship tennis, crowned by two achievements: his victory over Jimmy Connors at Wimbledon, and competing in Byrd Park, Virginia, a park he was not allowed to play in when he was a child. Alas, during heart surgery in 1983, it is likely that Ashe was given blood tainted with HIV. He became an active fundraiser and speaker on behalf of AIDS research. In 1997 the U.S. Tennis Center's main stadium in New York City was named Arthur Ashe Stadium in honor of his many contributions to the game. This inspiring biography showcases Ashe's courage in the face of bigotry.
