Is having more options always better than not having them? (Compare duelling) Are people who might choose euthanasia in a suitable condition to be offered the choice? Can we harm people by offering them a choice?

But, Velleman says... "If a significant number of patients were both competent and morally entitled to choose euthanasia, then we might be obligated to make that option available even if, in doing so, we would inevitably give it to some who would be harmed @by having it." Compare the right to refuse life- sustaining medical treatment.

"Euthanasia by default" "I favor euthanasia in some cases... I feel most comfortable with a policy of permitting euthanasia by default-that is, by a tacit failure to enforce the institutional rules that currently serve as barriers to justified euthanasia, or a gradual elimination of these rules without fanfare."
