NHG clinical practice guidelines

Ruim 20 jaar geleden is de eerste standaard van het Nederlands Huisartsen Genootschap (NHG) uitgekomen. Daarmee is het richtlijnenproject van het NHG wereldwijd een van de langst lopende en meest succesvolle programma's voor evidence based richtlijnenontwikkeling. In de loop van de jaren is de kwaliteit van de standaarden toegenomen. Belangrijke mijlpalen waren de keus voor een scheiding tussen aanbevelingen en onderbouwing met een notenapparaat begin jaren negentig en voor de toepassing van systematische literatuursearches op basis van uitgangsvragen rond de eeuwwisseling. Door de levensduur van het richtlijnenproject en de vlotte introductie van standaarden als onderwijsmateriaal in de (huis)artsenopleiding, is inmiddels een groot deel van de zittende huisartsenpopulatie in Nederland opgegroeid met de standaarden. De meest huisartsen in Nederland gebruiken de standaarden in de dagelijkse praktijk als leidraad. Over 10 jaar zal het aantal huisartsen in Nederland dat niet met de standaarden is opgeleid, op de vingers van een hand zijn te tellen. Vanwege het grote belang van de NHG-Standaarden voor de huisartsengeneeskunde en de kwaliteit daarvan heeft het NHG gemeend de starten met het vertalen van standaarden in het Engels. Daarmee komen de in Nederland geldende evidence based richtlijnen ter beschikking van doelgroepen buiten Nederland. Als pilot is begonnen met het vertalen van een tweetal standaarden te weten: M09 – Otitis Media Acuta en M29 – Kinderen met Koorts. Afhankelijk van de ontvangst zal worden besloten uit het totale aanbod van circa 90 NHG-Standaarden meer standaarden te vertalen.

Diagnosis and Management of Childhood Otitis Media in Primary Care

Otitis media with effusion is one of the most common problems of infancy and early childhood. Because the prevalence, incidence, and management of this condition varies with age, this guideline focuses on the group at high risk for long-term effects: children ages 1-3 years. These recommendations are based on an extensive review of medical and health-related literature and expert opinion. They are given for diagnosis and hearing evaluation; control of environmental factors; and sequencing of interventions, including observation, use of antibiotics and other medications, and the appropriateness and timing of surgery.

Otitis Media with Effusion in Young Children

Otitis media with effusion (OME) is a condition characterised by a collection of fluid within the middle ear without signs of acute inflammation. It is most common in young children, with a bimodal peak at 2 and 5 years of age. Eighty percent of children will have had a least one episode of OME by the age of 10 years. At age 7-8 years, about 8% of children will have middle ear effusions; this incidence increases in winter. The mean duration of effusions is 6-10 weeks but some cases are more persistent. OME is known to be a fluctuating condition with symptoms that vary with time and with age. The main symptom of OME is impaired hearing because the middle ear effusion causes a conductive hearing loss by reflection of the sound energy at the air-fluid interface. The diagnosis is based on suspicion of hearing loss, clinical history, clinical examination of the ears and appropriate audiometry and tympanometry. While most cases of OME will resolve spontaneously, some children will need intervention because of the effects of hearing loss. This intervention may take the form of educational and social action or the provision of a hearing aid to minimise the impact of the hearing loss. No non-surgical intervention has yet been shown conclusively to be of benefit. Surgical management usually takes the form of myringotomy and insertion of a ventilation tube (grommet), with or without adenoidectomy. Children with cleft palate are particularly susceptible to OME because of the impaired function of the Eustachian tube that results from the palatal anomaly, which in turn leads to a failure of middle ear ventilation. Similarly, children with Down's syndrome have a high incidence of OME, partly because of their impaired immunity

and mucosal abnormality, with resulting susceptibility to ear infection. These groups of children need particular surveillance for OME so that proper action can be taken. This guideline attempts to bring together the evidence related to surgical management of OME in children younger than 12 years, and to advise on best and safest practice; treatment decisions need to balance potential benefits against potential risks, reflecting the fact that the degree of benefit usually depends upon the severity and persistence of the condition.

Otitis Media with Effusion in Young Children

Patients with suspected or diagnosed cholesteatoma or permanent perforation of the eardrum in a dry ear should be referred to an ENT specialist. Adequate local treatment should be provided while the patient is waiting for the appointment with an ENT specialist.

Otitis Media

Diagnosis is based on ear-related signs and symptoms. The child should not unnecessarily be labelled as a "chronic ear patient". The criteria for acute otitis media (AOM) are middle ear effusion bulging, cloudy, yellowish tympanic membrane with distorted or absent light reflex (pictures) signs and symptoms of an acute infection. Redness alone is not a diagnostic finding (picture). Diagnostic accuracy is greatly improved with the use of pneumatic otoscopy and tympanometry . It is normal that some middle ear effusion persists after AOM, even for several weeks . This must not be interpreted as a new episode of AOM. Wrong and uncertain diagnoses result in unnecessary courses of antibiotics and tympanostomy tube insertions.
