Asian American Literature

An introduction to the literary works of Chinese-Americans, Japanese-Americans, Filipino-Americans, and Korean-Americans, this book focuses on the self-images and social contexts of the nineteenth-century immigrants, their descendants, and the Americanized writers of today. Although the book examines the novels, autobiographies, poems, and plays themselves, the social history of Asians in American is a significant backdrop—as Maxine Hong Kingston herself argues it should be. These racially distinctive Americans have confronted in their lives and writings American stereotypes of the "Oriental," racial discrimination, and the cultural gulf between East and West. After a chapter on Fu Manchu, Charlie Chan, and other Anglo-American caricatures of Asians, the author turns to a discussion of the first immigrant writers, many of whom were educated aristocrats playing the role of cultural ambassadors, and then to the less privileged, more socially critical generations of writers who followed. From works like *Flower Drum Song*, *Eat a Bowl of Tea*, *The Woman Warrior*, *China Men*, and a host of lesser-known writings, the author shows how portrayals of Chinatown, the Japanese-American family, and the roles of all the Asian-American women and men have changed. Drawing on her personal interviews with Asian-American writers, Kim also conveys their attitudes towards their own group, other Asian-Americans, other racial minorities, and white Americans—a complex mix of bitterness, acceptance, and militance. Asian American Literature

Ecocriticism and Asian American Literature: Gold Mountains, Weedflowers, and Murky Globes offers an ecocritical reinterpretation of Asian American literature. The book considers more than a century of Asian American writing, from Eaton's *Mrs. Spring Fragrance* (1912) to Ozeki's *A Tale for the Time Being* (2013), through an ecocritical lens. The volume explores the most relevant landmarks in Asian American literature: the first-contact narratives written by Bulosan, Kingston, Mukherjee, and Jen; the controversial texts published by Sui Sin Far (Edith Eaton) at the time of the Yellow Peril; the rise of cultural nationalism in the 1970s and 1980s, illustrated by Wong's *Homebase* and Kingston's *China Men*; old and recent examples of "internment literature" dealing with the incarceration of Japanese Americans during WWII (Sone, Houston, Miyake, Kadohata); and the new trends in Asian American literature since the 1990s, exemplified by Yamashita's and Ozeki's novels, which explore the challenges of our transnational, transnatural era. Begoña Simal-González's ecocritical readings of these texts provide crucial interdisciplinary insights, addressing and analyzing important narratives within Asian American culture and literature.

By paying special attention to what narrative theorists have regarded as one of the most extraordinary aspects of fiction—its ability to give (or else deny) readers a remarkably detailed knowledge of the inner lives of their characters—this book explores deeply and systematically the specific ways Asian American narratives attribute inscrutable minds to Asian American characters, situating them at various points along a spectrum stretching between alterity and empathy. Ultimately, the book reveals the link between narrative form and larger cultural issues associated with the representation of Asian American minds,

and how a nuanced investigation of narrative form can yield insights into the sociocultural embeddedness of Asian American literature under the case studies—insights that would not be available if such formal questions were by passed.

Alterity and Empathy in Post-1945 Asian American Narratives

In this age of rapid transition, Asian American studies and American studies in general are being reconfigured to reflect global migrations and the diverse populations of the United States. Asian American literature, in particular, has embodied the crisis of identity that is at the heart of larger academic and political debates surrounding diversity and the inclusion and exclusion of immigrant and refugee groups. These issues underlie the very principles on which literature, culture, and art are produced, preserved, taught, and critiqued. *Words Matter* is the first collection of interviews with 20th-century Asian American writers. The conversations that have been gathered here—interviews with twenty writers possessing unique backgrounds, perspectives, thematic concerns, and artistic priorities—effectively dispel any easy categorizations of people of Asian descent. These writers comment on their own work and speak frankly about aesthetics, politics, and the challenges they have encountered in pursuing a writing career. They address, among other issues, the expectations attached to the label "Asian American," the burden of representation shouldered by ethnic artists, and the different demands of "mainstream" and ethnic audiences.

The Big Aiiieeeee!

Drawing on a wide array of literary, historical, and theoretical sources, Rachel Lee addresses current debates on the relationship among Asian American ethnic identity, national belonging, globalization, and gender. Lee argues that scholars have traditionally placed undue emphasis on ethnic-based political commitments--whether these are construed as national or global--in their readings of Asian American texts. This has constrained the intelligibility of stories that are focused less on ethnicity than on kinship, family dynamics, eroticism, and gender roles. In response, Lee makes a case for a reconceptualized Asian American criticism that centrally features gender and sexuality. Through a critical analysis of select literary texts--novels by Carlos Bulosan, Gish Jen, Jessica Hagedorn, and Karen Yamashita--Lee probes the specific ways in which some Asian American authors have steered around ethnic themes with alternative tales circulating around gender and sexual identity. Lee makes it clear that what has been missing from current debates has been an analysis of the complex ways in which gender mediates questions of both national belonging and international migration. From anti-miscegenation legislation in the early twentieth century to poststructuralist theories of language to Third World feminist theory to critical studies of global cultural and economic flows, *The Americas of Asian American Literature* takes up pressing cultural and literary questions and points to a new direction in literary criticism.

The Routledge Companion to Asian American and Pacific Islander Literature

In *Double Agency*, Tina Chen proposes impersonation as a paradigm for teasing out the performative dimensions of Asian American literature and culture. Asian American acts of impersonation, she argues, foreground the limits of subjectivity even as they insist on the undeniable importance of subjecthood. By decoupling imposture from impersonation, Chen shows how Asian American performances have often been misinterpreted, read as acts of betrayal rather than multiple allegiance. A central paradox informing the book—impersonation as a performance of divided allegiance that simultaneously pays homage to and challenges authenticity and authority—thus becomes a site for reconsidering the implications of Asian Americans as double agents. In exploring the possibilities that impersonation affords for refusing the binary logics of loyalty/disloyalty, real/fake, and Asian/American, *Double Agency* attends to the possibilities of reading such acts as "im-personations"—dynamic performances, and a performance dynamics—through which Asian Americans constitute themselves as speaking and acting subjects.

Double Agency

In the eyes of mid-twentieth-century white America, "Aiiieeeee!" was the one-dimensional cry from Asian Americans, their singular expression of all emotions—it signified and perpetuated the idea of Asian Americans as inscrutable, foreign, self-hating, undesirable, and obedient. In this anthology first published in 1974, Frank Chin, Jeffery Chan, Lawson Inada, and Shawn Wong reclaimed that shout, outlining the history of Asian American literature and boldly drawing the boundaries for what was truly Asian American and what was white puppetry. Showcasing fourteen uncompromising works from authors such as Carlos Bulosan and John Okada, the editors introduced readers to a variety of daring voices. Forty-five years later the radical collection continues to spark controversy. While in the seventies it helped establish Asian American literature as a serious and distinct literary tradition, today the editors' forceful voices reverberate in contemporary discussions about American literary traditions. Now back in print with a new foreword by literary scholar Tara Fickle, this third edition reminds us how Asian Americans fought for—and seized—their place in the American literary canon.

Asian American Fiction, History and Life Writing

Divided into two parts – the first a combination of historical introduction and theoretical analysis, the second consisting of comprehensive, in-depth, detailed close readings of representative literary works – this book is a unique bridge connecting the fields of Comparative Literature, Asian American Studies, and Asian Studies. Through a repositioning of the Chinese component of Asian America in relation to the transformations of Chinese identity in modern times, it reads Asian American literature and Asian American literary studies in the context of the historical events and geopolitical changes that have informed the construction of “Chineseness”. Fracture Mechanics

When asked to start teaching a course on engineering fracture mechanics, I realized that a concise textbook, giving a general oversight of the field, did not exist. The explanation is undoubtedly that the subject is still in a stage of early development, and that the methodologies have still a very limited applicability. It is not possible to give rules for general application of fracture mechanics concepts. Yet our comprehension of cracking and fracture behaviour of materials and structures is steadily increasing. Further developments may be expected in the not too distant future, enabling useful prediction of fracture safety and fracture characteristics on the basis of advanced fracture mechanics procedures. The user of such advanced procedures must have a general understanding of the elementary concepts, which are provided by this volume. Emphasis was placed on the practical application of fracture mechanics, but it was aimed to treat the subject in a way that may interest both metallurgists and engineers. For the latter, some general knowledge of fracture mechanisms and fracture criteria is indispensable for an appreciation of the limitations of fracture mechanics. Therefore a general discussion is provided on fracture mechanisms, fracture criteria, and other metallurgical aspects, without going into much detail. Numerous references are provided to enable a more detailed study of these subjects which are still in a stage of speculative treatment.

Progress in Fracture Mechanics

Fracture and Mechanics is concerned with the experimental method of static and dynamic caustics and the Distribution of Determinant (Det.)-criterion of fracture. The Det.-criterion determines the conditions causing a crack and gives information on the expected angle of crack propagation. Mathematics cannot be avoided, but they are presented in a way that appeals to insight and intuition, in lieu of formal derivations which would show but the mathematical skill of the writer.

Finnie's Notes on Fracture Mechanics

This is not just another book on fracture mechanics. In recent years, there have been many books published on this subject in an attempt to assess the state of the art and its applications. The majority of the work dealt with energy release rate or critical stress intensity factor and is applicable only to fracture toughness testing. The main reason for this restriction is that the energy release concept cannot easily be extended to mixed mode fracture that occurs in practice as the rule rather than the exception. Cracks will normally curve or turn because the direction of loading can change as a function of time. Their directions of growth cannot be assumed as an a priori and must be determined from a pre-assumed criterion. Analysts are still perplexed with selecting an appropriate fracture criterion because it requires much discernment and judgement. Criteria which often appeared valid for idealized situations are quickly discredited when encountering more complex physical phenomena. Moreover, the claim of generality cannot be justified on the basis of agreement between theory and experiment for a few simple examples.

Application of Fracture Mechanics to Composite Materials

Problems of mixed mode crack propagation

The field of mechanics which focuses on the study of the propagation of cracks in materials is referred as fracture mechanics. It comprises the analysis of flaws that is used to discover which structures are safe and which ones are liable to propagate as cracks and thereby, resulting in the failure of the flawed structure. Safe operation of a structure can be achieved through damage tolerance analysis. The two kinds of fracture mechanics are linear elastic fracture mechanics and elastic-plastic fracture mechanics. Linear elastic fracture mechanics covers the concepts of Griffith's criterion, Irwin's modification, stress intensity factor, strain energy release and crack tip plastic zone. Elastic-plastic fracture mechanics focuses upon the concepts of crack tip opening displacement (CTOD), R-curve, J-integral, cohesive zone model and transitions flaw size. This book will also provide interesting topics for research which interested readers can take up. It studies, analyses and upholds the pillars of fracture mechanics and its

Liberating Voices

"When African American writers began to trust the literary possibilities of their own verbal and musical creations," writes Gayl Jones, they began to transform the European and European American models, and to gain greater artistic sovereignty. The vitality of African American literature derives from its incorporation of traditional oral forms: folktales, riddles, idiom, jazz rhythms, spirituals, and blues. Jones traces the development of this literature as African American writers, celebrating their oral heritage, developed distinctive literary forms. The twentieth century saw a new confidence and deliberateness in African American work: the move from surface use of dialect to articulation of a genuine black voice; the move from blacks portrayed for a white audience to characterization relieved of the need to justify. She documents how literary form is inherently and intensely national, and shows how the European monopoly on acceptable forms for literary art stifled American writers both black and white. Jones is especially eloquent in describing the dilemma of the African American writers: to write from their roots yet retain a universal voice; to merge the power and fluidity of oral tradition with the structure needed for written presentation. The New Negro

A Companion to African American Literature

More recent African-American literature has also been noteworthy for its largely affirmative vision of urban life. Amiri Baraka's 1981 essay "Black Literature and the Afro-American Nation: The Urban Voice" argues that, from the Harlem Renaissance onward, African-American literature has been "urban shaped," producing a uniquely "black urban consciousness." And Toni Morrison, although stressing that the American city in general has often induced a sense of alienation in many African-American writers, nevertheless adds that modern African-American literature is suffused with an "affection" for "the village within" the city.

Black Voices

During the last half of the twentieth century, a group of historically neglected but extremely powerful voices has emerged from the African American literary tradition. The voices of African American women have gathered strength from the suppressed tongues of their foremothers to provide insight into the history, psyche, and spirit of the African American woman. Professor Johnson examines the narrative strategies, with particular emphasis on the authorial and narrative voices, of three texts written by African American women: *Incidents in the Life of a Slave Girl* by Harriet Jacobs, *Their Eyes Were Watching God* by Zora Neale Hurston, and *The Color Purple* by Alice Walker.

The City in African-American Literature

Commissioned by the great Alain Locke and edited by Sterling A. Brown, *Negro Poetry and Drama* was an essential tool in the African American adult education movement during the early twentieth century. The fight for civil rights was accompanied by a move to educate African Americans who were forcibly ignorant to the histories and contributions of those before them. By showcasing the various works and biographies of black writers, poets, playwrights, and dramatists, *Negro Poetry* uncovers and celebrates voices of the past, offering unique stories which had previously been marginalized or otherwise ignored within the American canon. Complete with the original discussion questions at the end of each chapter, this edition of *Negro Poetry* gives us a glimpse of the steps African Americans took to re-educate and reclaim their narratives in the fight towards equality. Whitney Shepard has a background in English and African American Studies, with an interest in critical race theory and social justice. She is currently the Director of Development and Programs at the Policy Studies Organization in Washington DC.

African American Literature

New Black Voices

From the earliest texts of the colonial period to works contemporary with Emancipation, African American literature has been a dialogue across color lines, and a medium through which black writers have been able to exert considerable authority on both sides of that racial demarcation. Dickson D. Bruce argues that contrary to prevailing perceptions of African American voices as silenced and excluded from American history, those voices were loud and clear. Within the context of the wider culture, these writers offered powerful, widely read, and widely appreciated commentaries on American ideals and ambitions. *The Origins of African American Literature* provides strong evidence to demonstrate just how much writers engaged in a surprising number of dialogues with society as a whole. Along with an extensive discussion of major authors and texts, including Phillis Wheatley's poetry, Frederick Douglass's *Narrative*, Harriet Jacobs' *Incidents in the Life of a Slave Girl*, and Martin Delany's *Blake*, Bruce explores less-prominent works and writers as well, thereby grounding African American writing in its changing historical settings. *The Origins of African American Literature* is an invaluable revelation of the emergence and sources of the specifically African American literary tradition and the forces that helped shape it.

Within the Circle

Published in 1884, *Huck Finn* has become one of the most widely taught novels in American curricula. But where did *Huckleberry Finn* come from, and what made it so distinctive? Shelley Fisher Fishkin suggests that in *Huckleberry Finn*, more than in any other work, Mark Twain let African-American voices, language, and rhetorical traditions play a major role in the creation of his art. In *Was Huck Black?*, Fishkin combines close readings of published and unpublished writing by Twain with intensive biographical and historical research and insights gleaned from linguistics, literary theory, and folklore to shed new light on the role African-American speech played in the genesis of *Huckleberry Finn*. Given that book's importance in American culture, her analysis illuminates, as well, how the voices of African-Americans have shaped our sense of what is distinctively "American" about American literature. Fishkin shows that Mark Twain was surrounded, throughout his life, by richly talented African-American speakers whose rhetorical gifts Twain admired candidly and profusely. A black child named Jimmy whom Twain called "the most artless, sociable and exhaustless talker I ever came across" helped Twain understand the potential of a vernacular narrator in the years before he began writing *Huckleberry Finn*, and served as a model for the voice with which Twain would transform American literature. A slave named Jerry whom Twain referred to as an "impudent and satirical and delightful young black man" taught Twain about "signifying"--satire in an African-American vein--when Twain was a teenager (later Twain would recall that he thought him "the greatest man in the United States" at the time). Other African-American voices left their mark on Twain's imagination as well--but their role in the creation of his art has never been recognized. *Was Huck Black?* adds a new dimension to current debates over multiculturalism and the canon. American literary historians have told a largely segregated story: white writers come from white literary ancestors, black writers from black ones. The truth is more complicated and more interesting. While African-American culture shaped *Huckleberry Finn*, that novel, in turn, helped shape African-American writing in the twentieth century. As Ralph Ellison commented in an interview with Fishkin, Twain "made it possible for many of us to find our own voices." *Was Huck Black?* dramatizes the crucial role of black voices in Twain's art, and takes the first steps beyond traditional cultural boundaries to unveil an American literary heritage that is infinitely richer and more complex than we had thought.

African American Literary Theory

Three contemporary novels of slavery - Margaret Walker's *Jubilee* (1966), Sherley Anne Williams's *Dessa Rose* (1986) and Toni Morrison's *Beloved* (1987) - are the central focus of *Liberating Narratives*. In significantly different ways that reflect their individual and socio-political contexts of origin, these three novels can all be read as critiques of historical representation and as alternative spaces for

remembrance - 'sites of memory' - that attempt to shift the conceptual ground on which our knowledge of the past is based.

Voices from the Black Experience

Since the 18th century, African Americans have been contributing important works to American literature. However, their writing has been treated differently than those produced by white authors. Readers discover the challenges black authors have faced in having their work published and being taken seriously by critics and readers alike. Was Huck Black?

"Heretofore scholars have not been willing—perhaps, even been unable for many reasons both academic and personal—to identify much of the Harlem Renaissance work as same-sex oriented. . . . Christa Schwarz focuses on Countée Cullen, Langston Hughes, Claude McKay, and Richard Bruce Nugent and explores these writers' sexually dissident or gay literary voices. The portrayals of men-loving men in these writers' works vary significantly. Schwarz locates in the poetry of Cullen, Hughes, and McKay the employment of contemporary gay code words, deriving from the Greek discourse of homosexuality and from Walt Whitman. By contrast, Nugent—the only "out" gay Harlem Renaissance artist—portrayed men-loving men without reference to racial concepts or Whitmanesque codes. Schwarz argues for contemporary readings attuned to the complex relation between race, gender, and sexual orientation in Harlem Renaissance writing.

Black Voices

Dark Voices is the first sustained examination of the intellectual formation of W. E. B. Du Bois, tracing the scholar and civil rights leader's thought from his undergraduate days in the 1880s to the 1903 publication of his masterpiece, *The Souls of Black Folk*, and offering a new reading of his work from this period. Bringing to light materials from the Du Bois archives that have not been discussed before, Shamoan Zamir explores Du Bois's deep engagement with American and European philosophy and social science. He examines the impact on Du Bois of his studies at Harvard with William James and George Santayana, and shows how the experience of post-Reconstruction racism moved Du Bois from metaphysical speculation to the more instrumentalist knowledge of history and the new discipline of sociology, as well as toward the very different kind of understanding embodied in the literary imagination. Providing a new and detailed reading of *The Souls of Black Folk* in comparison with Hegel's *Phenomenology of Mind*, Zamir challenges accounts that place Du Bois alongside Emerson and James, or characterize him as a Hegelian idealist. This reading also explores Du Bois's relationship to African American folk culture, and shows how Du Bois was able to dramatize the collapse of many of his hopes for racial justice and liberation. The first book to place *The Souls of Black Folk* in its intellectual

context, *Dark Voices* is a case study of African American literary development in relation to the broader currents of European and American thought.

Liberating Narratives

Black Voices

Gay Voices of the Harlem Renaissance

Dark Voices

Liberating Voices

Drawing on a wide range of major literary voices, including Richard Wright, Ralph Ellison, and Toni Morrison, as well as lesser-known writers such as William Attaway (*Blood on the Forge*) and Dorothy West (*The Living Is Easy*), Rodgers conducts a kind of literary archaeology of the Great Migration. He mines the writers' biographical connections to migration and teases apart the ways in which individual novels relate to one another, to the historical situation of black America, and to African-American literature as a whole. In reading migration novels in relation to African-American literary texts such as slave narratives, folk tales, and urban fiction, Rodgers affirms the southern folk roots of African-American culture and argues for a need to stem the erosion of southern memory.

African-American Writers

Learning from Black voices means listening to more than snippets. It means attending to Black stories. Reading Black Books helps Christians hear and learn from enduring Black voices and stories as captured in classic African American literature. Pastor and teacher Claude Atcho offers a theological approach to 10 seminal texts of 20th-century African American literature. The Concise Oxford Companion to African American Literature

Relating the blues to American social and literary history and to Afro-American expressive culture, Houston A. Baker, Jr., offers the basis for a broader study of American culture at its "vernacular" level. He shows how the "blues voice" and its economic undertones are both central to the American narrative and characteristic of the Afro-American way of telling it.

Encyclopedia of African-American Literature

The New Red Negro surveys African-American poetry from the onset of the Depression to the early days of the Cold War. It considers the relationship between the thematic and formal choices of African-American poets and organized ideology from the proletarian early 1930s to the neo-modernist late 1940s. This study examines poetry by writers across the spectrum: canonical, less well-known, and virtually unknown. The ideology of the Communist Left as particularly expressed through cultural institutions of the literary Left significantly influenced the shape of African-American poetry in the 1930s and 40s, as well as the content. One result of this engagement of African-American writers with the organized Left was a pronounced tendency to regard the re-created folk or street voice as the authentic voice--and subject--of African-American poetry. Furthermore, a masculinist rhetoric was crucial to the re-creation of this folk voice. This unstable yoking of cultural nationalism, integrationism, and internationalism within a construct of class struggle helped to shape a new relationship of African-American poetry to vernacular African-American culture. This relationship included the representation of African-American working class and rural folk life and its cultural products ostensibly from the mass perspective. It also included the dissemination of urban forms of African-American popular culture, often resulting in mixed media high- low hybrids.

Canaan Bound

Fourteen contributions by Smith (library and information studies, Queens College) and other scholars discuss African-American young adult literature. A sampling of topics includes periodical literature for African-American young adults, supernatural African themes in horror literature, and positive images of African-American fathers in young adult literature.
