Based on the 2002 Revision, the Population Division has adopted 2 major innovations for this new set of long-range population projections. For the first time the long-range projections are made at the national level and the time horizon for the projections is extended to 2300.

International Transmission of Population Policy Experience

Since its early years, the United Nations has issued a series of international recommendations on population and housing censuses under the title “Principles and Recommendations for Population and Housing Censuses”. These publication series, which are based on good national practices in census taking, are widely used by national statistical offices and census officials in countries throughout the world in planning and carrying out population and housing censuses, as well as other related data collection activities, particularly demographic and socio-economic surveys. The recommendations provide guidance on the main characteristics of population and housing censuses, general material on census methodology, planning, and operations, and more detailed guidance on the content of censuses, in terms of topics for population and also housing. These series are currently revised to assist countries in preparing for the 2020 round of censuses by taking into account changes in methodology, technology, as well as the need for better data dissemination and utilization.

Population Growth and Demographic Structure

The general assumption throughout history has been that a growing population is beneficial for societies. By the mid-1960s, however, the United States and other developed countries became convinced that population control was an absolute necessity, especially in the developing world. This absorbing study explains why population control is no longer the focus of global population policy and why reproductive rights and health have become the major focus. The book highlights the role that the US and other developed countries play in affecting global population policy, looking in particular at the stance of the George W. Bush administration since taking office. It also studies the influence of the UN as an international forum and explores how civil society questioned the ethics of population control. *Global Population Policy* will appeal to a wide audience, including readers in the fields of women's studies, development politics and international relations.

Population Distribution and Migration

The population and housing census is part of an integrated national statistical system, which may include other censuses (for example, agriculture), surveys, registers and administrative files. It provides, at regular intervals, the benchmark for population count at national and local levels. For small geographical areas or sub-populations, it may represent the only source of information for certain social, demographic and economic characteristics. For many countries the census also provides a solid framework to develop sampling frames. This publication represents one of the pillars for data collection on the number and characteristics of the population of a country.

Advances in the biomedical sciences have raised pertinent, and often paradoxical, questions concerning the relationship between women's health and their rights. This book, based on the Round Table on Bioethics and Women held at UNESCO during the Fourth Session of the International Bioethics Committee (IBC), presents the experience of field workers and actors in areas as diverse as health, legal affairs, governance, education and psychology. It takes into account both the various stages of the biological life span and the insertion of women in a particular socio-economic and cultural context. Although the book does not claim to be exhaustive, it shows to what extent the specificity of issues related to women in relation to bioethical issues has sometimes been underestimated. Population policies and programmes

World Population to 2300

Principles and Recommendations for Population and Housing Censuses, Revision 3

This book takes an interdisciplinary approach to one of Japan's thorniest public policy issues: why are women increasingly forgoing motherhood? At the heart of the matter lies a paradox: although the overall trend among rich countries is for fertility to decrease as female labor participation increases, gender-friendly countries resist the trend. Conversely, gender-unfriendly countries have lower fertility rates than they would have if they changed their labor markets to encourage the hiring of women—and therein lies Japan's problem. The authors argue that the combination of an inhospitable labor market for women and insufficient support for childcare pushes women toward working harder to promote their careers, to the detriment of childbearing. Controversial and enlightening, this book provides policy recommendations for solving not just Japan's fertility issue but those of other modern democracies facing a similar crisis.

Report of the International Conference on Population and Development, Cairo, 5-13 September 1994

Population aging is perhaps the single biggest economic and social obstacle confronting Asia's future. The region-wide demographic transition towards an older population is fundamentally reshaping the demographic landscape, and is giving rise to two key socio-economic challenges. This timely book provides an in-depth analysis of these challenges and presents concrete policy options for tackling them. First, the expert contributors argue, Asia must find ways to sustain rapid economic growth in the face of less favorable demographics, which implies slower growth of the workforce. Second, they contend, Asia must find ways to deliver affordable, adequate and sustainable old-age economic security for its growing elderly population. Underpinned by rigorous analysis, a wide range of concrete policy options for sustaining economic growth while delivering economic security for the elderly are then presented. These include Asia-wide policy options relevant to the entire region such as building up strong national pension systems, whilst other policy options are more relevant to sub-groups of countries. Women's Rights and Bioethics

Migration, Women and Social Development

The book reviews also the situation of the developed countries and their specific challenges – sub-replacement fertility, population aging, and immigration – and examines the effectiveness of population policies. It also explores the way forward and future prospects for population policies over the next decades. The book provides numerous concrete examples from all over the world, and show how population policies are actually implemented and what have been their successes as well as their constraints. Above all, the book highlights the importance of understanding underlying demographic trends when assessing the development prospects of any country. The book is recommended for not only demographers, social scientists, and policymakers but also economists and political scientists who are interested in social and demographic change around the world. Demography students and researchers who are interested in applying knowledge on population trends and prospects in designing and evaluating public policies will find this an invaluable reference work.

Aging, Economic Growth, and Old-age Security in Asia

The United Nations population estimates and projections form a comprehensive set of demographic data to assess population trends at the global, regional and national levels. They are used in the calculation of many of the key development indicators commonly used by the United Nations system, including for more than one third of the indicators used to monitor progress towards the achievement of the Sustainable Development Goals. The 2019 revision of the World Population Prospects is the twenty-sixth edition of the official United Nations population estimates and projections, which have been prepared since 1951 by the Population Division of the Department of Economic and Social Affairs. The 2019 revision presents population estimates from 1950 until the present for 235 countries or areas, which have been developed through country-specific analyses of historical demographic trends. It builds on previous revisions by incorporating additional results from the 2010 and 2020 rounds of national population censuses as well as information from vital registration and recent nationally representative household sample surveys. The 2019 revision also presents population projections to the year 2100 that reflect a range of plausible outcomes at the global, regional and country levels. These Highlights summarise key population trends described by the estimates and projections presented in World Population Prospects 2019.

Causes of International Migration

The report presents findings from the 2018 revision of World Urbanization Prospects, which contains the latest estimates of the urban and rural populations or areas from 1950 to 2018 and projections to 2050, as well as estimates of population size from 1950 to 2018 and projections to 2030 for all urban agglomerations with 300,000 inhabitants or more in 2018. The world urban population is at an all-time high, and the share of urban dwellers, is projected to represent two thirds of the global population in 2050. Continued urbanization will bring new opportunities and challenges for sustainable development.

The World's Women 2010
