*Azemias* is a satirical attack on what William Beckford perceived as characteristically feminine novel-writing. First published in 1797, under the pseudonym *Jacquetta Agneta Mariana Jenks*, it joined its companion volume *Modern Novel Writing, or, The Elegant Enthusiast* (1796) in ridiculing the sentimental and sensational novels of the day, and especially the productions of William Lane's Minerva Press. However, it is also a biting political satire, attacking the Tory party and its leader, William Pitt the Younger, for the war with France, repressive legislation, and neglect of the poor. This is the first-ever scholarly edition of the novel and includes a new introduction by Robert J. Gemmett, as well as thorough annotations, a bibliography, and contemporary illustrations. William Beckford (1760-1844) was a novelist, travel writer, art critic, and collector. One of the most controversial figures of his time, as well reputedly the richest man in England, he is probably best remembered as the author of the Gothic novel *Vathek* (1786) and the creator of *Fonthill Abbey*. Robert J. Gemmett, Professor of English at the State University of New York, Brockport, is an acknowledged expert on William Beckford and is the author of numerous books and articles on his life and works. He is also editor of the first scholarly edition of *Modern Novel Writing*, published in 2008.

By presenting the novellas in light of such texts as Wollstonecraft's letters, her polemical and educational prose, similar works by other feminists and political reformists, the literature of sentiment, and contemporary medical texts, this edition encourages an appreciation of the complexity and sophistication of Wollstonecraft's writing goals as a radical feminist in the 1790s.

This innovative study will change the way we think not just about the history of reading, but about the genealogy of the canon wars, the future of intellectual property, and the role that anthologies play in our own classrooms.

The Sentimental Novel in the Eighteenth Century

*Writing the Lives of Painters* explores the development of artists' biographies in eighteenth- and early nineteenth-century Britain. During this period artists gradually distanced themselves from artisans and began to be recognised for their imaginative and intellectual skills. The development of the art market and the burgeoning of an exhibition culture, as well as the foundation of the Royal Academy of Arts in 1768, all contributed to redefining the rank of artists in society. This social redefinition of the status of artists in Britain was shaped by a thriving print culture. Contemporary artists were discussed in a wide range of literary forms, including exhibition reviews, art-critical pamphlets, and journalistic gossip-columns. Biographical accounts of modern artists emerged in a dialogue with these other types of writing. This book is an account of a new literary genre, tracing its emergence in the cultural context of the late eighteenth and early nineteenth centuries. It considers artistic biography as a malleable

generic framework for investigation. Indeed, while the lives of painters in Britain did not completely abandon traditional tropes, the genre significantly widened its scope and created new individual and social narratives that reflected and accommodated the needs and desires of new reading audiences. Writing the Lives of Painters also argues that the proliferation of a myriad biographical forms mirrored the privileging of artistic originality and difference within an art world that had yet to generate a coherent 'British School' of painting. Finally, by focusing on the emergence of individual biographies of British artists, the book examines how and why the art historiographic model established by Giorgio Vasari was gradually dismantled in the hands of British biographers during the Romantic period.

#### A Dictionary of the Anonymous and Pseudonymous Literature of Great Britain

James Watt's historically grounded account of Gothic fiction, first published in 1999, takes issue with received accounts of the genre as a stable and continuous tradition. Charting its vicissitudes from Walpole to Scott, Watt shows the Gothic to have been a heterogeneous body of fiction, characterized at times by antagonistic relations between various writers or works. Central to his argument about these works' writing and reception is a nuanced understanding of their political import: Walpole's attempt to forge an aristocratic identity, the loyalist affiliations of many neglected works of the 1790s, a reconsideration of the subversive reputation of *The Monk*, and the ways in which Radcliffean romance proved congenial to conservative critics. Watt concludes by looking ahead to the fluctuating critical status of Scott and the Gothic, and examines the process by which the Gothic came to be defined as a monolithic tradition, in a way that continues to exert a powerful hold.

#### Women Writing about Money

The years between the publication of Mary Wollstonecraft's *Vindication of the Rights of Woman* (1792) and of John Stuart Mill's essay *On the Subjection of Women* (1869) – a crucial phase in the emancipation movement – also saw the emergence of England's greatest women writers, whose response to the flux of new ideas as revealed in many outstanding works of fiction Dr Mews here examines. The central chapters of the book take the form of a perceptive and humane analysis of the way in which the greater women novelists conceived the role of women, on the one hand as young girls, wives and mothers, on the other as individuals standing alone in spinsterhood, as teachers or artists. The writers examined in detail are Fanny Burney, Maria Edgeworth, Jane Austen, the Brontë sisters, Elizabeth Gaskell, and George Eliot. Such a comprehensive study has not been attempted before. It throws light not only on the novel and the novelist in society but also on the transmutation of deeply felt experience into creative work.

#### A Gothic Bibliography (Unabridged)

This book investigates the critical importance of women to the eighteenth-century debate on property as conducted in the fiction of the period. April London argues that contemporary novels advanced several, often conflicting, interpretations of the relation of women to property, ranging from straightforward assertions of equivalence between women and things to subtle explorations of the self-possession open to those denied a full civic identity. Two contemporary models for the defining of selfhood through reference to property structure the book, one historical (classical republicanism and bourgeois individualism), and the other literary (pastoral and georgic). These paradigms offer a cultural context for the analysis of both canonical and less well-known writers, from Samuel Richardson and Henry Mackenzie to Clara Reeve and Jane West. While this study focuses on fiction from 1740–1800, it also draws on the historiography, literary criticism and philosophy of the period, and on recent feminist and cultural studies.

From the mid-sixteenth century, northern Europeans justified travel to the south in terms of education. The English had previously travelled to Italy to study the classics; now they travelled to learn Italian and study medicine, diplomacy, dancing, riding, fencing, and, eventually, art and architecture. Famous men, and an increasing proportion of women, all contributed to establishing a convention which eventually came to dominate European culture. Documenting the lives and travels of these personalities, Professor Chaney's remarkable book provides a complete picture of one of the most fascinating phenomena in the history of western civilisation.
