Across the Open Field

Twenty-eight years ago I went to England for a three-month visit and rest. What I found changed my life." So begins this memoir by one of America's best-known landscape architects, Laurie Olin. Raised in a frontier town in Alaska, trained in Seattle and New York, Olin found himself dissatisfied with his job as an urban architect and accepted an invitation to England to take a respite from work. What he found, in abundance, was the serendipity of a human environment built over time to respond to the land's own character and to the people who lived and worked there. For Olin, the English countryside was a palimpsest of the most eloquent and moving sort, yet whose manifestation was of ordinary buildings meant to shelter their inhabitants and further their work. With evocative language and exquisite line drawings, the author takes us back to his introduction to the scenes of English country towns, their ancient universities, meandering waterways, and dramatic cloudscapes racing in from the Atlantic. He limns the geologic histories found within the rock, the near-forgotten histories of place-names, and the recent histories of train lines and auto routes. Comparing the growth of building in the English countryside, Olin draws some sobering conclusions about our modern lifestyle and its increasing separation from the landscape. As much a plea for saving the modern American landscape as it is a passionate exploration of what makes the English landscape so characteristically English, *Across the Open Field* is "an affectionate ramble through real places of lasting worth.

Greater Perfections

Greater Perfections explores the meanings of garden and its relationship to other interventions into the natural world. But above all, it offers a new and challenging account of the role of representation in garden art.

A Life Spent Changing Places

Landscape architect, urban planner, teacher, and social visionary: over the course of a sixty-year career, Lawrence Halprin (1916-2009) reshaped the spaces we inhabit and our ways of moving through them. The *New York Times* called him "the tribal elder of American landscape architecture" and the critic Ada Louise Huxtable credited him with creating what "may be one of the most important urban spaces since the Renaissance." His bold use of abstract imagery could evoke the landscape of the American West in a sequence of city squares and fountains, while his plan for repurposing an abandoned factory near San Francisco's Fisherman's Wharf showed how adaptive use of a historic structure could turn commercial development into urban theater. A man who deeply loved cities, he left as one of his most important legacies the five thousand acres of coastline, hedgerows, and meadows that became Sonoma County's environmentally sensitive and enormously influential Sea Ranch. Featuring more than ninety black-and-white and one hundred color reproductions of photographs, plans, and sketchbooks, *A Life Spent Changing Places* is Halprin's own account of how a young boy who listened to the fireside chats of FDR on the radio became the man who designed the memorial to that president in the nation's capital. It is a book about the invention and reinvention of an extraordinary man over the span of decades and how he helped to reframe the world around him.

Edith Wharton sought his advice; Vita Sackville-West and Harold Nicolson admired and were influenced by him. Geoffrey Scott, author of *The Architecture of Humanism*, dedicated the book to him; and Sir Geoffrey Jellicoe, England's premier landscape architect, regarded Pinsent as his "first maestro on the placing of buildings in the landscape." This first book dedicated to bringing to light Pinsent's contribution to garden design is generously illustrated with photographs from his previously unpublished albums and archive of architectural drawings and sketches, and his letters to family friends and clients.

Hidden Histories

Born in Italy to a well-to-do Jewish family, Emilio Segrè (1905-1989) became Enrico Fermi's first graduate student in 1928, contributed to the discovery of slow neutrons and was appointed director of the University of Palermo's physics laboratory in 1936. While visiting the Radiation Laboratory in Berkeley, California in 1938, he learned that he had been dismissed from his Palermo post by Mussolini's Fascist regime. Ernest O. Lawrence hired him to work on the cyclotron at Berkeley with Luis Alvarez, Edwin McMillan, and Glenn Seaborg. For centuries artists and designers have recorded places, people, and life in travel sketchbooks. In 1903, Frank Albert Waugh (1869-1943) founded an undergraduate program in "landscape gardening" at Massachusetts Agricultural College, only the second such program in the nation. The profession he helped to pioneer is now known as landscape architecture, and the college has become the University of Massachusetts Amherst. Waugh, who had moved to New England in 1895 from his native Midwest, was one of the first practitioners to conceive of a history of American landscape architecture. He was a renowned teacher and horticulturalist as well as a prolific writer on topics ranging from design to pomology, a talented printmaker, photographer, and flutist. While Waugh's writings remained rooted in the principles of naturalistic nineteenth-century landscape gardening, his theories promoted modern applications. The most comprehensive of Waugh's several published books, and widely considered a classic in the field, *Book of Landscape Gardening* was first published in 1899 and revised several times. "Landscape gardening is eminently a fine art," Waugh began each edition of the popular text that became a standard in professional practice. In the chapters that follow, he covers several general principles of design and discusses three basic styles--the natural, the architectural, and the picturesque. The book achieved its broad appeal by striking a balance between well-known period examples and solutions that could be achieved by the professional designer, highway engineer, estate gardener, or average homeowner. Photographs, many of them taken by Waugh, depict far-ranging landscapes from Europe and Japan to diverse regions of the United States. Several plant lists and an annotated bibliography of landscape design sources accompany the text. In this edition, a new introduction by historian Linda Flint McClelland examines Waugh's contributions to landscape architecture during a period of great technological change, growing cultural sophistication, and economic prosperity. Site Soundscapes

'Site Soundscapes: Sonotope Design' is based on the assumption that landscape architects work on projects in which the acoustic aspects can be taken into consideration. In such projects activities are seen to be located within the landscape, and specific sounds belong to these activities. This research raised the orchestration of the soundscape as a new area of concern in the field of landscape

architecture; new methods of approaching the problem are suggested. The landscape is viewed as a space for sound sources and listeners where the sounds are transferred and coloured, such that each site constitute a 'sonotope.' Professionals can learn to recognise the auditory phenomena which are characteristic of a certain type of land use. Acoustic sources are obvious elements as a starting point in the planning process. Their effects on the soundscape can subsequently be evaluated according to various planning options. A prototype of a computer tool for use in landscape architecture is developed. This is intended to promote listening as well as stimulate an appreciation of the soundscape approach in the processes of planning and design.

Site Soundscapes

Universal Design, Design for All and Inclusive Design are all aimed at dismantling physical and social barriers to inclusion in all areas of life. Engagement in universal design is on the increase worldwide as practitioners and researchers explore creative and desirable solutions to shape the future of universal design products and practices. The guide invites landscape architects and urban designers to become soundscape architects and offers practical advice on sound and listening applicable to each stage of a design project: from reading the environment to intervening on it. Urban Soundscapes foregrounds listening as an affective mediator between subjects and multispecies environments, and a vehicle to think and conceptualise environmental research and design beyond prevailing visual and human-centred modes. The guide expands landscape architects'

and urban designers' tools and skills to assess existing soundscapes, predict how those soundscapes will be altered through their designs, consider sound as a creative and active part of the design process and envisage how users might perceive and be affected by those soundscapes as they evolve in time. The volume sits in the interface of research and practice and interweaves theoretical, methodological and creative contributions from acoustic ecology, ecoacoustics, bioacoustics and sound art. Each of the design stages is illustrated through project examples that demonstrate the many advantages of incorporating attentive listening and sound into Landscape Architecture and Urban Design Practice. This book shows how incorporating listening and sounding as part of the design process promotes slow and subtle ways of practice, adds social and ecological value through the reduction of noise pollution and by monitoring the health of habitats, and enables the design of soundscapes that complement the character and design intent of a scheme and elicit joy and wonder. The book will be of interest to practitioners and academics in landscape architecture, and other design and spatial fields such as urban design, architecture, geography and engineering, who play a primary role in the composition of the soundscape.

Urban Soundscapes

Landscape architecture is the design of outdoor and public spaces to achieve environmental, socio-behavioral, and/or aesthetic outcomes. It involves the systematic investigation of existing social, ecological, and geological conditions and processes in the landscape, and the design of interventions that will produce the desired outcome. The scope of the profession includes: urban design; site planning; town or urban planning; environmental restoration; parks and recreation planning; visual resource management; green infrastructure planning and provision; and private estate and residence landscape master planning and design - all at varying scales of design, planning and management. This book contains chapters on recent developments in studies of landscape architecture. For this reason I believe the book would be useful to the relevant professional disciplines.

Landscape Planning

This book gathers 14 original contributions published in an IJERPH Special Issue that deal with the perception of environmental sounds and how such sounds are likely to affect human quality of life and well-being and the experience of a place. The research focus over the years has been gradually shifting from treating sound simply as "noise" and something that cities should get rid of to a potential "resource" to promote and support community life in public spaces. Three main topics or "needs" to be addressed by researchers and practitioners emerged from this Special Issue: (1) the need to re-think "quietness" in cities as something that goes beyond the mere "pursuit of silence", (2) the need to integrate additional contextual factors in the characterization and management of urban acoustic environments for public health, and (3) the need to consider the acoustic quality of indoor spaces as opposed to an outdoor-only

perspective. The contributions collected in this book will hopefully trigger new questions and inform the agenda of future researchers and practitioners in the environmental acoustics domain.

Promoting Healthy and Supportive Acoustic Environments: Going beyond the Quietness

Traffic, music, language and nature help to create unique soundscapes that are essential to the place-based character of each city. Taking into account both the urban soundscape and the impacts of sound on the urban dweller, this book examines sound not as a by-product of urban life, but as a fundamental part of the urban experience that is crucial to understanding the city's sense of place. Illustrated by case studies from Europe and North America, these range from on-site measurements to the construction of audio tours for local tourism, from media analysis of popular culture audio drama to sound-identity and city branding, and from the classification of noise in city planning to a consideration of the complex relationship between sacred sound and the creation of a sense of place. Taking a social geographic perspective, the book focuses on the effects of sounds on the individual and how they influence the ways s/he engages the city as place, especially in their daily routines. In doing so, it uncovers the socio-scientific potential of sound in the urban environment, based on the understanding that sound cannot and must not be seen as detached from the urban landscape, but rather as a constituting element. Sound exists not only 'within the city': it 'is' the city.

Geographies of Urban Sound

As urban regions face the demand to decrease fossil fuel dependency, many cities in the developing world are undertaking initiatives designed to create a greener city by aiming for a more sustainable form of urban development and, to do so, they need to evaluate existing modes of transportation and patterns of land use. Focusing on Oslo, an early leader in urban environmental policy making and a European 'green city' award winner, it argues that this evaluation must adopt and integrate two approaches: firstly, as a process of ecological modernization based on a combination of transit, densification, and mixed use development and secondly, as an opportunity to reconsider the character and substance of the built environment as a reflection of natural values, landscapes and natural resources of the wider region. Environmental debate and concern is widespread in Oslo, and this is reflected in its earlier planning decisions to leave intact large forest reserves, its successful ecological restoration of the Oslo fjord, the importance of outdoor culture among its residents, the relatively progressive political agenda of Norway. This book provides an opportunity for a critical assessment of the limitations and opportunities inherent in 'green Oslo' and suggests the need for much broader integrative approaches. It concludes by highlighting lessons which other cities might learn from Oslo.

Green Oslo

Human beings have always been affected by their surroundings. There are various health benefits linked to being able to access to nature; including increased physical activity, stress recovery, and the stimulation of child cognitive development. The Oxford Textbook of Nature and Public Health provides a broad and inclusive picture of the relationship between our own health and the natural environment. All aspects of this unique relationship are covered, ranging from disease prevention through physical activity in green spaces to innovative ecosystem services, such as climate change adaptation by urban trees. Potential hazardous consequences are also discussed including natural disasters, vector-borne pathogens, and allergies. This book analyses the complexity of our human interaction with nature and includes sections for example epigenetics, stress physiology, and impact assessments. The Oxford Textbook of Nature and Public Health instead focuses on how nature can positively impact our health and wellbeing, and how much we risk losing by destroying it. The all-inclusive approach provides a comprehensive and complete coverage of the role of nature in public health, making this textbook invaluable reading for health professionals, students, and researchers within public health, environmental health, and complementary medicine.

Why should urban planning in our time be obsessed with the issue of sustainability? Or differently put, is sustainability really as desirable and possible as its proponents in urban planning (and other related fields like economics, political science, environmental studies, architecture, and so on) would like us to believe? Contrary to the conventional wisdom held by many since the modern era, the concern with

sustainability has been much exaggerated and distorted, to the point that it is fast becoming a new intellectual fad, so that its dark sides have been unwarrantedly ignored or downgraded. This is not to say, however, that the literature on sustainability in urban planning (and other related fields) hitherto existing in history has been full of nonsense. Indeed, on the contrary, much can be learned from different theoretical approaches in the literature. The important point to remember here, however, is that this book provides an alternative (better) way to understand the nature of sustainability in urban planning (and other related fields), which learns from different sides of the debate but in the end transcends them all. The urgency of this inquiry should not be underestimated, as it concerns not only urban planning (as a case study here) but also other highly related yet very serious challenges in our time (e.g., ecological, economic, demographic, technological, moral, spiritual, political, and the like). Therefore, if true, this seminal view will fundamentally change the way that we think about the issue of sustainability, with its enormous implications not only for understanding the future of urban planning, in a small sense—but also for predicting the relevance of sustainability in relation to the entire domain of human knowledge for the human future and what I originally called its “post-human” fate, in a broad sense.

The Future of Post-Human Urban Planning

Why is it that modern architects and planners - these benevolent and socially visionary experts - have created environments that can make one feel so uneasy? Using a philosophical and psycho-analytical approach, this book critically examines expert knowledge within architecture and urban planning. Its point of departure is the gap between visions and realities, intentions and outcomes in planning, with particular focus on projects in Sweden that try to create an urban atmosphere. Finding insights from the work of Sigmund Freud and his followers, the book argues that urban planning during the 20th century is a neurotic activity prone to produce a type of alienation. Besides trying to understand the gap between intentions and outcomes in planning, the book also discusses how to define the concept of the urban, juxtaposing different knowledge traditions; contrasting the positivistic theory of space syntax with poetic-dialectical approaches, the planner view of the city with that of the flâneur, examining texts by Virginia Woolf and August Strindberg.

These include Meyers' work with Stephen Vitiello, whose piece *A Bell For Every Minute* animated the New York High Line project, and her collaborations with composer and sound artist Michael Schumacher. *Digital Water i-Pavilion*, located opposite Ground Zero in Manhattan, has proved particularly innovative: Schumacher's score, developed especially for the building, has been etched into a glass facade which can be 'played' by the public via an app; onlookers direct their mobile phones at the glass to read and hear the music. Sound is not simply music however, and Meyers reflects upon this in her quest for an understanding of architecture as an auditory environment, through examples of buildings and materials which inspire and possess characteristic sonic properties.

The Architecture and Landscape Architecture of Jones & Jones

This collection of critical essays and photographs provides an overview of nine recent projects of Jones & Jones Architecture and Landscape Architecture. An introduction by the author provides personal and organizational history and context.

Landscape Architecture Theory

For decades, landscape architecture was driven solely by artistic sensibilities. But in these times of global change, the opportunity to reshape the world comes with a responsibility to consider how it can be resilient, fostering health and vitality for humans and nature. Landscape Architecture Theory re-examines the fundamentals of the field, offering a new approach to landscape design. Drawing on his extensive career in teaching and practice, Michael Murphy begins with an examination of influences on landscape architecture: social context, contemporary values, and the practicalities of working as a professional landscape architect. He then delves into systems and procedural theory, while making connections to ecosystem factors, human factors, utility, aesthetics, and the design process. He concludes by showing how a strong theoretical understanding can be applied to practical, every-day decision making and design work to create more holistic, sustainable, and creative landscapes. Students will take away a foundational understanding of the underpinnings of landscape architecture theory, as well as how it can be applied to real-world designs; working professionals will find stimulating insights to infuse their projects with a greater sense of purpose.

Beatrix Jones Farrand (1872-1959)

Honored with the 1990 American Institute of Architects Gold Medal for a lifetime of outstanding achievement, Fay Jones is an Arkansas original. In receiving the medal from Prince Charles of Great Britain, Jones was hailed as a “powerful and special genius who embodies nearly all the qualities we admire in an architect” and as an artist who used his vision to craft “mysterious and magical places” not only in Arkansas but all over the world. This book accompanied a special museum exhibit of Jones’s life and work at the Old State House in Little Rock. It traces Jones’s development from his early years as a student of Frank Lloyd Wright and Bruce Goff, to the culmination of his ability in such arresting structures as Pinecote Pavilion in Picayune, Mississippi; Thorncrown Chapel in Eureka Springs, Arkansas; and Chapman University Chapel in Orange, California. Through the black-and-white photographs of the homes, chapels, and other buildings that Jones has created and the accompanying captions and interviews of the architect, the reader is allowed a view into this man’s remarkable talent. Designing structures that fuse architecture and landscape, the organic and the man-made, Jones has created special places which touch their viewers with the power and subtlety of poetry. Herein we learn why. From the Foreword by Robert Adams Ivy Jr.: “Fay Jones’s architecture begins in order and ends in mystery. . . . His role can perhaps best be understood as mediator, a human consciousness that has arisen from the Arkansas soil and scoured the cosmos, then spoken through the voices of stone and wood, steel and glass. Art, philosophy, craft, and human aspiration coalesce in his masterworks, transformed from acts of will into harmonies: Jones lets space sing.”

Outside the Pale

Grant Jones, founding principal of the noted landscape architecture firm Jones & Jones, has practiced ecological design for more than 30 years and has been a pioneer in river planning, scenic highway design, zoo design, and landscape aesthetics. The latest addition to our successful Source Books in Landscape Architecture series, Grant Jones/Jones & Jones ILARIS, focuses on Jones's "green print" plan for Puget Sound in Washington State. Working in collaboration with the Trust for Public Lands and using new GIS technology, Jones & Jones developed the software tool ILARIS. This CAD-like tool helps to evaluate the aesthetic resources of landscape regions and is used as a basis for future planning.

The Puget Sound model can be applied to other landscapes at risk. Including an interview with Grant Jones, critical essays discussing his work, as well as numerous diagrams, plans, and photographs, Grant Jones/Jones & Jones ILARIS is a thorough study of an important project.

Grant Jones / Jones & Jones

Archibald Quincy Jones (1913-79) was a Los Angeles-based architect and educator who shared the Case Study goal of reinventing the house as a way of redefining the way people lived in post-war America. A pioneer in 'greenbelt' planning and 'green' design, Jones raised the level of the tract house in California from the simple stucco box to a structure of beauty and logic surrounded by gardens and integrated into the landscape. He introduced new materials and a new way of living within the built environment: his work bridged the gap between custom- and developer-built homes. The exquisite detailing and siting of Jones's houses, churches, civic and university buildings make them quintessential embodiments of mid-century American architecture. This is the first ever book to be published on Jones. It documents his full career, from his post-war planning projects to his long association with Palo Alto building magnate Joseph Eichler. The volume consists of two parts: a substantial introductory essay tracing Jones's life and career, with a synopsis of key projects and his contributions to planning; and a catalogue of 60 of Jones's projects illustrated with high-quality black-and-white period photographs, and plans and renderings by Jones himself.

Handbook of Landscape Archaeology

Dolmens are iconic international monumental constructions which represent the first megalithic architecture (after menhirs) in north-west Europe. These monuments are characterised by an enormous capstone balanced on top of smaller uprights. However, previous investigations of these extraordinary monuments have focussed on three main areas of debate. First, typology has been a dominant feature of discussion, particularly the position of dolmens in the ordering of chambered tombs. Second, attention has been placed not on how they were built but how they were used. Finally much debate has centred on their visual appearance (whether they were covered by mounds or cairns). This book provides a reappraisal of the 'dolmen' as an architectural entity and provides an alternative perspective on function. This is achieved through a re-theorising of the nature of megalithic architecture grounded in the results of a new research/fieldwork project covering Britain, Ireland and Scandinavia. It is argued that instead of understanding dolmen simply as chambered tombs these were multi-faceted monuments whose construction was as much to do with enchantment and captivation as it was with containing the dead. Consequently, the presence of human remains within dolmens is also critically evaluated and a new interpretation offered.

Clough Williams-Ellis

American Institute of Architects Gold Medalist E. Fay Jones is one of the most respected, admired, & honored architects in practice today. Frank Lloyd Wright's principles of organic architecture have inspired his work, but Jones has created his own order & point of view. Monuments in the Making

Historic landscapes have often been ignored in historic preservation. In 1987, Dr. Charles L.W. Leider asked design professionals and the public to nominate significant historic cultural landscapes in Oklahoma. As a result of this effort, 47 significant historic landscapes were identified. Students in Dr. Leider's historic preservation course at Oklahoma State University (OSU) conducted an inventory and analysis of these sites and, over a 25-year period, selected and completed 18 case studies as measured and interpreted drawings, including Villa Philbrook, 101 Ranch, Oklahoma Civic Center, and Utica Square in Tulsa. All of the case studies have been recorded with the Historic American Landscapes Survey (HALS) of the US National Park Service and placed in the US Library of Congress as well as being presented in this book.

Fay Jones

Winner, 2017 Ned Shank Award for Outstanding Preservation Publication from Preserve Arkansas *Shadow Patterns: Reflections on Fay Jones and His Architecture* is a collection of critical essays and personal accounts of the man the American Institute of Architects honored with its highest award, the Gold Medal, in 1990. The essays range from the academic, with appreciations and observations by Juhanni Palaasma and Robert McCarter and Ethel Goodstein-Murphree, to personal reflections by clients and friends. Two of Arkansas's most accomplished writers, Roy Reed and Ellen Gilchrist, who each live in Fay Jones houses, have provided intimate portrayals of what it's like to live in, and manage the quirks of, a "house built by a genius," where "light is everywhere. . . . Everything is quiet, and everything is a surprise," as Gilchrist says. Through this compendium of perspectives, readers will learn about Jones's personal qualities, including his strong will, his ability to convince other people of the rightness of his ideas, and yet his willingness, at times, to change his mind. We also enter into the work: powerful architecture like Stoneflower and Thorncrown Chapel and Pinecote Pavilion, along with private residences ranging from the modest to the monumental. And we learn about his relationship with his mentor, Frank Lloyd Wright. *Shadow Patterns* broadens and enriches our understanding of this major figure in American architecture of the twentieth century.

Historic Cultural Landscapes of Oklahoma

Shadow Patterns

The book will be of interest to scholars working in art history, contemporary art, environmental studies, environmental humanities, and Native American studies.

An Introduction to Political Geography provides a broad-based introduction to how power interacts with space; how place influences political identities; and how policy creates and remoulds territory. By pushing back the boundaries of what we conventionally understand as political geography, the book emphasizes the interactions between power, politics and policy, space, place and territory in different geographical contexts. This is both an essential text for political geographers and also a valuable resource for students of related fields with an interest in politics and geography.

The Designs of Inigo Jones

Between 2018 and 2019, Cornwall Archaeological Unit undertook two projects at Mount's Bay, Penwith. The first involved the excavation of a Bronze Age barrow and the second, environmental augur core sampling in Marazion Marsh. Both sites lie within an area of coastal hinterland, which has been subject to incursions by rising sea levels. Since the Mesolithic, an area of approximately 1 kilometer in extent between the current shoreline and St Michael's Mount has been lost to gradually rising sea levels. With current climate change, this process is likely to occur at an increasing rate. Given their proximity, the opportunity was taken to draw the results from the two projects together along with all available existing environmental data from the area. For the first time, the results from all previous palaeoenvironmental projects in the Mount's Bay area have been brought together. Evidence for coastal change and sea level rise is discussed and a model for the drowning landscape presented. In addition to modeling the loss of land and describing the environment over time, social responses including the wider context of the Bronze Age barrow and later Bronze Age metalwork deposition in the Mount's Bay environs are considered. The effects of the gradual loss of land are discussed in terms of how change is perceived, its effects on community resilience, and the construction of social memory and narratives of place. The volume presents the potential for nationally significant environmental data to survive, which demonstrates the long-term effects of climate change and rising sea levels, and peoples' responses to these over time.
