Murder Over Dorval

By the author of *The Crime on Cotes des Neiges*, this is the second title in the Véhicule Press Ricochet series of hard-boiled detective novels set in Montreal. Originally published in 1952, *Murder Over Dorval* follows the investigations of hard-drinking, seasoned private dick, Russell Teed. First Edition back cover: In one hand she held a plane ticket for Montreal, in the other, a wad of greenbacks. She was a gorgeous looking redhead. For the sake of her lovely green eyes, Russell Teed took the plane and the money. But

it wasn't long before he realized that whatever she had offered it wasn't worth it. The Murder Diaries - Seven Times Over

Marie Dorval

Dumas, Vigny, Hugo, Sand, Gautier and many others mingle their creative and affective energies with Dorval's in a ceaseless dynamic interplay. Canadian Crime Fiction

Panic Fiction explores a unique body of antebellum American women's writing that illuminates women's relationships to the marketplace and the links between developing ideologies of domesticity and the formation of an American middle class. Between the mid-1830s and the late 1850s, authors such as Hannah Lee, Catharine Sedgwick, Eliza Follen, Maria McIntosh, and Maria Cummins wrote dozens of novels and stories depicting the effects of financial panic on the home and proposing solutions to economic instability. This unique body of antebellum American women's writing, which integrated economic discourse with the language and conventions of domestic fiction, is what critic Mary Templin terms "panic fiction." In *Panic Fiction: Antebellum Women Writers and Economic Crisis*, Templin draws in part from the methods of New Historicism and cultural studies, situating these authors and their texts within the historical and cultural contexts of their time. She explores events surrounding the panics of 1837 and 1857, prevalent attitudes toward speculation and failure as seen in newspapers and other contemporaneous texts, women's relationships to the marketplace, and the connections between domestic ideology and middle-class formation. Although largely unknown today, the phenomena of "panic fiction" was extremely popular in its time and had an enormous influence on nineteenth-century popular conceptions of speculation, failure, and the need for marketplace reform, providing a distinct counterpoint to the analysis of panic found in newspapers, public speeches, and male-authored literary texts of the time.

Panic Fiction

Orders to Kill (Home Front Detective 9)

Intricate Relations charts the development of the novel in and beyond the early republic in relation to these two thematic and intricately connected centers: sexuality and economics. By reading fiction written by Americans between 1789 and 1814 alongside medical theory, political and economic tracts, and pedagogical literature of all kinds, Karen Weyler recreates and illuminates the larger, sometimes opaque, cultural context in which novels were written, published, and read. In 1799, the novelist Charles Brockden Brown used the evocative phrase “intricate relations” to describe the complex imbrication of sexual and economic relations in the early republic. Exploring these relationships, he argued, is the chief job of the “moral historian,” a label that most novelists of the era embraced. In a republic anxious about burgeoning individualism in the 1790s and the first two decades of the nineteenth century, the novel foregrounded sexual and economic desires and explored ways to regulate the manner in which they were expressed and gratified. In Intricate Relations, Weyler argues that understanding how these issues underlie the novel as a genre is fundamental to understanding both the novels themselves and their role in American literary culture. Situating fiction amid other popular genres illuminates how novelists such as Charles Brockden Brown, Hannah Foster, Samuel Relf, Susanna Rowson, Rebecca Rush, and Sally Wood synthesized and iterated many of the concerns expressed in other forms of public discourse, a strategy that helped legitimate their chosen genre and make it a viable venue for discussion in the decades following the revolution. Weyler’s passionate and persuasive study offers new insights into the civic role of fiction in the early republic and will be of great interest to literary theorists and scholars in women’s and American studies.

The Dusty Bookcase

Montreal in the 1940s and '50s was Canada's largest, richest, most vibrant and colourful city. It was, at the end of those prosperous decades, "bursting at the seams," still growing, still far ahead of Toronto. No one then could foresee the rise of Quebec separatism, which would cripple the city, and send it into its long decline. In "City Unique, William Weintraub introduces the reader to many of the extraordinary characters who gave Montreal its singular flavour. They include Camillien Houde, the mayor who was interned during the war for advocating treason; Lili St. Cyr, the ultimate striptease artiste, who mesmerized men and boys; Maurice Duplessis, the dictatorial premier who could evict individuals from their homes if he suspected they were communist; Harry Ship, the czar of illegal gambling dens; and Anna Beauchamp, the flamboyant madam who operated a string of at least a dozen brothels. Montreal was a "wide-open town," the vice capital of Canada, where the amply bribed police and politicians connived to resist all attempts at reform. But two crusaders, Pacifique Plante and Jean Drapeau, were determined to clean up the city and Weintraub gives a lively account of their battle with the vice lords. During the era, far-reaching changes took place within the communities that comprised Montreal's three solitudes - the English, the French, and the Jewish - and the author examines their effects. He also describes the city's passionate ideologues, both communist and fascist, their struggles and changing fortunes in the aftermath of the Second World War. He examines, too, the emergence of a generation of novelists, playwrights and poets, including Hugh MacLennan, Gabrielle Roy, Irving Layton and others who set a new standard for Canadian literature. The 1940s and '50s were a unique period, different from everything that came before - the Great Depression, the lingering stuffiness of the Edwardian era - and different from the period that followed - signaled by Quebec's Quiet Revolution. It was a pivotal, momentous time. William Weintraub, writing with indignation and affection, brings the Montreal of his youth vividly, entertainingly and wittily to life in this extraordinary book.

A blindingly blonde woman walks into private detective Mike Garfin's downtown Montreal office, complaining that she's being followed by a man. Their names resonate with organized crime in Montreal: the Matticks, MacAllisters, Johnstons and Griffins, and Peter Dunie Ryan. They are the Irish equivalent of the infamous Rizzuto and Cotroni families, and the "Mom" Bouchers and Walter Stadnicks of the Hells Angels. Award-winning producer,

journalist and author D'Arcy O'Connor narrates the genesis and rise to power of one of Montreal's most powerful, violent and colorful criminal organizations. It is the West End Gang, whose members controlled the docks and fought the Hells Angels and Mafia for their share of the city's prostitution, gambling, loan sharking and drug dealing. At times, they did not disdain forging alliances with rival gangs when huge profits were at stake, or when a killing needed to be carried out. The West End Gang—the Irish Mafia of Montreal—is a legendary beast. They sprang out of the impoverished southwest of the city, some looking for ways to earn enough just to survive, some wanting more than a job in an abattoir or on a construction site. In that sense, they were no different from other immigrants from Italy and other European countries. A shortcut to wealth was their common goal. And Montreal, with its burgeoning post-WWII population, was ripe for the picking. The Irish Mob made headlines with a spectacular Brinks robbery in 1976, using the money to broker a major heroin and cocaine trafficking ring. It took over the Port of Montreal, controlling the flow of drugs into the city, drugs which the Mafia funnelled to New York. The West End Gang had connections to the cocaine cartel in Colombia; hashish brokers in Morocco and France; and marijuana growers in Mexico. The gang imported drugs on an enormous scale. One bust that took place off the coast of Angola in 2006 involved 22.5 tonnes of hashish, destined for Montreal. The West End Gang is a ripping tale that unveils yet another chapter in Montreal's colorful criminal underworld.

The Fabric of Murder

Norwich in the 1760s is one of the largest and most prosperous cities in the realm. Its wealth comes from a booming trade in the famous "Norwich Stuffs"--fine worsted cloth, often richly dyed and embroidered. So when a leading cloth-manufacturer in the city is murdered and his business seems on the brink of collapse, there is a real fear that a forced sale of his huge stocks of cloth will ruin the trade for everyone else. And when the fabric of truth begins to unravel, it's up to Dan to piece together the facts, one thread at a time. Some secrets should never be kept. But when they're too terrible to tell, all that's left is revenge. And it seems that, after all, the scene is set for a mystery.

The Facts Behind the Guard House Murder, 1864, Keighley

The 1960s was one of the most tumultuous and divisive decades in world history. In London's east end, Jude and Anna, two young lovers born in poverty, struggle to forge a worthwhile future. Jude Croaker's mother had always told him that his father was a Lord, the Marquess of Melchester. Jude and Anna's discovery of who his father is leads them both into dishonesty and deceit. Silk Stalkings

Aligning the desire to create with a sense of guilt and dwelling on every impulse in the mind of a poet except those concerned with his work, Constantine Sult fashions a novel that is a stark and explicit portrait of contemporary man. Alternating between minutely detailed physical description and the referenceless intricacies of thought, *THE MURDER OF LINEN* follows Wyndaul Dressage as he wanders between his job and various lovers during the course of three days, obsessing over his desire to successfully confess to a crime he has not committed and ignoring his personal obligations and pursuits.

The Blantyre House Prison Affair

In this autobiographical account of his life as a prison governor and administrator, Tom Murtagh deals with life in charge of The Maze Prison, Northern Ireland - when he narrowly avoided being killed by a terrorist bomb - and his move to England. This is when he was faced with a remarkable series of events at Blantyre House where a modern, liberal, ground-breaking, and in many respects, successful regime was beginning to attract the attention of reformers, academics, and others. But that regime also masked more sinister developments - events that should ultimately have received serious attention from a House of Commons Select Committee set up to look into 'The Blantyre House Affair.' Only now - and after much reflection - does Tom Murtagh feel able to tell publicly his side of the affair of how the committee chose to concentrate on selective and misleading information. Despite all the accolades for Blantyre House, behind the scenes and in reality, the regime was being taken advantage of by a number of very serious offenders who had managed to get themselves transferred there so that the establishment was at risk of being overtaken by organized crime and corruption, leading to covert police and other criminal investigations. The book tells how the author acted to preempt this, only to be vilified by HM Inspectorate of Prisons, some penal reform groups, and ultimately the committee. The Blantyre House Affair is a telling example of how people can sometimes be swept along by events that may cause them to ignore those things that are counter or inconvenient to their own aims or interpretation.

Blantyre House Prison

Blantyre House prison in Kent had a 'reputation for excellence' in the resettlement of offenders. On May 5th 2000, the Governor was removed abruptly from his post and the same evening, 84 prison officers from other prisons were sent into the prison to conduct a full, overnight search. The report from the search was that 'there were no significant finds' but the trust which underpins the resettlement ethos had been destroyed. This report examines why these events happened and the results. The report concludes that what took place at Blantyre House was a serious error of judgement by the Prison Service and that capable governors and staff need to be reassured that they work for a competent employer. The status of Blantyre House must be clarified and a real effort must be made to revive the ethos of trust. The Committee expressed dissatisfaction at the attempts made to mislead the Committee and the public over the significance of finds made during the search. Recommendations include: when something goes seriously wrong in the Prison Service, investigations should be conducted independently by the Chief Inspector of Prisons; new inspection arrangements for the work of prisons should apply to the overall management of the Prison Service; and the Prison Service publish urgently a policy on resettlement and report to the House in one year's time on what has been achieved.

The Maze Prison

The Maze Prison shows how an establishment built to hold those involved in terrorism, atrocities, murder and allied crimes became a pawn in the partisan conflict that was Northern Ireland. There followed a breakdown of norms, values and control as the last of these shifted from Governors to Ministers, outside officials and even prisoners. This led to the (often random) killing of prison officers and countless allegations, denials and obfuscations, as Prison Rules came into conflict with claims to be treated as prisoners-of-war or be given Special Category status. A social document par excellence, this stark slant on The Troubles and Peace Process cuts through the propaganda and base politics to reveal the truth about the H-Blocks, hunger-strikes, escapes and power struggles. Based on actual records and personal accounts, it challenges myths and legends to warn how easily a community can descend into what the author calls anomie. The Monstering of Myra Hindley

The book is written from the perspective of a participant observer. It is not strictly an autobiography or a history, although it has elements of both, as it would fail without them. It is intended for both the general reader and criminal justice professionals. My intention is that the book is educational, showing the prison system over three decades in the context of social, political and organisational change, in particular the impact of the decline of deference, the growth of public managerialism and the rise of political correctness. The trenchant opinions expressed are based on intellectual rumination, observation of human behaviour, and personal and professional experience. I have deliberately chosen a thematic approach for the book so that explanation and information work in tandem, giving a unique insight into the modern prison service and the workings of the public sector.

26 Years Behind Bars

This is a comprehensive, detailed and humane account of the thousands who came into custody during the years of the Northern Ireland conflict and how they lived out the months, years and decades in Irish and English maximum security prisons. Erupting in 1969, the Northern Ireland troubles continued with terrible intensity until 1998. The most enduring civil conflict in Western Europe since the Second World War cost almost 4,000 lives, inflicted a vast toll of injuries and wrought much destruction. Based on extensive archival research and numerous interviews, this book covers the jurisdictions of Northern Ireland, the Republic of Ireland and England, providing an account of riots, escapes, strip and dirty protests and hunger strikes. It paints a picture of coming to terms with sentences, some of which lasted for two decades and more. Republicans and loyalists, male and female prisoners, officials and staff, families, supporters, clergy and politicians all played a part – and all were changed. The narrative includes some of the most remarkable events in prison history anywhere – mass breakouts, organised cell-fouling and prolonged nakedness, and hunger striking to the death; there are also accounts of the prisoners' very effective parallel command structure. The book shows how Anglo-Irish and intra-Irish relations were profoundly affected and how the prisoners' involvement and consent were critical to the Good Friday Agreement that ended the long war. The final part of a trilogy dealing with Irish political prisoners from 1848 to 2000 by renowned expert Seán McConville, this is an essential resource for students and scholars of Irish history and Irish political prisoners; it is also a major contribution to the study of imprisonment.

Prisongate

The aim of the report is to highlight what the Committee felt were the most important and controversial measures of the Bill, to lay out the arguments for and against, and to reach a tentative conclusion in time for the second reading debate. The Committee concluded that the Bill should be given a second reading, but it will need close examination in committee. Doubt is expressed whether a bill of this length and with major implications for civil liberties should be passed through the Commons in such a short period and with so little time for detailed examination. The legislation will pass through the Commons in two weeks with only three days of debate by all MPs. The report recommends that the Government should seek an alternative measure, in consultation with other European partners, which avoids the need to exercise the power of indefinite detention. It expresses reluctant acceptance that there may be a small category of persons who will have to be detained, but states that this should only be exercised as a last resort, for those who cannot be prosecuted, extradited or deported. The report recommends that a "sunset" clause should apply to the immigration and asylum provisions of the Bill, which would

mean detention powers would lapse after five years. A full parliamentary debate would then be needed for an annual renewal order, rather than a 90 minute debate in a standing committee. The report also states that there is insufficient evidence to justify the extension of the law of incitement to include religious hatred, as it is doubtful that this will work in practice.
