Greek Capitalism in Crisis

Despite the depth of the Greek crisis, the exorbitant burdens placed upon the working people and the massive popular resistance movement to capitalist policies, there is a definite lack of consistently Marxist analyses of the Greek problem. International debates regarding the Greek crisis have been dominated by orthodox (Neoclassical and neo-Keynesian) approaches. The heterodox side of these debates has been occupied by Radical Political Economy approaches (usually radical post-Keynesian or Marxo-Keynesian perspectives). Moreover, they are dominated by the 'financialisation' thesis which is quite alien to Marxism, neglects the sphere of production and professes that the global crisis is simply a financial crisis that has nothing to do with 'real' accumulation and the profit rate. This book argues that by emphasising the sphere of production and profitability, classical Marxist analysis better explains the Greek crisis than its orthodox and heterodox competitors. The contributors present critiques of the prevalent approaches and offer studies of the Greek crisis that use the methodology and the analytical and empirical tools of classical Marxist Political Economy. In particular, it is shown that the Greek crisis was caused by falling profitability and the ensuing overaccumulation crisis. The 'broad unequal exchange' existing between the euro-center and the euro-periphery contributed to Greek capital's falling profitability. This book enriches the debate about the Greek economic crisis by demonstrating the insights that can be drawn by considering the Marxist alternative to the dominant mainstream and heterodox approaches.

The main message of the book is that a gradual recovery is possible only if there is a change of course in individual countries that then triggers reactions in the policies of other countries and perturbations at the EU level. Combining an analytical narrative with a selection of primary texts and visual images, this book provides undergraduate students with a brief, readable history, including an overview of how socialist political movements have evolved over time and stressing the rich diversity that has characterized socialism’s foundations from its beginning. This new edition brings this text up to date and examines the European socialist movement in the face of 21st century challenges. Crisis, Austerity and Transnational Party Cooperation in Southern Europe

The most internationalist of all party families, the radical left has paradoxically always lagged behind in its cooperation at the EU level. The previous decade, however, the transnational character of the Eurozone crisis and its austerity-centred management provided a strong incentive to remedy that. By focusing on the relations between three prominent members of this party family at the time (SYRIZA, Podemos, Left Bloc), this book shows how and why the transnational cooperation on the radical left largely failed to deliver in a propitious context. With implications for the study of other party families, the book lays out the key factors that prevented the European radical left from coming together to provide an alternative to the neoliberal status quo in the EU.

Paradoxes of Emancipation

In *Paradoxes of Emancipation*, Dimitris Soudias traces the formation of political subjectivity in times of crisis by attending to the 2011 occupation of Syntagma Square in Athens—the heart of the Greek anti-austerity movement following the debt crisis. Soudias conceives of the Syntagma Square occupation as a lens through which we can critically engage with broader theoretical and political issues: the crumbling promises of the capitalist imaginary, the epistemic “spirit” of neoliberal rationalities, the spatialized practices of navigating precarity and uncertainty, and the prospects for a radically better tomorrow. By challenging both the romanticization of anti-austerity activism and the reduction of neoliberalism to mere free market thinking, Soudias reveals that the relationship between political subject formation and emancipation in neoliberalism is utterly paradoxical. In their effort to overcome

neoliberal rationalities, individuals also partly stabilize them. Interweaving the stories and insights of activists with sociology, geography, and political theory, this book makes bold claims about the future of emancipation by envisioning an “alter-neoliberal critique.” In so doing, *Paradoxes of Emancipation* presents an illuminating inquiry into how our experiences with capitalist crises lead to profound reevaluations of ourselves that challenge our expectations of the future.

Transforming Classes

The Political Economies of Turkey and Greece

The economic policies of reactive states such as Turkey and Greece, both of which have shown limited ability to implement institutional reforms in recent years, have paved the way for deep crises. The crises are devastating for both societies' social fabric, but they also open up the opportunity to introduce new economic regimes. They do, however, not always invite changes in dominant paradigms. Despite weak state capacity and deep economic crisis in both cases, substantial reforms were initiated in Turkey whilst an opposite trend prevailed in Greece. Drawing on field research, this book develops a political economy framework that explains reform cycles and post-crisis outcomes in reactive states.

Structural Crisis and Institutional Change in Modern Capitalism

This book analyses the evolution of the French model of capitalism in relation to the instability of socio-political compromises. In the 2010s, France was in a situation of systemic crisis, namely, the impossibility for political leadership to find a strategy of institutional change, or more generally a model of capitalism, that could gather sufficient social and political support. This book analyses the various attempts at reforming the French model since the 1980s, when the left tried briefly to orient the French political economy in a social-democratic/socialist direction before changing course and opting for a more orthodox macroeconomic and structural policy direction. The attempts of governments of the right to implement a radically neo-liberal structural policy also failed in the face of a significant social opposition. The enduring French systemic crisis is the expression of contradictions between the economic policies implemented by the successive left and right governments, and the existence of a dominant, social bloc, that is, a coalition of social groups that would politically support the dominant political strategy. Since 1978, both the right and the left have failed to find a solution to the contradictions between the policies they implemented and the expectations of their respective social bases, which are themselves inhabited by tensions and contradictions that evolve with the structural reforms that gradually transformed French capitalism.

World in Crisis

Most mainstream economists view capitalism's periodic breakdowns are nothing more than temporary aberrations from another wise unbroken path toward prosperity. For Marxists, this fundamental flaw has long been acknowledged as a central feature of the free market system. This groundbreaking volume brings together Marxist scholars from around the world to offer an empirically grounded defense of Marx's law of profitability and its central role in explaining these capitalist crises. Guglielmo Carchedi has worked at the United Nations in New York and has taught at the University of Amsterdam. Understanding Angry Groups

This book examines the dynamics that lead to anger in individuals, within groups, and between groups; identifies the role of the media in angry group behavior; and offers solutions for dealing with angry groups and channeling that negative energy in positive ways. In today's society, we see angry groups in many forms—from animal rights and climate crisis activists to citizens opposed to allowing more immigrants of certain ethnicities or religions into the country, militia groups frustrated by acts of domestic terrorism and legislation that limits gun ownership and the ability to carry weapons in public, and those outraged by what they see as police brutality or the unnecessary use of deadly force against people of color. More than just evidence of civil unrest in society, angry groups across history and nations often ultimately affect our politics and our government, for better or worse, and sometimes result in injury, bloodshed, or financial costs that hit otherwise-uninvolved taxpayers. This book demonstrates how people across our nation are involved in, affected by, or harmed by angry groups; covers historical and modern perspectives on angry groups; and offers suggestions for predicting and influencing the expression of angry group behavior. It provides readers with an understanding of such conflicts and of their origins and dynamics that may offer insights to successful resolution, and it identifies strategies that can reduce the suffering that comes from such conflicts.

Capitalism's Crises

The contributors to this volume draw on a non-dogmatic Marxist approach to explain the systemic and conjunctural dynamics of crisis inherent in global capitalism. Their analysis asks what is historically specific to capitalism's crises while avoiding catastrophic or defeatist claims. At the same time the volume situates left agency within actual patterns of resistance and class struggle to clarify the potential for transformative change. The cycle of resistance strengthened by the World Social Forum and transnational activism is now punctuated by the experience of the Arab Spring, the agency of anti-systemic movements, left think tanks, the Occupy Wall Street Movement, labour unions, left parties in Europe such as Syriza and Podemos and peoples' budgeting in Kerala, India. On the down side, we are witnessing the waning of the Workers Party in Brazil and serious challenges for South Africa's once powerful labour movement and still formative social justice activism. All these developments are assessed in this volume. This is the second volume in the Democratic Marxism series. It elaborates on crucial themes introduced in the first volume, *Marxism in the 21st Century: Crisis, Critique and Struggle* (edited by Michelle Williams and Vishwas Satgar).

The Radical Left in Europe in the Age of Austerity

The complex trajectory of Europe after the 2008 global financial crisis, has led to the catastrophic failure of deep austerity measures that swept across the Union, and is reflected in the rise of some radical left parties such as SYRIZA as well as an unfortunate rise in far right and nationalist parties and movements. This collection brings together a group of European scholars and activists from various European countries to discuss the recent economic, political, and electoral changes in respective countries, and the current status and future plans of radical left parties and movements. This book fills a significant gap within the current literature in the English-speaking world on post-2008 Europe, featuring a nation-based European wide survey of the current activities and plans of radical Left parties and movements in relation to the mounting social, political, and economic problems in Europe. This book contributes to the discussion by presenting a realistic depiction of the existing radical Left forces in Europe. This title was previously published as a special issue of *Socialism and Democracy*.

Asymmetric Crisis in Europe and Possible Futures

The crisis in Europe is often discussed as a crisis of European integration or a crisis of national economies within Europe. Both the 'methodological Europeanism' and 'methodological nationalism' miss out the important links between economic and political processes at different spatial scales

within Europe, and therefore, asymmetries and phenomena of uneven development. In addition, a discussion of possible scenarios which systematically addresses the implications of anti-crisis policies is missing. This volume seeks to close this gap by systematically integrating the analysis of economic policy or 'technical' solutions to the crisis within a broader framework of political economy. It argues that combining critical political economy approaches and post-Keynesian perspectives allows for a systematic understanding of the economic and political dimensions of the crisis. Although both approaches have the capacity to deal with asymmetries and uneven development, the heterogeneity in Europe has been an often largely neglected dimension of analysis. However, this recent crisis has shown that this is an essential dimension which has to be addressed in order to better understand the dynamics of European development and integration. Hence, this book aims to deal with asymmetries in Europe and to bridge the gap between the two perspectives. This work will initiate an integrative debate that is crucial for a deeper understanding of the current crisis and is an important resource for all students and scholars of IPE, European political economy and European politics.

The Social Ontology of Capitalism

This book addresses core questions about the nature and structure of contemporary capitalism and the social dynamics and countervailing forces that shape modern life. From a robust and self-consciously sociological framework, it analyzes and interrogates such issues as the nature of the social, the power of the sacred, the nature of authority, the problem of representation, reification, alienation, utopia, and collective resistance. Historical materialism reveals that the scope of productive functions is broader than the crude realism of economism. Marx's critical theory of the commodity and his analysis of the capitalist regime of accumulation remain as vital as ever and serve as a guiding light for the continued exploration of the philosophical underpinnings of critical inquiry and praxis.

Neoliberal Legality

Neoliberalism has been studied as a political ideology, an historical moment, an economic programme, an institutional model, and a totalising political project. Yet the role of law in the neoliberal story has been relatively neglected, and the idea of neoliberalism as a juridical project has yet to be considered. That is: neoliberal law and its interrelations with neoliberal politics and economics has remained almost entirely neglected as a subject of research and debate. This book provides a systematic attempt to develop a holistic and coherent understanding of the relationship between law and neoliberalism. It does not, however, examine law and neoliberalism as fixed entities or as philosophical categories. And neither is its objective to uncover or devise a 'law of neoliberalism'. Instead, it uses empirical evidence to explore and theorise the relationship between law and neoliberalism as dynamic and complex social phenomena. Developing a nuanced concept of 'neoliberal legality', neoliberalism, it is argued here, is as much a juridical project as a political and economic one. And it is only in understanding the juridical thrust of neoliberalism that we can hope to fully comprehend the specificities, and continuities, of the neoliberal period as a whole.

Social Policy and the Eurocrisis

In this study, an international and multidisciplinary team take stock of the promise and shortfalls of 'Social Europe' today, examining the response to the Eurocrisis, the past decade of social policy in the image of the Lisbon Agenda, and the politics that derailed a more Delorsian Europe from ever emerging.

Radical Left Parties in Government

This book provides a comparative analysis of how two radical left parties achieved government participation and their subsequent political experiences. In the face of the most severe and most prolonged crisis in the history of capitalism, it would be expected for radical left parties to seize the opportunity to promote their political agenda. Although reality has often confounded prognosis, two particular radical left parties – the Greek SYRIZA and the Cypriot AKEL – were elected to the highest government office. The author uses these two examples to engage with the broader question of what to expect when left-wing radicals achieve governance. This question is now of particular importance given the emergence of radical leftists in other parts of Europe, including Corbyn in the UK and Podemos in Spain.

Crisis, Movement, Strategy: The Greek Experience

Since 2010 Greece entered a period of austerity, protest and political crisis. The contributions in this volume deal with questions regarding capitalist crisis, debt, European integration, political crisis, new forms of protest, the rise of neo-fascist parties and left-wing strategy today.

Food Insecurity

This book explores the experiences, causes, and consequences of food insecurity in different geographical regions and historical eras. It highlights collective and political actions aimed at food sovereignty as solutions to mitigate suffering. Despite global efforts to end hunger, it persists and has even increased in some regions. This book provides interdisciplinary and historical perspectives on the manifestations of food insecurity, with case studies illustrating how people coped with violations of their rights during the war-time deprivation in France; the neoliberal incursions on food supply in Turkey, Greece, and Nicaragua; as well as the consequences of radioactive contamination of farmland in Japan. This edited collection adopts an analytical approach to understanding food insecurity by examining how the historical and political situations in different countries have resulted in an unfolding dialectic of food insecurity and resistance, with the most marginalized people—immigrants, those in refugee camps, poor peasants, and so forth—consistently suffering the worst effects, yet still maintaining agency to fight back. The book tackles food insecurity on a local as well as a global scale and will thus be useful for a broad range of audiences, including students, scholars, and the general public interested in studying food crises, globalization, and current global issues.

The Populist Radical Left in Europe

Building on a comprehensive theoretical framework that draws on discursive and ideational approaches to populism, this volume offers a comparative mapping of the Populist Radical Left in contemporary Europe. It explores the novel discursive, political and organisational features of several political actors, as well as the conditions of their emergence and success, while being alert to the role of relevant social movements. Chapters feature case studies of the Greek party Syriza, the Spanish Podemos, the German Die Linke, Jean-Luc Mélenchon and France Insoumise, the Dutch Socialist Party and the Slovenian Levica. Jeremy Corbyn's leadership of Labour in the UK and 'Momentum', the movement that supports him is also examined. A separate chapter is devoted to recent grassroots social movements that can be seen as instances of progressive populism, such as the 'squares movement' in Spain and Greece. This book fills a crucial gap in the literature on radical left politics and populism in Europe, contributing to the rapidly burgeoning field of populism studies.

Defiance

This socialist history of modern Greece tells the story of its rebirth in struggle, the heroic resistance to Nazi occupation, the civil war and its aftermath, the colonels' dictatorship and its overthrow, the rise and fall of PASOK, the debt crisis, the popular uprising of 2010-12, the election of SYRIZA, the referendum and the subsequent capitulation. What lessons can Greece's experience teach those campaigning against austerity throughout Europe? This book includes an Appendix by Eric Toussaint.

Crisis-scapes

Four years and four days. The exact amount of time, that is, that has lapsed since the day the greek state would sign its 'memorandum of agreement' with its lenders (the IMF, the EU and the ECB), on May 5, 2010—officially making its own way into the era of global austerity and crisis. An entering that would come with a bang, and very much stay so: from that moment on, the social tension playing out at the greek territory would feature—constantly, it seems—in discussions, analyses and reports the world over. But what is life like in a city that finds itself in the eye of the crisisstorm, how does the everyday reality here compare to Athens' global media portrait? What kind of lessons might our city be able to learn from the outbreaks of capitalism's crises elsewhere, and what lessons might the Athenian example be able to offer, in return? The volume that you hold in your hands acts as an accompaniment to a conference that tried to answer some of these questions. 'Crisis-scapes: Athens and beyond' took place in the city of Athens on May 9&10, 2014. Over the two days, the conference tried to explore an array of the facets of the crisis in the city, divided between five axes/panels, which are in turn mirrored in the structure of this book: 1. Flows, infrastructures and networks, 2. Mapping spaces of racist violence, 3. Between invisibility and precarity, 4. The right to the city in crisis and 5. Devaluing labour, depreciating land. Five broad axes comprising the vehicles we used to perambulate through the dark landscapes

of the crisis. A crisis neither commencing nor ending here, today. Through these conceptual vehicles taking us through Athens, through her spaces and her times, we focused on the particularities of the greek crisis; a crisis first of all concerning the structures, meanings and processes weaving together what we could broadly label as the greek everyday reality. Yet we also believe these particularities ought to be understood within the global financial crisis framework: hence this centrifugal “beyond”. Athens may now be in a position to offer explanations about phenomena taking place much beyond the city’s strict geographical limits. What renders the city a field of experimentation are trials and productions of new means of governance. And they acquire a new meaning when seen as wider tendencies in crisis management. Yet these Athenian testing grounds must at the same time be studied as traces and as future projections of structural readjustments taking place in seemingly disparate locations, but often-times ever so close in their causes and consequences alike. The interventions put together in the present volume try to take another composite look at Athens and its crisis. They try to comprehend the city through crossings and transitions in space and in time.

Governments around the World

Additionally, the content includes constitutional excerpts that clarify how human rights are conceptualized and articulated throughout the world.

Austerity, Welfare and Work

David Etherington provides bold and fresh perspectives on the link between welfare policy and employment relations as he assesses their fundamental impact on social inequalities. Exploring how reforms, including Universal Credit, have reinforced employment and social insecurity, he assesses the role of NGOs, trade unions and policymakers in challenging this increasingly work-focused welfare agenda. Drawing on international and national case studies, the book reviews developments, including rising job insecurity, low pay and geographical inequalities, considered integral to neoliberal approaches to social spending. Etherington sets out the possibilities and challenges of alternative approaches and progressive new paths for welfare, the labour market and social rights.

Why Not Default?

Jerome Roos provides a sweeping investigation of the political economy of sovereign debt and international crisis management.
