The Lancelot-Grail Reader

This work provides a single-volume condensation of the complete five-volume translation of the Vulgate and post-Vulgate Cycles of Arthurian romance. Like the original, this present volume is the work of a team of translators directed by Norris J. Lacy. It has been edited for students and Arthurian enthusiasts in general. Dating from early 13th century, the Vulgate Cycle, relates the entire course of Arthurian legend, from the early history of the Grail to Arthur's death. The five component romances written by an anonymous author or group of authors, are the Estoire del Saint Graal, the Estoire de Merlin, the huge Lancelot propre, the Queste del Saint Graal, and the tragic conclusion, the Mort Artu. The post-Vulgate Cycle, also anonymous, is a rehandling of the Vulgate material dating to 1230-40. The author attempted to impose a more homogeneous unity on the narrative by setting Arthur and the Grail at center stage, rather than the illicit love of Lancelot and Guenevere. This work has existed only in fragmentary form (in French, Spanish, and Portuguese) and has been largely reconstructed by scholars.

For more than a thousand years, the adventures of King Arthur and his Knights of the Round Table have been retold across Europe. They have inspired some of the most important works of European literature, particularly in the medieval period: the romances of Chrétien de Troyes, Wolfram von Eschenbach's Parzival, Sir Gawain and the Green Knight and Malory's Le Morte d'Arthur. Lancelot-Grail: The death of Arthur

La Queste del Saint Graal is one of the best-known and most important of the medieval Grail Romances, being the first text to portray the character of Galahad the «perfect» knight, and the earliest extant version of the tale to attempt to fuse the dual tradition associated with the Grail: pseudo-Celtic and Christian. However, it is often considered a difficult text, containing passages of dense metaphor and a seemingly disjointed plot. This study explains the link between metaphor and structure within the text, by means of detailed analysis of certain key sections of the narrative, showing how the author has carefully constructed a hierarchy of characters. What also emerges is that the author places the reader in a position analogous to that of the questing knights, struggling to understand the adventures with which they are presented, and able to do so insofar as they have grasped the symbolic significance of earlier events in the story. The literary technique of structuring a text by means of metaphor is employed not only in La Queste del Saint Graal, but is characteristic of much medieval narrative: thus this analysis has implications for the interpretation of other examples of the genre.

The Legend of Sir Lancelot du Lac

Sir Galahad is a knight of King Arthur's Round Table and one of the three achievers of the Holy Grail. At the Round Table, he was assigned the perilous seat or the "Siege Perilous." He is the illegitimate son of Sir Lancelot and Elaine of Corbenic, and is renowned for his gallantry and purity. Emerging guite late in the medieval Arthurian tradition, Sir Galahad first appears in the Lancelot-Grail cycle, and his story is taken up in later works such as the Post-Vulgate Cycle and Sir Thomas Malory's Le Morte d'Arthur. The Holy Grail was a vessel used by Christ at the Last Supper. Given to his grand-uncle, Joseph of Arimathea, it was used by him to collect Christ's blood and sweat while Joseph tended him on the Cross. Later, Joseph travelled to Britain with his family and several followers. He settled at Ynys Witrin (Glastonbury), but the Grail was taken to Corbenic where it was housed in a spectacular castle, guarded always by the Grail Kings, descendants of Joseph's daughter, Anna (Enygeus) and her husband, Brons. Centuries later, the location of the Great Castle of Corbenic became forgotten. At the Court of King Arthur, however, it was prophesied that the Grail would one day be rediscovered by a descendant of Joseph: the best knight in the land, the only man capable of sitting in the mysterious Siege Perilous. When such a man arrived in the form of Galahad, the son of Lancelot, along with a miraculous, though brief, vision of the Grail itself, a quest to find this holiest of relics began. King Arthur is a legendary British King who, according to medieval histories and romances, led the defense of Britain against Saxon invaders in the late 5th and early 6th centuries AD. The details of Arthur's story are mainly composed of folklore and literary invention and his historical existence is debated and disputed by modern historians. Le Morte D'Arthur was one of the earliest printed books in England. It was written in French about 1450AD and was translated and published in England by William Caxton in 1485. Most of the later works are derivative of Malory's as is this series of books. Claxton's own story of how the book was brought to him and why he printed it may be read in his own preface. From this we learn also that he was not only the printer of the book, but to some extent its editor also, dividing Malory's work into twenty-one books, splitting up the books into chapters. If the reader wants to read all the books in Volume One and/or Volume Two they may be purchased at a significantly reduced price as listed under the title "Times and Death of King Arthur." The original text from the introduction to chapters in Malory's books is added below chapter titles in this book to help give a flavor to how things were written in the fifteenth century. This book is an edition based on Caxton's Book VII, Volume One which was translated into English from French in the late 1400s. The book has been upgraded with modern words and spelling which make it easier to read.

Negotiating these influences, Malory transforms constructions of masculine heroism, especially in the presentation of Launcelot, and exposes the tensions and disillusions of the Arthurian project. The Morte poignantly conveys a desire for integrity in narrative and subject-matter, but at the same time tests literary conceptualizations of history, nationalism, gender and selfhood, and considers the failures of social and legal institutionalizations of violence, in a critique of literary form and of social order.
