Compassion Fatigue is the physical and mental exhaustion resulting in a depleted ability to cope. During these times, it can be hard to refuel and regenerate.

Compassion fatigue can lead to anxiety and depression, it can compromise the Quality of care, and affect relationships with family members and even colleagues

Secondary trauma, also known as vicarious trauma, is the "contagious" trauma that occurs when helpers are repeatedly exposed to other's traumatic experiences.

Create a protection plan for yourself: pay attention to your feelings - make it a point to stop and check in with yourself during the day to see how you are feeling

practice self-care by doing those things that recharge your battery

maintain strong social supports at home and at work

and have a transition from work to home - as this can help us let go of the trials of the day Remember to practice being kind to yourself. Respond to your stress with care and support.
