Le guide de l'astrologie

Le « fait astrologique » est une donnée présente aussi bien dans la civilisation de l'Occident médiéval que dans notre société européenne du 21^e siècle. L'Astrologie

L'astrologie est un ensemble de croyances et de pratiques non scientifiques basées sur l'interprétation symbolique des correspondances supposées - "ce qui est en haut est comme ce qui est en bas" dit la Table d'émeraude - entre les configurations célestes (la position et le mouvement des planètes dans le système solaire ou des constellations dans le cosmos) et les affaires humaines, collectives ou individuelles. Ce parallélisme conjecturé fait que l'astrologie, outre l'analyse de l'existant, est parfois utilisée comme outil divinatoire. Le présent article est consacré à l'astrologie occidentale, à laquelle renvoie généralement le terme astrologie. Il s'agit de celle qui est partie de Sumer, a influencé l'Égypte, a dominé Babylone, et s'est démocratisée en Grèce, d'où elle nous est parvenue grâce à la médiation des Arabes. Si, selon Wilhelm Knappich, la forme la plus ancienne sous laquelle a été pratiquée l'astrologie est l'astrologie mondiale, les horoscopes des revues ou les affinités des signes du zodiaque sont ses versions populaires actuelles à l'heure de l'individualisme moderne. Si ces dernières sont généralement considérées comme des échos lointains et déformés de l'astrologie historique, elles en restent la manifestation et l'expression la plus répandue. Les scientifiques considèrent l'astrologie comme une pseudo-science ou une superstition, l'ensemble des recherches menées depuis l'Antiquité ayant abouti au fait que l'astrologie se place, par sa méthode-même, en dehors du domaine scientifique. Face à ces considérations, les défenseurs de l'astrologie tendent presque tous à en réduire le caractère déterministe, élément nécessaire pour utiliser le mot de « science rationnelle ». Luc Bigé, Docteur ès science en biologie et chercheur en astrologie, affirme que l'astrologie n'est pas une « science rationnelle ». Selon d'autres astrologues, leur discipline n'a même pas pour but premier la prédiction de l'avenir, l'astrologie pouvant notamment être une voie du développement personnel. Les croyances associées à l'astrologie restent populaires. Un sondage mené en France indique qu'entre 30 et 40 pour cent des concitoyens accorderaient du crédit à l'astrologie.

Vietnam at the Vanguard

Enseignée dans les universités, elle a une fonction très éloignée de celle qui lui est assignée en Occident, où elle est regardée comme une croyance marginale et "superstitieuse". Entre science et religion, elle répond aux transformations de la société contemporaine. Nourri d'enquêtes de terrain, l'ouvrage de Caterina Guenzi éclaire avec subtilité les processus d'adaptation, d'interprétation et de réécriture dont cette discipline brahmanique fait l'objet dans l'Inde urbaine du XXI^e siècle.

L'abbé Lecanu y analyse la position de l'Église de son époque face l'ésotérisme et l'occultisme ainsi que sur des sujets tels que la Magie, Possession, Illuminisme, Magnétisme, Spirites, Exorcismes, Enchantements, Sortilèges, Gnosticisme, Envoûtements, Franc-Maçonnerie et Rosicrucisme.

The Emergence of EU Defense Research Policy

For almost fifteen years, both the EU and North Atlantic Treaty Organization (NATO) have claimed to partake in a relationship that is purported to be a 'Strategic Partnership', albeit one that is troubled by lasting political blockages. The constraints that affect the formal relationship between the two organizations are well-covered terrain in the academic literature – including by most of the contributors to this volume; however, the popular argument that the EU and NATO simply do not cooperate in any substantive way warrants deeper investigation, both theoretically and thematically. Author's note: If I had known just how difficult an ancestor Erkenbald the Fleming would be, I would possibly have stuffed him back into the academic journal in which I first found him, namely: History, volume 28, issue 108, September 1943, pp. 129-147, Companions of the Conqueror by David C. I was told that it is common knowledge that the Flemings of the British Isles descend from any number of unrelated immigrants from Flanders who took the surname Fleming. Apparently, there cannot possibly have been any "first Fleming." With the publication of this present volume, I hope to give Erkenbald some of the notoriety that I believe he deserves by having made him an interesting character in a story. Later, perhaps, we can re-examine the historical evidence without burdensome preconceptions.

Following in the 'state-centered' tradition of Theda Skocpol's *States and Social Revolutions* and Jack Goldstone's *Revolutions and Rebellion in the Early Modern World*, Goodwin demonstrates how the actions of specific types of authoritarian regimes unwittingly channeled popular resistance into radical and often violent directions. Revolution became the 'only way out', to use Trotsky's formulation, for the opponents of these intransigent regimes. By comparing the historical trajectories of more than a dozen countries, Goodwin also shows how revolutionaries were sometimes able to create, and not simply exploit, opportunities for seizing state power.

Stories from the Other Side

Drama documentary is a program category unique to television. Combining the factual approach of documentary with the entertainment values of drama, dramadoc/docudrama has featured in television schedules for over forty years, and has often been the focus of controversy. Questions are frequently asked about how the viewer is to judge between fact and fiction, and whether such programs invade individuals' privacy. *No Other Way to Tell It* is an introductory book which defines the form, and reviews its history and development on British and American television. The people who make the programs--television producers, writers, actors and lawyers--give their views, and recent co-production work between Granada TV in Britain and Home Box Office in America is examined. *Hostages*, a co-production which was bitterly opposed by the British and American hostages released from captivity in Beirut at the beginning of the decade, is used to illustrate the changes that are now taking place within the medium.

No Other Way Out

Often overlooked in accounts of World War II is the Soviet Union's quiet yet brutal campaign against Polish citizens, a campaign that included, we now know, war crimes for which the Soviet and Russian governments only recently admitted culpability. Standing in the shadow of the Holocaust, this episode of European history is often overlooked. Wesley Adamczyk's gripping memoir, *When God Looked the Other Way*, now gives voice to the hundreds of thousands of victims of Soviet barbarism. Adamczyk was a young Polish boy when he was deported with his mother and siblings from their comfortable home in Luck to Soviet Siberia in May of 1940. His father, a Polish Army officer, was taken prisoner by the Red Army and eventually became one of the victims of the Katyn massacre, in which tens of thousands of Polish officers were slain at the hands of the Soviet secret police. The family's separation and deportation in 1940 marked the beginning of a ten-year odyssey in which the family endured

fierce living conditions, meager food rations, chronic displacement, and rampant disease, first in the Soviet Union and then in Iran, where Adamczyk's mother succumbed to exhaustion after mounting a harrowing escape from the Soviets. Wandering from country to country and living in refugee camps and the homes of strangers, Adamczyk struggled to survive and maintain his dignity amid the horrors of war. When God Looked the Other Way is a memoir of a boyhood lived in unspeakable circumstances, a book that not only illuminates one of the darkest periods of European history but also traces the loss of innocence and the fight against despair that took root in one young boy. It is also a book that offers a stark picture of the unforgiving nature of Communism and its champions. Unflinching and poignant, When God Looked the Other Way will stand as a testament to the trials of a family during wartime and an intimate chronicle of episodes yet to receive their historical due.
