COMMON GOOD Hand in hand with the authority to make decisions Is the obligation a leader has to use their authority for the common good.

POWER Because the leader usually has more power and control than followers have, leaders have to be particularly sensitive to how their leadership affects the well-being of others.

COMMON GOOD Put another way, ethical leadership is a process by which a good person rightly influences others to accomplish a common good: to make the world better, fairer, and more humane. VALUES Ethics is concerned with the kind of values and morals an individual or society finds desirable or appropriate.

SIX DIMENSIONS A model for many of these programs was developed by the Josephson Institute in California, which frames instruction around six dimensions of character: trustworthiness, respect, responsibility, fairness, caring, and citizenship

CORE VALUES Based on these and similar character dimensions, schools are emphasizing the importance of character and how core values influence an individual's ethical decision making. DEVELOPMENT Although character is clearly at the core of who you are as a person, It is also something you can learn to strengthen and develop. When practiced over time, good values become habitual.

GOALS Actions refer to the ways a leader goes about accomplishing goals. Ethical leaders use moral means to achieve their goals.

ACTIONS The actions a leader takes to accomplish a goal need to be ethical. They cannot be justified by the necessity or importance of the leader's goals. Ethical leadership involves using morally appropriate actions to achieve goals.

SERVING OTHERS Serving others is an example of altruism, an approach that suggests that actions are ethical if their primary purpose is to promote the best interest of others.

SHOWING JUSTICE Justice demands that a leader place the issue of fairness at the center of decision making. As a rule, no one should receive special treatment or special consideration except when a particular situation demands it.

GOLDEN RULE In addition, justice is concerned with the Golden Rule: Treat others as you would like to be treated. If you expect fair treatment from others, then you should treat others fairly.

RESOURCES Because of the real or perceived scarcity of resources, conflicts often occur between individuals about fair methods of distribution. It is important for a leader to establish clearly the rules for distributing rewards.

GOALS Leaders play a significant in determining whether leadership is ethical. The goals a leader selects are a reflection of the leader's ethics.

VALUE Identifying and pursuing just and worthy goals are the most important steps an ethical leader will undertake. In choosing goals, an ethical leader must assess the relative value and worth of their goals.

COMMUNITY In the process, it is important for the leader to take into account the interests of others in the group or organization and, in some cases, the interests of the community and larger culture in which they work.

The challenge for a leader is to strike a balance between being open and candid and at the same time monitoring what is appropriate to disclose.

EFFECT CHANGE When they use their potential, they are using their power as a resource to effect change in others.

BASES OF POWER The most widely cited research on power is French and Raven's work on the bases of social power. They identified five common and important bases of power: referent power, expert power, legitimate power, reward power, and coercive power.

USING POWER Since power can be used in positive ways to benefit others or in destructive ways to hurt others, a leader needs to be aware of how they use power. Power is not inherently bad, but it can be used in negative ways.

PERSONAL ENDS There is a dark side of leadership where a leader uses their influence or power for personal ends. Unfortunately, there are many examples in the world of such leaders.

VALUES Values are the ideas, beliefs, and modes of action that people find worthwhile or desirable. Some examples of values are peace, justice, integrity, fairness, and community. A leader's ethical values are demonstrated in everyday leadership.

END VALUES End values describe the outcomes or goals a leader seeks to achieve. End values are present when a person addresses broad issues such as liberty and justice.

#### The Third World and International Order

This collection of essays explores different dimensions of the relationship between the third world and international law. The topics covered include third world approaches to international law, non-state actors and developing countries, feminism and the third world, foreign investment, resistance and international law, and territorial disputes and native peoples. It is a further contribution to the work done by scholars intent on elaborating what might be termed Third World Approaches to International Law (TWAIL). This initiative seeks to continue and further develop the important work that has been done over many decades, particularly by scholars and jurists from the third world, to construct an international law which is sensitive to the needs of third world peoples. This body of scholarship has attempted to extend and expand the concerns and materials of international law. The essays in this volume are animated by these same motives at a time when unprecedented issues confront third world peoples, particularly since the contemporary international system appears to be disempowering third world peoples, intensifying inequality between the North and the South, and indeed, importantly, within the North and the South. TWAIL scholars attempt to look afresh at the history of colonial international law, engage previous trends in third world scholarship in international law, take cognizance of the dramatic changes which have characterized the body of international law in the last few decades from the perspective of third world peoples, record their resistance to unjust and oppressive international laws, and advance new approaches that address their needs and concerns. These are the broad themes and concerns which animate this collection of essays.

#### International Law from Below

The emergence of transnational social movements as major actors in international politics - as witnessed in Seattle in 1999 and elsewhere - has sent shockwaves through the international system. Many questions have arisen about the legitimacy, coherence and efficiency of the international order in the light of the challenges posed by social movements. It examines in detail the growth of two key components of modern international law - international institutions and

human rights - in the context of changing historical patterns of Third World resistance. # Bandung, Global History, and International Law

In early modern Europe, international law emerged as a means of governing relations between rapidly consolidating sovereign states, purporting to establish a normative order for the perilous international world. However, it was intrinsically fragile and uncertain, for sovereign states had no acknowledged common authority that would create, change, apply, and enforce legal norms. In Imagining World Order, Chenxi Tang shows that international world order was as much a literary as a legal matter. To begin with, the poetic imagination contributed to the making of international law. As the discourse of international law coalesced, literary works from romances and tragedies to novels responded to its unfulfilled ambitions and inexorable failures, occasionally affirming it, often contesting it, always uncovering its problems and rehearsing imaginary solutions. Tang highlights the various modes in which literary texts—some highly canonical (Camões, Shakespeare, Corneille, Lohenstein, and Defoe, among many others), some largely forgotten yet worth rediscovering—engaged with legal thinking in the period from the sixteenth to the eighteenth century. In tracing such engagements, he offers a dual history of international law and European literature. As legal history, the book approaches the development of international law in this period—its so-called classical age—in terms of literary imagination. As literary history, Tang recounts how literature confronted the guestion of international world order and how, in the process, a set of literary forms common to major European languages (epic, tragedy, romance, novel) evolved.

## Humanizing Our Global Order

The law governing the international claims of dual nationals relates to, and is influenced by, the wider subject of the individual's standing at the international level. But while the latter had, as a result of modern trends in human rights, hugely improved as from the middle of the last century, no occasion to test its impact on such claims had arisen prior to the 1980s, when the Iran-United States Claims Tribunal - justifiably described as the most influential arbitral institution in the history of international adjudication - first became involved with the issue. The significance of the Tribunal's jurisprudence on the subject is not, however, limited to the judicial support it gives to the international rights of the individual. Having made its basic findings of law on the subject, the Tribunal has proceeded to apply them, for some twenty years, to a host of Cases of widely different characters. The result is a wealth of material - comprehensively reviewed in this book for the first time - which is likely to be of some benefit to those interested in this area of international law.

#### International Law and World Order

The concept of the common heritage of mankind is one of the most extraordinary developments in recent intellectual history and one of the most revolutionary and radical legal concepts to have emerged in recent decades. The year 1997 marks the thirtieth anniversary of the advent of the concept in the domain of public international law. Ever since its emergence, it has become evident that no other

concept, notion, principle or doctrine has brought as much intensive debate, controversy, confrontation and speculation as the common heritage phenomenon did. This is because it is a philosophical idea that questions the regimes of globally important resources regardless of their situation, and requires major changes in the world to apply its provisions. ## **Customary International Law and Treaties**

Determining whether the Iran-US Claims Tribunal (the Tribunal) is a truly public international tribunal is not merely an interesting theoretical exercise. The Tribunal's legal character has significant ramifications, for example on enforceability at the international level, the applicability and scope of "res judicata" regarding dismissed claims, and the evidentiary value of its jurisprudence, particularly pursuant to Article 38(1) of the ICJ statute. This title explores the legal character of the Tribunal and its status under the law of peaceful settlement of international disputes. The public or private nature of the Tribunal is a matter of significant controversy.
