# With Healing Hands

Early in the Vietnam War the South Vietnamese government appealed to the United States and its allies, including Australia, for desperately needed medical help. Most of the country's doctors had been conscripted into the army and the civilian population was facing a medical crisis. From October 1964 until the end of 1972 over 450 surgeons, nurses, and other medical specialists from Australian hospitals volunteered to work in South Vietnam. In the towns of Long Xuyen, Bien Hoa, Vung Tau, and Ba Ria they brought expert medical care, comfort and support to a war-weary and traumatized civilia.

#### War Wounds

The history of warfare and the history of medicine are closely intertwined. War has been an accelerator of advances in medical treatment and surgery. As modern weaponry became more destructive, medicine developed techniques and procedures to deal with the volume and nature of battlefield casualties. Preventative medicine has also increased the effectiveness of fighting forces through improvements in soldiers' health and disease resistance. This book is a collection of chapters by historians, medical practitioners and researchers, former and serving military medical officers, surgeons, nurses and veterans, who explore the impact of war, wounds and trauma through the historical record, reported narratives and personal experiences. The book includes major sections on World War One (including chapters on shell shock and plastic surgery), World War Two (including a chapter on the Nazi death camps), the Vietnam War (including chapters on Agent Orange and sexually transmitted diseases), together with chapters on the Korean War and the current conflict in Afghanistan. In addition, the book includes several personal stories in which veterans describe their experiences of injury and recovery. War Wounds is a truly unique book, which offers considerable insights into an aspect of war that is often mentioned but seldom examined as it is here. Medical professionals, military personnel and the general public will all find it a remarkably revealing read.

#### **Unending War**

Malaria is not only the greatest killer of humankind, the disease has been the relentless scourge of armies throughout history. Malaria thwarted the efforts of Alexander the Great to conquer India in the fourth century BC. Malaria frustrated the ambitions of Attila the Hun and Genghis Khan to rule all Europe in the fourth and thirteenth centuries AD; and malaria stymied Napoleon Bonaparte's plan to conquer Syria at the end of the eighteenth century. The second time was in Papua New Guinea in 1942–43, when the Army was fighting malaria as well as the Japanese. The third time was in Vietnam in 1968, when malaria caused more casualties than did enemy action. Indeed the Australian Army has been fighting 'an unending war' against malaria ever since the Boer War at the end of the nineteenth century. The struggle against the disease continues 115 years later because virtually

all Army's overseas deployments are to malarious regions. Fortunately for Australian troops serving in nations where malaria is endemic, the Australian Army Malaria Institute undertakes the scientific research necessary to protect our service personnel against the disease. Ian Howie-Willis, in this very readable book, tells the dramatic story of the Army's long and continuing struggle against malaria. It breaks new ground by showing how just one disease, malaria, is as much the serving soldier's foe as any enemy force.

This report offers conclusions based on available evidence regarding associations of persistent or latent adverse events.

Qualifying as an Army research psychologist requires, first of all, a Ph.D. from a research (not clinical) intensive graduate psychology program. Due to their advanced education, research psychologists receive a direct commission as Army officers in the Medical Service Corps at the rank of captain. In terms of numbers, the 71F AOC is a small one, with only 25 to 30 officers serving in any given year. However, the 71F impact is much bigger than this small cadre suggests. Army research psychologists apply their extensive training and expertise in the science of psychology and social behavior toward understanding, preserving, and enhancing the health, well being, morale, and performance of Soldiers and military families. As is clear throughout the pages of this book, they do this in many ways and in many areas, but always with a scientific approach. This is the 71F advantage: applying the science of psychology to understand the human dimension, and developing programs, policies, and products to benefit the person in military operations. This book grew out of the April 2008 biennial conference of U.S. Army Research Psychologists, held in Bethesda, Maryland. This meeting was to be my last as

Consultant to the Surgeon General for Research Psychology, and I thought it would be a good idea to publish proceedings, which had not been done before. As Consultant, I'd often wished for such a document to help explain to people what it is that Army Research Psychologists "do for a living." In addition to our core group of 71Fs, at the Bethesda 2008 meeting we had several brand-new members, and a number of distinguished retirees, the "grey-beards" of the 71F clan. Together with longtime 71F colleagues Ross Pastel and Mark Vaitkus, I also saw an unusual opportunity to capture some of the history of the Army Research Psychology specialty while providing a representative sample of current 71F research and activities. It seemed to us especially important to do this at a time when the operational demands on the Army and the total force were reaching unprecedented levels, with no sign of easing, and with the Army in turn relying more heavily on research psychology to inform its programs for protecting the health, well being, and performance of Soldiers and their families."

To speak in the way of illustration, we attain our ends when we produce stools by senna, or sleep by opium. I am far from denying that a physician ought to attend diligently to particular cases in respect to the results both of the method and of the remedies which he employs in the cure of disease. I grant, too, that he may lay up his experiences for use, both in the way of easing his memory and of seizing suggestions. By so doing he may gradually increase in medical skill, so that eventually, by a long continuance and a frequent repetition of his experiments, he may lay down and prescribe for himself a METHOdUS Medendi, from which, in the cure of this or that disease, he need not deviate a single straw's breadth.
