Stanley (1841-1904), a British-born reporter who was to become a noted explorer in his own right, led the Herald's expedition. On November 10, 1871, Stanley found Livingstone in the town of Ujiji, on the shores of Lake Tanganyika, in present-day Tanzania. News of the discovery caused a worldwide sensation. # Visualizing Africa in Nineteenth-Century British Travel Accounts

Prepared by the US Bureau of Mines with the purpose of providing the latest available data and information on mining and mineral resources in Namibia, this is a well-informed and useful reference work. The study covers regional geology, the history of exploitation, mining policies and legislation, production (including detailed tables on production and reserves 1970-1981) as well as water resources, energy supply, labour and transport. It argues that uranium has the greatest potential for long-term growth, and that elsewhere a pattern of diminishing ore reserves in the metals and to a lesser extent diamonds suggests a declining resource base. Shortages of water supplies, lack of artisans and skilled labour and "the unresolved international dispute" are identified as constraints to future growth in Namibia's mining industry. There is a chapter outlining the main features of mining legislation, and a lengthy, mainly technical bibliography listing close to 200 items. As a technical and economic surveyrelying heavily on information provided by the mining companies themselves, the study has considerable value. As a guide to the political economy of Namibia, it is, however, quite misleading. The UN Decree No. 1 of 1974 is not mentioned at all, while two decades of worker organization, liberation struggle and harsh colonial repression are dismissed in the assertion that "differences among worker languages and interests have inhibited the formation of a uniform political party or union". In addition, the quality and effectiveness of many of our treatments, and health promotion and disease prevention efforts, have been significantly enhanced by the contributions of health psychologists (Taylor, 1995). Unfortunately, however, much of the theo rizing in health psychology and the empirical research that derives from it continue to reflect the mainstream bias of psychology and medicine, both of which have a primary focus on white, heterosexual, middle-class American men. This bias pervades our thinking despite the demographic heterogeneity of American society (U. S. Bureau of the Census, 1992) and the substantial body of epidemiologic evidence that indicates significant group differences in health status, burden of morbidity and mortality, life expectancy, quality of life, and the risk and protective factors that con tribute to these differences in health outcomes (National Center for Health Statistics, 1994; Myers, Kagawa-Singer, Kumanyika, Lex, & M- kides, 1995). There is also substantial evidence that many of the health promotion and disease prevention efforts that have proven effective with more affluent, educated whites, on whom they were developed, may not yield comparable results when used with populations that differ by eth

nicity, social class, gender, or sexual orientation (Cochran & Mays, 1991; Castro, Coe, Gutierres, & Saenz, this volume; Chesney & Nealey, this volume).

# African-American Exploration in West Africa

In the 1860s, as America waged civil war, several thousand African Americans sought greater freedom by emigrating to the fledgling nation of Liberia. While some argued that the new black republic represented disposal rather than emancipation, a few intrepid men set out to explore their African home. African-American Exploration in West Africa collects the travel diaries of James L. Sims, George L. Seymour, and Benjamin J. K. Anderson, who explored the territory that is now Liberia and Guinea between 1858 and 1874. These remarkable diaries reveal the wealth and beauty of Africa in striking descriptions of its geography, people, flora, and fauna. The dangers of the journeys surface, too -- Seymour was attacked and later died of his wounds, and his companion, Levin Ash, was captured and sold into slavery again. Challenging the notion that there were no black explorers in Africa, these diaries provide unique perspectives on 19th-century Liberian life and life in the interior of the continent before it was radically changed by European colonialism.

# The Ties that Bind

This book presents an interpretation and analysis of the phenomenon of ambivalence so persistent in the Afro-American consciousness of Africa. Today a wide range of black opinion has accepted Pan-Africanism and Africa and many are consciously making an effective attempt to create more links with Africa. The right of blacks to be culturally independent is now accepted, at least verbally, without question. But this was not always the case. The present study is offered as an exploration in the field of social identity as it affects people in diaspora. The identity of every people is shaped in their environment, it is a legacy of historical forces.

#### African Americans and Africa

An introduction to the complex relationship between African Americans and the African continent What is an "African American" and how does this identity relate to the African continent? # The African-American Odyssey: To 1877

An exploration of the political and social experiences of African Americans in transition from enslaved to citizen Claiming Freedom is a noteworthy and dynamic analysis of the transition African Americans experienced as they emerged from Civil War slavery, struggled through emancipation, and then forged on to become landowners during the Reconstruction and post-Reconstruction period in the Georgia lowcountry. Karen Cook Bell's work is a bold study of the political and social strife of these individuals as they strived for and claimed freedom during the nineteenth century. Bell begins by examining the meaning of freedom through the delineation of acts of self-emancipation prior to the Civil War. Consistent with the autonomy that they experienced as slaves, the emancipated African Americans from the rice region understood citizenship and rights in economic terms and sought them not simply as individuals for the sake of individualism, but as a community for the sake of a shared destiny. Bell also examines the role of women and gender issues, topics she believes are understudied but essential to understanding all facets of the emancipation experience. It is well established that women were intricately involved in rice production, a culture steeped in African traditions, but the influence that culture had on their autonomy within the community has yet to be determined. A former archivist at the National Archives and Records Administration, Bell has wielded her expertise in correlating federal, state, and local records to expand the story of the all-black town of 1898 Burroughs, Georgia, into one that holds true for all the American South. By humanizing the African American experience, Bell demonstrates how men and women leveraged their community networks with resources that enabled them to purchase land and establish a social, political, and economic foundation in the rural and urban post-war era.

# West Indians in West Africa, 1808-1880

One of the most famous early white explorers of central West Africa, the American Paul du Chaillu won fame for confirming the existence of the gorilla-and for his accurate and breathtaking descriptions of the life, customs and behavior of Africans in the pre-colonial era. This book was written after the author's last expedition into the African interior when Du Chaillu set out with the intention of reaching the Nile River. After over a year of travel, the expedition failed and he was forced back after being wounded by a poison arrow during an attack by a hostile interior tribe. The high adventure of Du Chaillu's expedition-and brutally frank descriptions of his encounters with the natives-are just part of what makes this work a compelling read. It also contains vivid and uncensored descriptions of native African culture, cannibalism, tribal warfare, witchdoctors, superstition, and technology. His astute observations were

used by Oxford University professor John R. Baker in a section on African cognitive ability in his classic work Race. His description of African slavery in particular, is highly relevant, as it shows that the biggest traders in slaves were the Africans themselves, despite all efforts by the British Royal Navy to halt the practice. "Happily the Slave Trade will never flourish as it did in times past, and it may be said now to be almost entirely done away with. In the country of my late exploration, the only people who continue the traffic in slaves are negro agents, from the two Portuguese islands St. Thomas and Prince's, who purchase people for their masters, who are also negroes. They cross to and from the mainland in small canoes, and thus avoid the cruisers." He also addresses the claimed existence of advanced African kingdoms in West Africa prior to the advent of the European Age of Exploration: "The reader who has followed me through the volume of my former exploration and the present book, will have been able to gather an idea of the general character and disposition of the negro of this part of Africa, as he now stands. I have made researches to ascertain if his race had formerly left remains, showing that he had once attained a tolerably high state of civilisation; my researches have proved vain, I have found no vestige whatever of ancient civilisation. Other travellers in different parts of Africa have not been more successful than I have." He also addresses pre-colonial African technology: "I think everything tends to show that the negro is of great antiquity, and has always remained stationary. The working of iron, considering the very primitive way they work it, and how easy it is to find the ore, must have been known to them from the remotest time, and to them the age of stone and bronze must have been unknown." He also opines unfavorably on Africa's future: "As to his future capabilities, I think extreme views have prevailed among us. Some hold the opinion that the negro will never rise higher than he is; others think that he is capable of reaching the highest state of civilization. For my own part, I do not agree with either of these opinions. "I believe that the negro may become a more useful member of mankind than he is at present, that he may be raised to a higher standard; but that, if left to himself, he will soon fall back into barbarism, for we have no example to the contrary. In his own country the efforts of the missionaries for hundreds of years have had no effect; the missionary goes away and the people relapse into barbarism. Though a people may be taught the arts and sciences known by more gifted nations, unless they have the power of progression in themselves, they must inevitably relapse in the course of time into their former state." This new edition has been completely reset and contains all original 23 illustrations and maps.
