This volume is a result of the need to reflect upon Portugal's position from the viewpoint of the literary assets imported and exported through translation. It brings together a number of scholars working in the field of Translation Studies directly concerned with the Portuguese cultural system in order to analyse this question from various theoretical perspectives and from case studies of translation flows and movements in Portuguese culture. By Translating Portugal Back and Forth, the articles discuss issues such as: how can one draw the borderline between a peripheral and a semi-peripheral system? Is this borderline useful or necessary? How peripheral is the Portuguese cultural system as far as translation transfers are concerned? How stable or pacific has this positioning been? Does the economic and historical perception of Portugal as peripheral entail that, from the viewpoint of translation, it would behave similarly? By addressing some of these questions, and as shown by the (second) subtitle – Essays in Honour of João Ferreira Duarte –, the volume pays homage to one of the most prominent Translation Studies scholars in Portugal, who has extensively reflected on the binary discourse on translation, its metaphors and images.

Chronica do Principe D. Sebastião Decimosexto Rey de Portugal

In his book "The Study Of Ancient Times In The Malay Peninsula", Dato Sir Roland Braddell (1880-1966) writes, "No statement could be more untrue or more unwise than that Malaya has no history". This dense work of 458 pages (reprinted edition no. 7 by MBRAS in 1989), from Dato Sir Braddell's studies appearing in the "Journal of Asiatic Society", between 1935 and 1951, is followed by 50 pages of notes on the historical geography of Malaya and sidelights on the Malay Annals by Dato F.W. Douglas, a contemporary of Braddell. Sir Roland examines the book VII of "Ptolemy's Geographica" written about 160 AD, which sends us back to the land of Ophir of the Bible, also called "Golden Chersonese", where gold of higher purity had already been found around 3000 years ago in today's Pahang. As to the human presence, the "Malay Orang", "being an islander", (he) was able to sail the Eastern seas long before the people of the mainland could; and by such contacts achieved a higher state of civilization: he took the products of this area, gold, incense, spices and the Malayan jungle fowl with him and then the people of other countries came here", according to F.W. Douglas in the conclusion of his foreword, dated 15.1.1949. Malays are therefore inborn sea traders.

Identity, Civic Engagement and Multiculturalism: Portuguese-Canadian Immigrant Descendants in Canada and Portugal

In this richly detailed, sensitive ethnographic work, Sally Cole takes as her starting point the firsthand accounts of five differently situated Portuguese women, who describe their lives in a rural fishing community on the north coast of Portugal. Skillfully combining these life stories with cultural and economic analysis, Cole radically departs from the picture of women as sexual beings that prevails in the anthropological literature on Europe and the Mediterranean. Her very different strategy--a focus on women as workers--reflects the Portuguese women's own definition of themselves and allows them the strong, resonant voice that is the goal of both the new ethnography and feminist scholarship. From this new perspective, Cole proposes an important critique of the dominant paradigm of southern European gender relations as being embedded in the code of honor and shame. Covering the Salazar years, as well as the period since the 1974 Revolution, Cole shows that fisherwomen of the past enjoyed greater autonomy in work and social relations than do their daughters and granddaughters, who live in a context of increasing commoditization and industrialization. Central to this account is an examination of the changing structure and role of the household as economic production moved to the factory.

Foreword by Adrian Forty. The Algarve is not only Portugal's foremost tourism region. Uniquely Mediterranean in an Atlantic country, its building customs have long been markers of historical and cultural specificity, attracting both picturesque driven conservatives and modernists seeking their lineage. Modernism, regionalism and the 'vernacular' – three essential tropes of twentieth-century architecture culture – converged in the region's building identity construct and, often the subject of strictly metropolitan elaborations, they are examined here from a peripheral standpoint instead. Drawing on work that won the Royal Institute of British Architects President's Award for Outstanding PhD Thesis in 2013, *Algarve Building* challenges the conventional inclusion of Portuguese modern architecture in 'Critical Regionalism' narratives. A fine-grain reconstruction of the debates and cultures at play locally exposes the extra-architectural and widely participated antecedents of the much-celebrated mid-century shift towards the regional. Uncelebrated architects and a cast of other players (clients, officials, engineers and builders) contributed to maturing a regional strand of modern architecture that, more than being the heroic outcome of a hard-fought 'battle' by engaged designers against a conservative establishment, became truly popular in the Algarve. *Algarve Building* shows, more broadly, what the processes that have been appropriated by the canon of architectural history and theory – such as the presence of folk traditions and regional variation in learned architecture – stand to gain when observed in local everyday practices. The grand narratives and petites histoires of architecture can be enriched, questioned, revised and confirmed by an unprejudiced return to its facts and sources – the buildings, the documents, the discourses, the agents and the archives.

Combining regional and local perspectives on both sides of the Atlantic, *Chains of Gold* provides a vivid account of the trajectories of migrant men and women as they moved from rural Portugal to contrasting places of settlement in the Argentine pampas and Patagonia.

Portugal

This book examines the entire Portuguese normative universe up until the eve of the definitive establishment of the liberal legal order in 1834. Through this investigation, its aim is to determine the space that the 'private sphere' (comprising individuals, families, societies, and associations) had to lawfully carry out their actions or initiatives, particularly those of an economic nature involving the mobilization of assets and their conversion into capital. In this context, fiscal and administrative constraints are also considered, along with the conditions of access to justice and the informal procedures encouraged by formal rules. Focusing specifically on the period starting in 1603, with the last compilation of the Ordinances of the Kingdom, the study of the legal structure and its practical application in various sectors of activity is systematically related to its antecedents since the medieval period and in Roman law.

Globalism, Localism and Identity

This volume gathers 88 contributions related to the theme 'Ships and Maritime Landscapes' of the Thirteenth International Symposium on Boat and Ship Archaeology (ISBSA 13) held in Amsterdam on the 7th to 12th October 2012.
