#### It's All in the Game

Three questions concerning modern legal thought provide the framework for It's All in the Game: What should judges do? What do judges do? What can judges do? Contrasting his own answers to traditional responses and moving playfully between debates of high theory, daily practices of appellate judges, and his own enlightening analyses of significant court rulings, Allan C. Hutchinson examines what it means to treat adjudication as an engaged game of rhetorical justification. His resulting argument enables the reader to grasp more fully the practical operation, political determinants, and the transformative possibilities of law and adjudication. Taking on leading contemporary theories to explore the claim that "law is politics," Hutchinson delineates a route toward professional, relevant, and responsible—if radical—judicial practices. After discussing the difference between foundationalist, antifoundationalist, and nonfoundationalist legal critiques, he offers a focused, unequivocal, and positive account of the advantages of operating within a nonfoundationalist framework. Although such an approach centralizes the role of rhetoric in law, Hutchinson claims that this does not necessitate a turn away from politics or, more particularly, from a progressive politics. Driving home the political and jurisprudential impact of his critique and of his account of nonfoundationalist alternatives, he urges judges and jurists to engage in law's language game of politics. This engaging book will interest linguistic philosophers, legal theorists, law students, attorneys, judges, and jurists of all stripes.

## It's All in the Game

#### Cricket and the Law

There is an enormous scholarly literature on law's treatment of religion. Most scholars now recognize that although the US Supreme Court has not offered a consistent interpretation of what 'non-establishment' or religious freedom means, as a general matter it can be said that the First Amendment requires

that government not give preference to one religion over another or, although this is more controversial, to religion over non-belief. But these rules raise questions that will be addressed in Legal Responses to Religious Practices in the United States: namely, what practices constitute a 'religious activity' such that it cannot be supported or funded by government? And what is a religion, anyway? How should law understand matters of faith and accommodate religious practices?

## Legal Responses to Religious Practices in the United States

This book offers a radical challenge to accounts of the common law's development. Contrary to received jurisprudential wisdom, it maintains there is no grand theory which will explain satisfactorily the dynamic interactions of change and stability in the common law's history. Offering original readings of Charles Darwin's and Hans-Georg Gadamer's works, the book shows that law is a rhetorical activity that can only be properly appreciated in its historical and political context; tradition and transformation are locked in a mutually reinforcing but thoroughly contingent embrace. In contrast to the dewy-eyed offerings of much contemporary work, it demonstrates that, like life, law is an organic process (i.e., events are the products of functional and localized causes) rather than a miraculous one (i.e., events are the result of some grand plan or intervention). In short, common law is a perpetual work-in-progress - evanescent, dynamic, messy, productive, tantalising, and bottom-up.

#### Evolution and the Common Law

Providing another key contribution to the immensely popular field of law and economics, this book, written by the doyen of the history of economic thought in the US, explores the dynamic relationship between economics, law and polity. Combining a selection of old and new essays by Warren J. Samuels that chart a number of key themes, it provides an important commentary on the development of an academic field and demonstrates how policy is structured and manipulated by human social construction. The areas covered include: the role of manufactured belief power the nature and sources of rights the construction of markets by firms and governments and the problem of continuity and change in the form of the question of the selectively defined status quo and its status the absolutist character of government, rights, markets and legal principles and the accepted ideational structure of law. The Legal-Economic Nexus is an essential read both economists and legal professionals as well as those researching the history of economic thought and the social construction of law.

## The Legal-Economic Nexus

A liberal state is a representative democracy constrained by the rule of law. Richard Posner argues for a conception of the liberal state based on pragmatic theories of government. He views the actions of elected officials as guided by interests rather than by reason and the decisions of judges by discretion rather than by rules. He emphasizes the institutional and material, rather than moral and deliberative, factors in democratic decision making. Posner argues that democracy is best viewed as a competition for power by means of regular elections. Citizens should not be expected to play a significant role in making complex public policy regarding, say, taxes or missile defense. The great advantage of democracy is not that it is the rule of the wise or the good but that it enables stability and orderly succession in government and limits the tendency of rulers to enrich or empower themselves to the disadvantage of the public. Posner's theory steers between political theorists' concept of deliberative democracy on the left and economists' public-choice theory on the right. It makes a significant contribution to the theory of democracy—and to the theory of law as well, by showing that the principles that inform Schumpeterian democratic theory also inform the theory and practice of adjudication. The book argues for law and democracy as twin halves of a pragmatic theory of American government.

## Law, Pragmatism, and Democracy

Challenging the dominant account of medical law as normatively and conceptually subordinate to medical or bioethics, this book provides an innovative account of medical law as a rhetorical practice. The aspiration to provide a firm grounding for medical law in ethical principle has not yet been realized. Rather, legal doctrine is marked, if anything, by increasingly evident contradiction and indeterminacy that are symptomatic of the inherently contingent nature of legal argumentation. Against the idea of a timeless, placeless ethics as the master discipline for medical law, this book demonstrates how judicial and academic reasoning seek to manage this contingency, through the deployment of rhetorical strategies, persuasive to concrete audiences within specific historical, cultural and political contexts. Informed by social and legal theory, cultural history and literary criticism, John Harrington's careful

reading of key judicial decisions, legislative proposals and academic interventions offers an original, and significant, understanding of medical law.

### Towards a Rhetoric of Medical Law

The contemporary legal theory is gradually departing from traditional theory of the hierarchical legal system. Some authors announce the supposed death of the concept of law within the state. The so-called multicentrism might become an attractive alternative to the traditional monocentric approach. The essence of multicentrism may be characterized as coexistence of many adjudicating bodies, especially courts, whose verdicts are equally effective within the national legal system. Such a situation takes place e. g. within the European legal area where multicentrism could be perceived as the existence of «sensitive» liaisons, entanglements and relations of dependence between the European Court of Human Rights in Strasbourg, the European Court of Justice in Luxemburg and national (especially constitutional) courts in member states. The coexistence of many centres of adjudication may thus become a constant feature of the system of regional and global law.

# Multicentrism as an Emerging Paradigm in Legal Theory

This book argues, from a normative perspective, for the incorporation of an egalitarian sensitivity into tort law, and more generally, into private law. It shows how an egalitarian sensitivity can reformulate tort doctrine, with an emphasis on the tort of negligence. Rather than a comprehensive descriptive account of existing tort law, this book pro-actively searches for new approaches and conceptual tools to meet the challenges faced by egalitarians. The understanding of tort law offered in this book will bring about better practical results in specific cases. It supports the progressive troops in the ongoing philosophical and social battles that take place in the field of tort law and also adds another voice - rich, nuanced and sensitive - to the chorus that is tort theory.

# The Power of Language in the Making of International Law

Capturing the Change: Universalising Tendencies in Legal Interpretation Joanna Jemielniak and Przemys aw Mik aszewicz International and supranational integration on the European continent, as well as the harmonisation of the rules of international trade and the accompanying dev-opment and global popularity of the resolution of commercial disputes through arbitration, constantly exerts a considerable in uence on modern legal systems. The sources of each of these phenomena are different, and their action is dissimilar. Each can be described as reaching either from the top to the bottom, through the direct involvement of interested States and consequently affecting their internal legal stems (international and supranational integration; harmonisation of trade regulations through public international law instruments), or bottom-up, as a result of activity by private parties, leading to the achievement of uniform practices and standards (ar-tration, lex mercatoria). Nonetheless, they both enrich national legal cultures and contribute to transgressing the limits of national (local) particularisms in creating, interpreting and applying the law. The aim of this book is to demonstrate how these processes have in uenced the interpretation of law, how they have shaped the methods and techniques of the interpretation and with what consequences for the outcomes of the interpretative procedures. In assessing the extent of this in uence, due regard must be paid to the fact that the interpretation of law is not, in principle, directly determined by the provisions of law itself.

## Interpretation of Law in the Global World: From Particularism to a Universal Approach

Normative texts are meant to be highly impersonal and decontextualised, yet at the same time they also deal with a range of human behaviour that is difficult to predict, which means they have to have a very high degree of determinacy on the one hand, and all-inclusiveness on the other. This poses a dilemma for the writer and interpreter of normative texts. The author of such texts must be determinate and vague at the same time, depending upon to what extent he or she can predict every conceivable contingency that may arise in the application of what he or she writes. The papers in this volume discuss

important legal and linguistic aspects relating to the use of vagueness in legal drafting and demonstrate why such aspects are critical to our understanding of the way normative texts function.

## Vagueness in Normative Texts

International lawyers have long recognised the importance of interpretation to their academic discipline and professional practice. As new insights on interpretation abound in other fields, international law and international lawyers have largely remained wedded to a rule-based approach, focusing almost exclusively on the Vienna Convention on the Law of Treaties. Such an approach neglects interpretation as a distinct and broader field of theoretical inquiry. Interpretation in International Law brings international legal scholars together to engage in sustained reflection on the theme of interpretation. The book is creatively structured around the metaphor of the game, which captures and illuminates the constituent elements of an act of interpretation. The object of the game of interpretation is to persuade the audience that one's interpretation of the law is correct. The rules of play are known and complied with by the players, even though much is left to their skills and strategies. There is also a meta-discourse about the game of interpretation - 'playing the game of game-playing' - which involves consideration of the nature of the game, its underlying stakes, and who gets to decide by what rules one should play. Through a series of diverse contributions, Interpretation in International Law reveals interpretation as an inescapable feature of all areas of international law. It will be of interpretation.

## Interpretation in International Law

Adopting a multi-disciplinary and comparative approach, this book focuses on the emerging and innovative aspects of attempts to target the accumulated assets of those engaged in criminal and terrorist activity, organized crime and corruption. ## The Rule of Law and Delivering Justice in Africa

This book examines the use, principally in economics, of the concept of the invisible hand, centering on Adam Smith. It interprets the concept as ideology, knowledge, and a linguistic phenomenon. It shows how the principal Chicago School interpretation misperceives and distorts what Smith believed on the economic role of government. The essays further show how Smith was silent as to his intended meaning, using the term to set minds at rest; how the claim that the invisible hand is the foundational concept of economics is repudiated by numerous leading economic theorists; that several dozen identities given the invisible hand renders the term ambiguous and inconclusive; that no such thing as an invisible hand exists; and that calling something an invisible hand adds nothing to knowledge. Finally, the essays show that the leading doctrines purporting to claim an invisible hand for the case for capitalism cannot invoke the term but that other nonnormative invisible hand processes are still useful tools.

## The Rhetoric of the Jewish Liturgy

In the 2002 edition of From Ideology to Liturgy, Eric Caplan examined Reconstructionism's interpretation and adaptation of the traditional Jewish liturgy and its creation of new prayer texts to convey and express the movement's changing ideology. Further insight into Reconstructionist liturgy was gained through comparing these prayerbooks to the contemporaneous liturgies of Reform and Conservative Judaism and to the work of Jewish Renewal. In this new supplemented reprint edition, Caplan offers an expansive study of liberal Jewish prayerbooks published in the decades since From Ideology to Liturgy first appeared and revisits his earlier conclusions in light of more recent expanded access to Mordecai Kaplan's diaries and archives.

## The Experience of Jewish Liturgy

Readers of this book will emerge with a new awareness of what we as Jews are doing when we pray, why we are doing it, how we are supposed to be affected by prayer, how the prayers came to be as they are today, and how they differ among the major movements of American Judaism. The traditional Jewish liturgy, if properly understood, is a deep and powerful technique for spiritual transformation. However, spiritual depth of prayer has been progressively reduced over the past 2000 years as the underlying currents of the Siddur, the Jewish prayerbook, have been lost to the majority of worshippers. This book explains the Jewish liturgy prayer by prayer, according to what, in the context of ancient and medieval Judaism, was its raison d',tre: a structure for transforming one's mind and way of life. The author writes: "The crisis Judaism now faces, while genuine, is due not to a lack of depth in the traditional Jewish prayer service, but to a profound and almost universal lack of understanding of that prayer service that pervades all segments of the Jewish community. Jewish prayer services in many contemporary synagogues lack spiritual fervor because the linkage between word and ritual, on the one hand, and mental transformation on the other, that would generate such fervor is not generally known to Jewish adults and is not taught to Jewish children. Unfortunately, the prayer service regularly degenerates into

a race through words and gestures divorced from the sequence of mental states and visualizations through which these words and gestures were intended to lead us." This book was written to reunite the activity and language of prayer with its original transformative goal, by educating worshippers about what is at the heart of the siddur. Several chapters provide an overview of the Jewish prayer service and its spiritual flow. These chapters explain the visualizations, allusions, and meditative techniques that form the heart of the service and the altered states of consciousness through which the service ca

## From Ideology to Liturgy

A major influence on the development of rabbinic liturgical custom after the destruction of the Temple was the need to establish that this innovative worship of the heart was as acceptable to God as biblically prescribed sacrificial worship. Later Jewish communities and their leaders continually refined the details of the system they inherited to reflect their changing understandings of acceptable, meaningful, and constructive worship. These understandings have in turn been shaped not only by liturgical halakhah and active custom, but by new intellectual and social currents and by the vicissitudes of Jewish history. Ruth Langer uses the tools of historical scholarship and anthropological study of ritual to analyze some of the dynamics that have shaped Jewish liturgical law and determined the broader outlines of the prayer life of the Jews. After a consideration of the talmudic issues upon which the acceptability of prayer depends, she offers a basic list of legal principles derived by later generations from talmudic literature to ensure that prayer takes the form of blessings composed according to a very specific pattern and invoking God in a very precise way. She then investigates the development and implementation of the corollary that invoking this blessing formula in ways that deviate from the specific directions of the Talmud constitutes precisely inefficacious and even dangerous prayer. Questions about appropriate prayer language go beyond the blessing formula to the contents of the prayers themselves. Langer analyzes the battles fought over the legitimacy of inserting liturgical poetry into the fixed texts of the statutory liturgy and over the requirement of community for the proper recitation of certain prayers, specifically those that include the angelic liturgy. Although in each of these controversies the rabbis compromised by reinterpreting either legal theory or custom-or both-to bring them into harmony, their solutions have never been monolithic or simple. In its lucid illumination of those complexities, To Worship God Properly adds to our understanding of the history of Jewish liturgy and the general history of rabbinic leadership and law.

# Jewish Liturgy as a Spiritual System

The contributors and editors dedicate this volume of research to Professor Stefan C. Reif on the occasion of his 75th birthday. Together these twenty papers reflect our appreciation for his exemplary scholarship and lifelong commitment to acquaint our world with the theological and cultural riches of Jewish Studies. This collection reflects the breadth of Prof. Reif's interests insofar as it is a combination of Second Temple studies and Jewish studies on the roots of Jewish prayer and liturgy which is his main field of expertise. Contributions on biblical and second temple studies cover Amos, Ben Sira, Esther, 2 Maccabees, Judith, Wisdom, Qumran Psalms, and James. Contributions on Jewish studies cover nuptial and benedictions after meals, Adon Olam, Passover Seder, Amidah, the Medieval Palestinian Tefillat ha-Shir, and other aspects of rabbinic liturgy. Moreover, the regional diversity of scholars from Israel, continental Europe, the United Kingdom, Ireland and North America mirrors Stefan's travels as a lecturer and the reach of his publications. The volume includes a foreword of appreciation and a bibliographic list of Professor Reif's works.

## Contributions to the Scientific Study of Jewish Liturgy

Having been raised as a Quaker, with a distinct lack of liturgical celebration, Sean Innerst shows how the liturgical year of the Church is a fulfillment of the Jewish "liturgical year." Many protestant denominations claim that the ritual celebrations (for example, Easter and Christmas) are a part of the Old Law that was laid aside with the coming of our Lord – they maintain that every day is a "day of grace," equally blessed by God. However, Innerst shows that there is a distinct correlation between the Jewish and Catholic liturgical cycles, and why this rhythm of fast and feast is so important from a human perspective.

## To Worship God Properly

This unique and groundbreaking study moves "beyond the texts" of prayers to carefully study the worshipping community from an anthropological perspective. Hoffman's innovative approach opens

up the world of prayer to the academy and the community at large. With the publication of this book, the study of liturgy will never again be the same.

## On Wings of Prayer

In this collection of essays, Professor Zahavy explores the origins and early history of prayer in Judaism. He examines the growth of rabbanic liturgy from immediately after the destruction of the Temple in 70 CE until the close of the Talmud of the Land of Israel. Zahavy shows how rabbanic rules for prayer reflect the historical circumstances of the Jews in late antique Israel. He argues, based on close textual analysis, that rabbis had little influence over the governance of synagogues in the first and second centuries.

## Time for Liturgy Appointed Times in Judaism and Christianity: Catholic for a Reason III

Since the period in which the Jewish liturgy was standardized, there has hardly been a time when it was not somehow in a state of flux. Eric L. Friedland explores the countless ways that the Siddur, Mahzor, and Haggadah have been adjusted, amplified, or transformed so as to faithfully mirror modern Jews' understanding of themselves, their place in society, and their sancta. In the tradition of liturgologists such as Elbogen, Idelsohn, and Petuchowski, Friedland focuses on latter-day adaptations of the prayerbook, giving proper recognition to the recent concern for intellectual integrity, cultural congruity, group and individual self-redefinition, and honest speech in Jewish prayer. The prayerbooks themselves are witnesses to innovation in the Jewish liturgy. From David Einhorn's Olath Tamid (Baltimore 1855), to Isaac Mayer Wise's Minhag Amerika (Cincinnati 1857) and Marcus Jastrow's 1873 revision of Benjamin Szold's Abodath Israel (Baltimore 1864), Friedland analyzes evidence of creativity in British and American Reform Jewish liturgy. Various rites for the Days of Awe provide a particularly accurate glimpse of how Jewish communities here and abroad experience the sacred, consider eternal mysteries, and communicate with God. Friedland also sets the Reform Gates of Prayer in historical and denominational perspective by considering it alongside the Reconstructionist Kol Haneshamah, and the Israeli Progressive HaAvodah shebaLev. The state and direction of liturgical change emerges from a survey of commonalities and divergences in nineteenth- and twentieth-century prayerbooks in terms of Sephardic and mystical influences, attitudes toward the messianic hope, and collective sentiments of forgiveness or vengeance toward Israel's enemies. Liturgical approaches to the commemoration of the Ninth of Av suggest that even an ancient fast day can recover relevance, credibility, and authenticity for Liberal Jews in the postmodern era.

## Beyond the Text

Liturgies mirror the philosophical, theological, sociological, and political realities of the communities that create them. As Jewish communities immigrated to the New World, they brought with them the language, structure, and content of their prayers. Early Sephardic immigrants created liturgy that reflected their traditions as well as their new colonial life. Later German immigrants of the mid-nineteenth century brought reforming trends from their native country. These different communities had different language needs, and prayerbooks began appearing with translations (English, German, Yiddish). The Hebrew text also varied. Wachs' American Jewish Liturgies offers scholars, rabbis, and anyone interested in liturgical history a bibliography of Jewish liturgy published in the United States up to 1925. With 1,300 separate entries that catalogue prayerbooks, devotionals, memorials, children's prayers, hymnals, and scores, it attempts to be as comprehensive as possible and represents the very first time such an extensive bibliography has been brought together on the topic. It is invaluable for the information it provides on the creation, evolution, and distribution of Jewish liturgy in the United States through 1925. Four indices (Geographical, Name, Title, and Liturgical) makes it easy to find information of particular interest.

## The Lord's Prayer and Jewish Liturgy

The "Radical Traditions" series cuts new lines of enquiry across a confused array of debates concerning the place of theology in the modern world. The series invites Jewish, Christian and Islamic theologians back to the word, recovering modes of scriptural reasoning that underlie modernist reasoning. The latest in series, "Liturgy, Time and the Politics of Redemption" is divided into five parts - Liturgical Acts, Liturgical Time, Liturgical Scrolling, Liturgical Improvisation, and Liturgical Silence - each featuring essays about a different aspect of Jewish or Christian liturgy. Among the highlights: In the first part, Peter Ochs invites readers to participate in a thought experiment that demonstrates how the act of reciting

Jewish Morning Prayer has the potential for reorienting our view of the world. Sam Wells presents an improvisational reading of the "Book of Esther" in the section entitled Liturgical Improvisation. He illustrates how the idea of "overacceptance" characterizes Christian engagement with the world. In the section entitled Liturgical Silence, Oliver Davies imports two Russian words for silence (molchanie and tishina) to illumine what he calls "the silence of the cross." Taken together, the essays challenge the modern and postmodern understandings of time that Western culture takes for granted and pose alternatives that, to quote coeditor Randi Rashkover, "have the capacity to redefine sociality and choreograph the redemption of time through political acts of liturgical life."

## Studies in Jewish Prayer

Much of the primary research summarized here relates to Cambridge Genizah manuscripts, a thousand-year-old source that testifies to liturgical (as well, of course, as non-liturgical) developments that greatly predate other source material. When the research is concerned with pre-Genizah history, the Genizah evidence is also relevant since the historian of religious ideas must ultimately decide how to date, characterize, and conceptualize its contents and how to explain where they vary significantly from what became, or is regarded (rightly or wrongly) as having become, the standard rabbinic liturgy sanctioned by the Iraqi Jewish authorities from the ninth to the eleventh century.

## Jewish Liturgy and Its Development

Common to both Judaism and Christianity is a heightened engagement with time within liturgical practice, in which collective religious memory and anticipation come together to create a unique sense of time. Exploring the nebulous realms of religious experience and the sense of time, Remembering the Future charts the ways that the experience of time is shaped by the traditions of Judaism and Christianity and experienced within their ritual practices. Through comparative explorations of traditional Jewish and Christian understandings of time, contemporary oral testimonies, and discussions of the work of select twentieth-century Jewish and Christian thinkers, this book maps the temporal landscapes of the religious imagination. Maintaining that the sense of time is integral to Jewish and Christian religious experience, Remembering the Future makes a notable contribution to interreligious studies and liturgical studies. It sheds light on essential aspects of religious experience and finds that the intimacy of the experience of time grants it the capacity to communicate across religious boundaries, subtly transgressing obstacles to interreligious understanding.

#### Were Our Mouths Filled With Song

This book demonstrates the complexity, fluidity and variety in Jewish liturgy, and discusses the possible parameters of change, be it in additions, deletions, alterations, and/or corrections, so as to reflect the contemporary situation and its sensitivities. It will stimulate thought and discussion and lead to a deeper appreciation of the nature of the liturgy, and an ability to find greater meaning in prayer.

## American Jewish Liturgies

This work of immense Scholarship (673 pages) is well-documented and written with scholarship and love. Chapter 7 deals with Shabbat liturgy (p. 161-198), which is discussed in detail with a special focus on historical development.

## Liturgy, Time, and the Politics of Redemption

This book examines the basic beliefs of Judaism in light of modern thought. Its shape is traditional but not fundamentalist. This book, the main cause of the 'Jacobs Affair' in which the author's appointment to an Orthodox Rabbinic position was vetoed, suggests that the doctrine Torah Min Ha-Shamayyin (The Torah is from Heaven) needs to be reinterpreted so as not to be in conflict with modern knowledge. The controversy erupted again in the 1990s when Chief Rabbi Jonathan Sacks declared that those who hold views similar to the author's have severed links with the faith of their ancestors. This expanded fifth edition, with a Preface by William Frankel and a Retrospect of the 'Jacobs Affair' by the author, will enable readers to follow the argument and make up their own minds. In a recent poll conducted by the (London) Jewish Chronicle, Louis Jacobs was chosen as the 'Greatest British Jew.'

#### **Problems with Prayers**

The Making of Jewish and Christian Worship, volume 1 of Two Liturgical Traditions, surveyed the origins and growth of Christian and Jewish liturgy from the first century of the common era until our time.
