Dual Tableaux: Foundations, Methodology, Case Studies

This book presents logical foundations of dual tableaux together with a number of their applications both to logics traditionally dealt with in mathematics and philosophy (such as modal, intuitionistic, relevant, and many-valued logics) and to various applied theories of computational logic (such as temporal reasoning, spatial reasoning, fuzzy-set-based reasoning, rough-set-based reasoning, order-of magnitude reasoning, reasoning about programs, threshold logics, logics of conditional decisions). After a brief introduction to classical propositional logic, the text explores three variants of sequent calculus and their features and applications. The remaining chapters then show how sequent calculi can be extended, modified, and applied to non-classical logics, including modal, intuitionistic, substructural, and many-valued logics. Sequents and Trees is suitable for graduate and advanced undergraduate students in logic taking courses on proof theory and its application to non-classical logics. It will also be of interest to researchers in computer science and philosophers.
