Gilbert Ryle's 1949 *The Concept of Mind* is now famous above all as the origin of the phrase "the ghost in the machine" – a phrase Ryle used to attack the popular idea that our bodies and minds are separate. His own position was that mental acts are not at all distinct from bodily actions. Indeed, they are the same thing, merely described in different ways – and if one cuts through the confusing language of the old philosophical debates, he suggests, that becomes clear. While, in many ways, modern philosophers of mind have moved on from or discarded Ryle's actual arguments, *The Concept of Mind* remains a classic example of two central critical thinking skills: interpretation and reasoning. Ryle was what is known as an "ordinary language" philosopher – a school who considered many philosophical problems to exist purely because of philosophical language. He therefore considered his task as a philosopher to be one of cutting through confusing language, and clarifying matters – exemplifying the critical thinking skill of interpretation at its best. Rather than adding to philosophical knowledge as such, moreover, he saw his role as one of mapping it – giving it what he called a "logical geography." As such, *The Concept of Mind* is also all about reasoning: laying out, organizing, and systematizing clear arguments.

An Analysis of Gilbert Ryle's The Concept of Mind

Aspects of Mind contains previously unpublished manuscript material by Gilbert Ryle along with notes taken by the editor, Rene Meyer, at lectures given by Ryle on the philosophy of mind in 1964. Gilbert Ryle, Waynflete Professor of Metaphysical Philosophy at the University of Oxford from 1945 until 1967, had a decisive influence on contemporary philosophy. His *Concept of Mind* (1949) not only put a methodological edge in a most readable way to what has become known as Analytical Philosophy, but it also stimulated interest in the philosophy of mind as a pivotal part of philosophy as a whole. A second important influence derives from his reorganization of philosophical studies at Oxford after the war which made it, for several years, one of the liveliest philosophical centres in the world. Ryle's interest covered almost the entire field of philosophy. He also made substantial contributions to the history of philosophy, notably on Plato, Locke, Hume, Husserl and Heidegger. Gilbert Ryle died in October 1976. The book also includes two tributes to Ryle; one from John Mabbott, a close friend, on Ryle the man, and one from David Gallop, an ex-student, on Ryle the Philosopher. A chapter entitled "Philosophy, Logical Geography and Dilemmas" by Rene Meyer provides a perspective on Ryle's philosophy.

Passions of the Soul

In the years since Daniel Dennett's influential *Consciousness Explained* was published in 1991, scientific research on consciousness has been a hotly contested battleground of rival theories—"so rambunctious," Dennett observes, "that several people are writing books just about the tumult." With *Sweet Dreams*, Dennett returns to the subject for "revision and renewal" of his theory of consciousness, taking into account major empirical advances in the field since 1991 as well as recent theoretical challenges. In *Consciousness Explained*, Dennett proposed to replace the ubiquitous but bankrupt Cartesian Theater model (which posits a privileged place in the brain where "it all comes together" for the magic show of consciousness) with the Multiple Drafts Model. Drawing on psychology, cognitive neuroscience, and artificial intelligence, he asserted that human consciousness is essentially the mental software that reorganizes the functional architecture of the brain. In *Sweet Dreams*, he recasts the Multiple Drafts Model as the "fame in the brain" model, as a background against which to examine the philosophical issues that "continue to bedevil the field." With his usual clarity and brio, Dennett enlivens his arguments with a variety of vivid examples. He isolates the "Zombic Hunch" that distorts much of the theorizing of both philosophers and scientists, and defends heterophenomenology, his "third-person" approach to the science of consciousness, against persistent misinterpretations and objections. The old challenge of Frank Jackson's thought experiment about Mary the color scientist is given a new rebuttal in the form of "RoboMary," while his discussion of a famous card trick, "The Tuned Deck," is designed to show that David Chalmers's Hard Problem is probably just a figment of theorists' misexploited imagination. In the final essay, the "intrinsic" nature of "qualia" is compared with the naively imagined "intrinsic value" of a dollar in "Consciousness—How Much is That in Real Money?"

Content and Consciousness

Descartes's Concept of Mind

An important task for every major philosopher is to offer us an understanding of the nature of mind. The essays in this volume discuss different aspects of the philosophical theories of mind put forward in the century and a half that followed Descartes' *Meditations* of 1641. These years, often referred to as the 'early-modern' period, are probably unparalleled for originality and diversity in conceiving the mind. Essays on the Concept of Mind in Early-Modern Philosophy

In the 20th century theorists of mind were almost exclusively concerned with various versions of the materialist thesis, but prior to current debates accounts of soul and mind reveal an extraordinary richness and complexity which bear careful and impartial investigation. This book is the first single-authored, comprehensive work to examine the historical, linguistic and conceptual issues involved in exploring the basic features of the human mind - from its most remote origins to the beginning of the modern period. MacDonald traces the development of an armature of psychical concepts from the Old Testament and Homer's works to the 18th century advocacy of an empirical science of the mind. Along the way, detailed attention is paid to the Presocratics, Plato, Aristotle, the Stoics and Epicurus, before turning to look at the New Testament, Neoplatonism, Augustine, Medieval Islam, Aquinas and Dante. History of the Concept of Mind

Gilbert Ryle's 1949 *The Concept of Mind* is now famous above all as the origin of the phrase "the ghost in the machine" – a phrase Ryle used to attack the popular idea that our bodies and minds are separate. His own position was that mental acts are not at all distinct from bodily actions. Indeed, they are the same thing, merely described in different ways – and if one cuts through the confusing language of the old philosophical debates, he suggests, that becomes clear. While, in many ways, modern philosophers of mind have moved on from or discarded Ryle's actual arguments, *The Concept of Mind* remains a classic example of two central critical thinking skills: interpretation and reasoning. Ryle was what is known as an "ordinary language" philosopher – a school who considered many philosophical problems to exist purely because of philosophical language. He therefore considered his task as a philosopher to be one of cutting through confusing language, and clarifying matters – exemplifying the critical thinking skill of interpretation at its best. Rather than adding to philosophical knowledge as such, moreover, he saw his role as one of mapping it – giving it what he called a "logical geography." As such, *The Concept of Mind* is also all about reasoning: laying out, organizing, and systematizing clear arguments.

An Analysis of Gilbert Ryle's *The Concept of Mind*

The modern materialist approach to life has conspicuously failed to explain such central mind-related features of our world as consciousness, intentionality, meaning, and value. This failure to account for something so integral to nature as mind, argues philosopher Thomas Nagel, is a major problem, threatening to unravel the entire naturalistic world picture, extending to biology, evolutionary theory, and cosmology. Since minds are features of biological systems that have developed through evolution, the standard materialist version of evolutionary biology is fundamentally incomplete. And the cosmological history that led to the origin of life and the coming into existence of the conditions for evolution cannot be a merely materialist history, either. An adequate conception of nature would have to explain the appearance in the universe of materially irreducible conscious minds, as such. Nagel's skepticism is not based on religious belief or on a belief in any definite alternative. In *Mind and Cosmos*, he does suggest that if the materialist account is wrong, then principles of a different kind may also be at work in the history of nature, principles of the growth of order that are in their logical form teleological rather than mechanistic. In spite of the great achievements of the physical sciences, reductive materialism is a world view ripe for displacement. Nagel shows that to recognize its limits is the first step in looking for alternatives, or at least in being open to their possibility.

Racing to Win

Gilbert Ryle developed his theory of mind in his book "The Concept of Mind" (1949) against the Cartesian dualism. The official doctrine is mainly originates from Ren Descartes "mind-body dualism". Concerning the official doctrine, I aspire to elucidate two main aspects: Firstly, I will epitomize important aspects of mind-body "parallelism". More precisely, I will illustrate, taking into account the official doctrine, that mind and body are two separate entities. Secondly, I will illustrate mind-body "interactionalism".

Aristotle's Concept of Mind

A comprehensive proposal for a conceptual framework for describing conscious experience in dreams, integrating philosophy of mind, sleep and dream research, and interdisciplinary consciousness studies. Dreams, conceived as conscious experience or phenomenal states during sleep, offer an important contrast condition for theories of consciousness and the self. Yet, although there is a wealth of empirical research on sleep and dreaming, its potential contribution to consciousness research and philosophy of mind is largely overlooked. This might be due, in part, to a lack of conceptual clarity and an underlying disagreement about the nature of the phenomenon of dreaming itself. In *Dreaming*, Jennifer Windt lays the groundwork for solving this problem. She develops a conceptual framework describing not only what it means to say that dreams are conscious experiences but also how to locate dreams relative to such concepts as perception, hallucination, and imagination, as well as thinking, knowledge, belief, deception, and self-consciousness. Arguing that a conceptual framework must be not only conceptually sound but also phenomenologically plausible and carefully informed by neuroscientific research, Windt integrates her review of philosophical work on dreaming, both historical and contemporary, with a survey of the most important empirical findings. This allows her to work toward a systematic and comprehensive new theoretical understanding of dreaming informed by a critical reading of contemporary research findings. Windt's account demonstrates that a philosophical analysis of the concept of dreaming can provide an important enrichment and extension to the conceptual repertoire of discussions of consciousness and the self and raises new questions for future research.

Phenomenology and Ontology

Aspects of Mind contains previously unpublished manuscript material by Gilbert Ryle along with notes taken by the editor, Rene Meyer, at lectures given by Ryle on the philosophy of mind in 1964. Gilbert Ryle, Waynflete Professor of Metaphysical Philosophy at the University of Oxford from 1945 until 1967, had a decisive influence on contemporary philosophy. His *Concept of Mind* (1949) not only put a methodological edge in a most readable way to what has become known as Analytical Philosophy, but it also stimulated interest in the philosophy of mind as a pivotal part of philosophy as a whole. A second important influence derives from his reorganization of philosophical studies at Oxford after the war which made it, for several years, one of the liveliest philosophical centres in the world. Ryle's interest covered almost the entire field of philosophy. He also made substantial contributions to the history of philosophy, notably on Plato, Locke, Hume, Husserl and Heidegger. Gilbert Ryle died in October 1976. The book also includes two tributes to Ryle; one from John Mabbott, a close friend, on Ryle the man, and one from David Gallop, an ex-student, on Ryle the Philosopher. A chapter entitled "Philosophy, Logical Geography and Dilemmas" by Rene Meyer provides a perspective on Ryle's philosophy.

Ryle Vs. Official Doctrine on how to Explain an Intentional Action

Gentile's philosophy is on the one hand unexpectedly simple, but on the other somewhat difficult to understand for those who are not well versed with German and Italian idealism. Gentile follows a certain current in Italian philosophy based on a "Fichte-ised" Hegel, but carries it to its extremes. For Gentile, the transcendental point of view is found in the reality of our thought when thought is considered not as a completed act but as an act-in-act, so to speak. This is probably the leit-motiv of Gentile's philosophy: the radical negation of the proposition that one can detach oneself from one's thought, even thoughts already thought. Thought is always in action, what he called "autoctisis". This is the first book in which Gentile's philosophy appears. Gentile's contribution to philosophy is not only important because of its originality but also because Gentile was Fascism's philosopher and his legacy is still felt today.

Dreaming

According to Thomas Metzinger, no such things as selves exist in the world: nobody ever had or was a self. All that exists are phenomenal selves, as they appear in conscious experience. The phenomenal self, however, is not a thing but an ongoing process; it is the content of a "transparent self-model." In *Being No One*, Metzinger, a German philosopher, draws strongly on neuroscientific research to present a representationalist and functional analysis of what a consciously experienced first-person perspective actually is. Building a bridge between the humanities and the empirical sciences of the mind, he develops new conceptual toolkits and metaphors; uses case studies of unusual states of mind such as agnosia, neglect, blindsight, and hallucinations; and offers new sets of multilevel constraints for the concept of consciousness. Metzinger's central question is: How exactly does strong, consciously experienced subjectivity emerge out of objective events in the natural world? His epistemic goal is to determine whether conscious experience, in particular the experience of being someone that results from the emergence of a phenomenal self, can be analyzed on subpersonal levels of description. He also asks if and how our Cartesian intuitions that subjective experiences as such can never be reductively explained are themselves ultimately rooted in the deeper representational structure of our conscious minds.

Aspects of Mind

This book introduces students to the principal issues in the philosophy of mind by tracing the history of the subject from Plato and Aristotle through to the present day. Over forty primary-source readings are included. Extensive commentaries from the editors are provided to guide student readers through the arguments and jargon and to offer necessary historical context for the readings. The new third edition examines some of the most exciting recent developments in the field, including advances in theories about the mind's relation to action and agency. Previous editions of this book, published under the title *A Historical Introduction to the Philosophy of Mind*, have been praised and widely taught for more than two decades.

Self-consciousness and awareness of others, Musholt argues, are two sides of the same coin. After surveying the philosophical problem of self-consciousness, the notion of nonconceptual content, and various proposals for the existence of nonconceptual self-consciousness, Musholt argues for a non-self-representationalist theory, according to which the self is not part of the representational content of perception and bodily awareness but part of the mode of presentation. She distinguishes between implicitly self-related information and explicit self-representation, and describes the transitions from the former to the latter as arising from a complex process of self–other differentiation. By this account, both self-consciousness and intersubjectivity develop in parallel.
