The Lebanese Forces

State sponsorship of terrorism is a complex and important topic in today's international affairs - and especially pertinent in the regional politics of the Middle East and South Asia, where Pakistan has long been a flashpoint of Islamist politics and terrorism. In Islamism and Intelligence in South Asia, Prem Mahadevan demonstrates how over several decades, radical Islamists, sometimes with the tacit support of parts of the military establishment, have weakened democratic governance in Pakistan and acquired progressively larger influence over policy-making. Mahadevan traces this history back to the anti-colonial Deobandi movement, which was born out of the post-partition political atmosphere and a rediscovery of the thinking of Ibn Taymiyyah, and partially ennobled the idea of 'jihad' in South Asia as a righteous war against foreign oppression. Using Pakistani media and academic sources for the bulk of its raw data, and reinforcing this with scholarly analysis from Western commentators, the book tracks Pakistan's trajectory towards a `soft' Islamic revolution. Envisioned by the country's intelligence community as a solution to chronic governance failures, these narratives called for a re-orientation away from South Asia and towards the Middle East. In the process, Pakistan has become a sanctuary for Arab jihadist groups, such as Al-Qaeda, who had no previous ethnic or linguistic connection with South Asia. Most alarmingly, official discourse on terrorism has been partly silenced by the military-intelligence complex. The result is a slow drift towards extremism and possible legitimation of internationally proscribed terrorist organizations in Pakistan's electoral politics.

Emphasis is placed on the influence the proper authority principle has had in the human rights based approach being favored when dealing with "criminal" non-State actors during both international and non-international armed conflict. Part III analyzes the threats of insurgency and terrorism, and the state response. This includes exploring their link to criminal activity and the phenomenon of transnational criminal organizations. Part IV addresses the conduct of operations against non-State actors that span the conflict spectrum from inter-state warfare to international law enforcement. Lastly, Part V looks at the way ahead and discusses the approaches that can be applied to address the evolving, diverse and unique security threats facing the international community.

The Reagan Era

When the United States sent a fleet to the Gulf, raising the Stars and Stripes over Kuwait's commercial tankers, a tinderbox was set off. The Iranians laid mines throughout the narrow passage and launched attack boats against both tankers and US warships. The US Navy fought its largest surface battle since World War II against the Ayatollah's assault boats. As Saddam Hussein looked on, Iranian gunners fired missiles against US forces—actions which, if made known at the time, would have required the US Congress to declare war against Iran.

Fighting at the Legal Boundaries

Intelligence, surveillance and reconnaissance (ISR) is today a core capability for the modern military, in peacetime and in war. ISR is and will remain a key enabler in the Gulf region in ongoing conflicts. There is still a reliance on the United States, and its ISR systems deployed in the Gulf, to facilitate ongoing operations and to provide situational awareness at the tactical, operational and strategic levels. However, even US ISR is finite, and there is growing demand for its resources in other regions. The Gulf Cooperation Council states have some ISR capacity, but this needs further development and improved exploitation to better address regional needs. Written by a team of IISS specialists, ISR & the Gulf: An Assessment considers the meaning of and requirement for intelligence, surveillance and reconnaissance in the context of the region. It examines the military needs and industrial aspirations of the Gulf Arab states regarding ISR, and the opportunities and risks these present. The report is a companion work to the Institute's Missile-Defence Cooperation in the Gulf, and is similarly intended to help provide the basis for informed decision-making to support improved security in the region.

United States Relations with China and Iran

In the eighty years since Pearl Harbor, the United States has developed a professional intelligence community that is far more effective than most people acknowledge--in part because only intelligence failures see the light of day, while successful collection and analysis remain secret for decades. Intelligence and the State explores the relationship between the community tasked to research and assess intelligence and the national decision makers it serves. The book argues that in order to accept intelligence as a profession, it must be viewed as a non-partisan resource to assist key players in understanding foreign societies and leaders. Those who review these classified findings are sometimes so invested in their preferred policy outcomes that they refuse to accept information that conflicts with preconceived notions. Rather than demanding that intelligence evaluations conform to administration policies, a wise executive should welcome a source of information that has not "drunk the Kool-Aid" by supporting a specific policy decision. Jonathan M. House offers a brief overview of the nature of national intelligence, and especially of the potential for misperception and misunderstanding on the part of executives and analysts. Furthermore, House examines the rise of intelligence organizations first in Europe and then in the United States. In those regions fear of domestic subversion and radicalism drove the need for foreign surveillance. This perception of a domestic threat tempted policy makers and intelligence officers alike to engage in covert action and other policy-based, partisan activities that colored their understanding of their adversaries. Such biases go far to explain the inability of Nazi Germany and the Soviet Union to predict and deal effectively with their opponents. The development of American agencies and their efforts differed to some degree from these European precedents but experienced some of the same problems as the Europeans, especially during the early decades of the Cold War. By now, however, the intelligence community has become a stable and effective part of the national security structure. House concludes with a historical examination of familiar instances in which intelligence allegedly failed to warn national leaders of looming attacks, ranging from the 1941 German invasion of the USSR to the Arab surprise attack on Israel in 1973.

ISR and the Gulf

This provocative examination of major controversies in military history enables readers to learn how scholars approach controversial topics and provides a model for students in the study and discussion of other historical events. Why did Alexander the Great's empire fall apart so soon after his death? How did France win the Hundred Years War despite England winning its major battles? Was slavery the primary cause of the American Civil War? Would it have benefited the Allies militarily to have gone to war against Germany in 1938 rather than in 1939? Should women be allowed to serve in combat positions in the U.S. military? All of these questions and many other historical controversies are addressed in this thought-provoking reference book. By exploring every angle of some of the most contentious debates involving military history, this book builds students' critical thinking skills by supplying a complete background of the controversial topic to provide context, and also by providing multiple perspective essays written by top scholars in the field. Readers will consider the cases for and against whether Hannibal should have marched on Rome after his momentous victory at Cannae, whether the United States was justified in using the atomic bomb in Japan, whether Adolf Hitler was primarily responsible for the Holocaust, and whether torturing prisoners during the War on Terror is warranted, among many other historical military debates.

Intelligence and the State

How three key figures in Moscow, Beijing, and Tehran built ruthless irregular warfare campaigns that are eroding American power. In Three Dangerous Men, defense expert Seth Jones argues that the US is woefully unprepared for the future of global competition. While America has focused on building fighter jets, missiles, and conventional warfighting capabilities, its three principal rivals—Russia, Iran, and China—have increasingly adopted irregular warfare: cyber attacks, the use of proxy forces, propaganda, espionage, and disinformation to undermine American power. Jones profiles three pioneers of irregular warfare in Moscow, Beijing, and Tehran who adapted American techniques and made huge gains without waging traditional warfare: Russian Chief of Staff Valery Gerasimov; the deceased Iranian Maior General Qassem Soleimani: and vice chairman of China's Central Military Commission Zhang Youxia. Each has spent his career studying American power and devised techniques to avoid a conventional or nuclear war with the US. Gerasimov helped oversee a resurgence of Russian irregular warfare, which included attempts to undermine the 2016 and 2020 US presidential elections and the SolarWinds cyber attack. Soleimani was so effective in expanding Iranian power in the Middle East that Washington targeted him for assassination. Zhang Youxia presents the most alarming challenge because China has more power and potential at its disposal. Drawing on interviews with dozens of US military, diplomatic, and intelligence officials, as well as hundreds of documents translated from Russian, Farsi, and Mandarin, Jones shows how America's rivals have bloodied its reputation and seized territory worldwide. Instead of standing up to autocratic regimes, Jones demonstrates that the United States has largely abandoned the kind of information, special operations, intelligence, and economic and diplomatic action that helped win the Cold War. In a powerful conclusion, Jones details the key steps the United States must take to alter how it thinks about—and engages in—competition before it is too late.

Tehran at Twilight

With lucid analysis and engaging storytelling, USA Today senior diplomatic correspondent Barbara Slavin portrays the complex love-hate relationship between Iran and the United States. She takes into account deeply imbedded cultural habits and political goals to illuminate a struggle that promises to remain a headline story over the next decade. In this fascinating look, Slavin provides details of thwarted efforts at reconciliation under both the Clinton and Bush presidencies and opportunities rebuffed by the Bush administration in its belief that invading Iraq would somehow weaken Iran's Islamic government. One of the few reporters to interview Iranian president, Mahmoud Ahmadinejad, as well as his two predecessors and scores of ordinary Iranians, Slavin gives insight into what the U.S. government may not be taking into account. She portrays Iran as a country that both adores and fears America and has a deeply rooted sense of its own historical and regional importance. Despite government propaganda that portrays the U.S. as the "Great Satan," many Iranians have come to idolize staples of American pop culture while clinging to their own traditions. This is clearly not a relationship to be taken a face value. The interplay between the U.S. and Iran will only grow more complex as Iran moves toward becoming a nuclear power. Distrustful of each other's intentions yet longing at some level to reconcile, neither Tehran nor Washington know how this story will end.

Empire of Terror

This is the real story of how George W. Bush came to double-down on Iraq in the highest stakes gamble of his entire presidency. Even a president at war is bound by rules of consensus and limited by the risk of constitutional crisis. What is to be achieved in the warzone must also be possible in Washington, D.C. Bush risked losing public esteem and courted political ruin by refusing to disengage from the costly war in Iraq. The Last Card is a portrait of leadership—firm and daring if flawed—in the Bush White House. This book is a major reinterpretation of the Iran-Iraq War and is a source for reexamining the U.S. involvement in the Gulf. Pelletiere demonstrates that the war was not a standoff in which Iraq finally won a grinding war of attrition through luck, persistence, and the use of poison gas. Instead, Iraq planned the last campaign almost two years prior to its unfolding. [The Iraqis] trained extensively and expended enormous sums of money to make their effort succeed. What won for them was their superior fignting prowess and greater commitment. Gas--if it was used at all--played only a minor part in the victory.' Pelletiere concludes that the key to understanding the war is the Extraordinary Congress of the Ba'th Party held in July 1986. It was there that the initial planning for the final campaign was done, and this campaign is what decided the fate of the conflict. The study centers around the last Iraqi campaign, which Pelletiere argues was based upon World War II blitzkrieg tactics, but he also treats the background, the politics, and the history of the conflict, and analyzes the significance of the war to the Middle East and to the position of the United States there.
