Delving deeply into the many layers of meaning within the "Gospel of Signs"--the first 11 chapters of the Fourth Gospel which describe seven of Jesus' miracles--he shows how Mary's teachings outline seven key steps for personal transformation and profound healing. For example, the sixth sign describes the shamanic healing of a blind man when Jesus spits on clay and smears the paste over the man's eyes. Angelo explains how the deeper meaning of this sign is about perceiving with the "eyes of the heart." Beyond the beauty and simplicity of Mary's wisdom for personal transformation and healing, Angelo also shows how Mary's heart-centered teachings embody the resurgence of feminine energy that is vitally needed to restore balance to the psyche and health of humanity as well as to Earth.

# Scripture Windows

As a dominant voice in our society, Western Christianity (including fundamentalism) is dying despite the growing tendency of people to identify as spiritual but not religious. In the face of this reality, churches continue to preach the same message of sin, judgment, guilt, in order to be saved, or in the case of more progressive churches, feel-good messages. No wonder Western Christianity is failing. If it is ever to regain its viability, Christianity must rethink its total devotion to Christ and look again at its roots. A new Christianity must start over with the original vision of God's dream for us as expressed by Moses and Jesus. Jesus was not a Christian. He was a Jewish reformer and he worked within the context of the Jewish Scriptures (the Old Testament). Deuteronomy was one of these books. When this ancient wisdom is paired with post-modern Christianity we see that the teachings of Moses and Jesus are as relevant today as they were two to three thousand years ago, perhaps even more so.

### The Book of Deuteronomy and Post-modern Christianity

This book, an examination of Judaism as it evolved over a period of approximately 1,500 years, is an analysis of the Hebrew Bible and other ancient Jewish writings, with special emphasis on theology and morality. By the middle of the first millennium, with the writing of Deuteronomy, the Psalms, and the works of the prophets, Judaism had embraced the idea that God is a compassionate father; that His relationship with His people is based on love rather than fear; and that His response to their commission of sins is based on the assumption that they are capable of repentance and worthy of forgiveness. In the final stage of its development—culminating in the first and second centuries AD—Judaism was understood to require its adherents to enact the will of God—specifically, to establish a community based on political, economic, and social laws that enforce the principles of justice and mercy. And that process came to be seen as inevitably dependent on human agency—the need for human beings to fulfill God's commandments. In Judaism, loving neighbors (and strangers) came to be understood as the principal—and, for many Jews, the only—way of loving God.

The term 'Judeo-Christian' in reference to a tradition, heritage, ethic, civilization, faith etc. has been used in a wide variety of contexts with widely diverging meanings. Contrary to popular belief, the term was not coined in the United States in the middle of the 20th century but in 1831 in Germany by Ferdinand Christian Baur. By acknowledging and returning to this European perspective and context, the volume engages the historical, theological, philosophical and political dimensions of the term's development. # Rescuing the Bible from Fundamentalism

In the view of many contemporary scholars, both Jesus and Judaism have been misrepresented by the church for the past two thousand years. Their main point is that Judaism was not a superficial, rigid, and outdated religion, and Jesus did not reject it. In fact, along with his disciples, he remained a Law-abiding Jew his entire life. However, as Christianity developed from a Jewish sect in the first century AD to the official religion of the Roman Empire in the fourth century, the church was transformed, Jesus was redefined, and both Jews and their religion were repudiated and marginalized. In short, both Christians and Jews were deeply affected by what many scholars now call the de-Judaization of Jesus. This book is an attempt to correct the traditional theological and scholarly misinterpretations of Jesus and Judaism that emerged over the first four centuries of the life of the church.

### The Great Betrayal

Three conditions plague us individually and socially—the compulsion to be successful, to be powerful, and to be right. Jesus faced these demons in the wilderness, and they tempt us as well. When used selfishly or for personal gain, success, power, and ideology can weaken and corrupt. However, when applied humbly and compassionately, they can be useful, even transformative. Central to the Christian Scriptures are the stories of Jesus and his disciples, and no account is more inspiring than that told by an anonymous author we call Luke. His Gospel, aptly described as "the most beautiful book in the world," and its sequel, the book of Acts, narrate the history of Jesus and early Christianity. These books, known by scholars as Luke-Acts, constitute over one quarter of the New Testament. Together they reveal what success, power, and truth look like spiritually, from God's perspective. Because Luke does not "do theology" in a vacuum, that is, for the sake of theology alone, questions of Luke's purpose in composing his two-volume work impact Christianity's relationship to the secular world, particularly issues of peace, equality, and social justice. In fact, social and political categories may be as important for understanding Luke as traditional theological ones. While exploring fascinating perspectives on Luke as historian, literary artist, and theologian, Power Revealed approaches Luke-Acts exegetically, expositing the biblical text for practical, pastoral, and spiritual needs. Useful for individual or group study. each chapter contains aids to learning, including (a) chapter summaries or outlines, (b) homework assignments, and (c) learning objectives.

#### Power Revealed

Jesus was murdered by the Jewish religious leaders whose power base was the temple of Jerusalem. Saul of Tarsus—later the Paul of Christianity—was one of these, and his brand of faith theology mirrored their theology of covenantal entitlement. Thus, Christianity's basic theological principles derive from those who killed Jesus. This is just one of many challenging propositions backed with strong evidence that appear in this book. Jesus, like most Jews, was attuned to faithfulness rather than pure faith, to ethical behavior based on human empathy rather than metaphysical beliefs and rituals. The central focus of Jesus was hesed, the heart of the Jewish covenant with God which linked God's mercy to human compassion and forgiveness, making both mutually interactive. This hesed forgiveness was anathema to the temple's faux forgiveness and threatened its very existence. Therefore, Jesus came not to save us, but to show us how to save ourselves. Reinterpreting a key parable of Jesus in this light, the Parable of the Tares, Jesus can be most plausibly understood as an incarnation of Adam, the original prototype human who God, in Genesis, appointed to oversee his creation and guide our spiritual evolution. His mission was not about any sacrificial death, but about establishing the spiritual humanism of Judaic hesed as the central purpose of human existence.

#### **Bad Faith**

### The Bible Reading of Young Evangelicals

Young evangelicals in Britain often find themselves at odds with an increasingly secular society, and yet the tradition persists and in some places flourishes. Sociological studies into the faith of this demographic group are rare, yet there is much to be explored as to how their faith functions and how

it compares to other groups globally. Similarly, given the privilege evangelicals afford the biblical text, how young believers engage with the ancient Scriptures they understand to be "the word of God" is particularly significant. This work addresses that core question. How do young evangelicals make sense of the Bible today? Based on qualitative data gathered from three diverse evangelical churches it compares the reading priorities, ordinary hermeneutics, and theological concerns of young adults. Presenting age-related focus groups with challenging biblical narratives, the study compares strategies for negotiating the texts based on age, gender, and churchmanship. It provides a unique insight into the realities of Bible reading and the faith of "Generation Y" and gives food for thought not only to those with scholarly interests, but also those with a pastoral concern to shape and sustain the Christian faith of young adults in Britain and beyond.

# The Early Christian Community

Douglas A. Hume offers a narrative ethical reading of the passages depicting the early Christian community in Acts (2:41-47 and 4:32-35). He begins with a methodological exploration of how contemporary scholars may examine the impact of biblical narratives upon reader's moral imaginations. Given the presence of friendship language in Acts, the work subsequently launches into an examination of this idiom in Greco-Roman philosophical and literary works by Aristotle, Plutarch, Diogenes Laertius, and lamblichus. The author then proceeds to an exegetical examination of how friendship language is employed by Luke in the narrative summaries of Acts. This ethical reading of the Acts 2:41-47 and 4:32-35 incorporates multiple features of narrative criticism and asks such wide ranging questions as the use of emotion, point of view, and characterization to shape the reading audience's perception of God, the early Christian community, and other characters within the story of Luke-Acts. This study has implications for biblical studies, practical theology, and contemporary understandings of ecclesiology.

# Pilgrim's Process

This book traces the intellectual journey of a Christian minister and theologian. Starting with his discovery of God through a love of the natural world, David Peel's encounter with thinkers from his Reformed tradition and extensive ecumenical involvement takes him to a revisionary theology which meets his attempt to integrate a scientific background with the Christian faith. Essays written during his career illustrate the path he has taken. The topics covered include theological method; the centrality of theology for the church's life and work; a sacramental view of ministry; the missional church; biblical authority; nonconformity's gifts to the contemporary church; and theological education.
