In the aftermath of World War I, the "Great War," the nations of the world tended to retreat inside themselves, to lick their wounds and reorganize their economic and social structures. The United States, relatively untouched by the first world war, at least in comparison with the losses suffered by the European nations, also turned inward. In America, the Roaring Twenties were a time of great excitement - bathtub gin, speakeasies, new dress styles, a revolution in manners and morals, the Harlem Renaissance, a golden age of sports, radios, movies, and a booming stock market. Toward the end of the decade came the great stock market crash which, although it was not the cause of the Depression, helped trigger a series of events that led to the worst economic slump in American history. Into such milieu came Franklin Delano Roosevelt, fifth cousin of progressive President Theodore Roosevelt, and a man who had suffered a serious personal tragedy when he contracted polio. He overcame his disease and was elected twice as governor of New York and came to Washington in 1933 ready to do battle with the forces of depression. Roosevelt's New Deal was a huge experiment in government intervention in the economy, and although they did not end the Depression, Roosevelt's policies gave hope to many and changed the relationshi

In this Volume, the various measures taken by successive Administrations to fully utilize the new-found potential are examined critically. These include the Smoot-Hawley Tariff Act of 1930, the National Industrial Recovery Act of 1933 and the National Labor Relations Act of 1935. While the passage of time has perhaps dulled the memory and effect the men and women detailed herein contributed to the culture of the United States, either in positive or negative ways, the retelling of their stories help us determine where we come from and hopefully, who we are.

Flappers, flag-pole sitting, and the Ford Model T--these are just a few of the things that instantly conjure up a unique era--the Roaring Twenties. It was the bees' knees, the cat's meow. A born and bred working-class Midwesterner, his story intersects urgently and meaningfully with those of the de-industrialization of middle America, the US's reckoning with Second Amendment rights and gun culture in the wake of mass shootings, the attack on the Twin Towers and the American launch of the so-called "War on Terror," and most of the other major political milestones of the last three decades. Along the way, Lachowsky folds in a searing critique of American imperialism, the dominance of US media and government by liberal elites, the same government's abandonment of American veterans and the working class, and a number of challenging, idiosyncratic takes on race, gender, and power relations that readers are unlikely to have encountered anywhere else. Ultimately, Lachowsky's is a story of persevering against the odds, and it should bolster the spirit of anyone who feels the world is trying to keep them down.
