Costa nostra : la realidad de la mafia en la Costa del Sol

En 2013 se cumplieron tres siglos de la firma del Tratado de Utrecht por el que Gibraltar fue declarado posesión británica. A pesar de los intentos por recuperarlo, el Peñón continúa estando bajo el manto de armiño de la Corona Británica. Con apenas cuatro kilómetros de largo, una superficie de 584 hectáreas y una población de poco más de 30.000 habitantes, Gibraltar es, hoy como ayer, un 'melting pot' en la que conviven distintas nacionalidades, culturas y religiones, otorgando a sus habitantes, los yanitos, una condición mestiza ante la vida que nuclea su identidad colectiva. *Includes pictures *Includes a bibliography for further reading The word "mafia," Sicilian in origin, is synonymous with Italy, but Italy is home to several different mafias, with three being particularly notorious. While the Cosa Nostra of western Sicily is the most infamous, other powerful groups include the ferocious 'Ndrangheta of Calabria and the Camorra, the third-largest mafia, which is active in Naples and the Campania region. A "mafia" is loosely defined as a criminal organization that is interested in social, economic and political power, combining elements of a traditional secret society with those of a business, but further levels of nuance are necessary in order to understand these groups. In a general sense, this is because each mafia creates a myth about the development of the organization, which

becomes like an unquestionable truth. In essence, part of what makes its members so completely loyal to it is also what makes outsiders so utterly afraid of it. Over the course of the 19th century, the people of Sicily found themselves at the center of a struggle for freedom, one that ended up being long and often very bloody. It was during these crucial years of struggle that the Sicilian mafia, La cosa nostra ("Our thing"), started to take shape. The original word "mafia" was a part of Palermitan slang, and although the origins of the word are not completely certain, some linguistic historians believe it originally meant "flashy." One historian of the mafia, Salvatore Lupo, helpfully suggests that it was used in its earliest iterations to vaguely refer to a "pathological relationship among politics, society and criminality." In the particular case of the Camorra, the difficulty of understanding an underground criminal association is made all the more intense because it is so heterogeneous in terms of its development, its different functions, and the diversity of economic sectors in which it operates. To reflect that diversity, some scholars like to refer to it as Camorre, the plural version of Camorra. This decision is more than just a question of semantics, because using the plural form helps emphasize the internal differences and conflicts within the Neapolitan mafia, which, in turn, helps explain the very nature of the organization itself. The Neapolitan mafia is famous for its pervasive nature, which is due to the fact that it is organized in a horizontal, decentralized way. This means there is not one single "boss" who dictates policy and can be more strategic in how and when violence is deployed. Unlike other mafias, in the Camorra there has been no long-term reigning family, nor extensive coordination between families to form an alliance and function as a unified mafia for their shared benefit. The 'Ndrangheta (pronounced an-drang-et-ah) is a close neighbor of the Cosa Nostra and currently considered the most powerful (and difficult to spell) criminal organization in Italy. The 'Ndrangheta is centered around Calabria, the most southwestern region of Italy, almost touching the Sicilian city of Messina. Though it began as far back as the late 19th century, it was not until the 1950s that the 'Ndrangheta started to spread its tentacles throughout Italy and then across the entire globe, forming an empire that now ranges from Australia and Turkey to Chile to Canada. The fact that the 'Ndrangheta is overshadowed by the Sicilian Cosa Nostra, as well as by the Neapolitan mafia, the Camorra, allowed it to grow and develop outside of the public eye. For years, people actually considered the Calabrian mafia to be part of the Cosa Nostra as a mere appendage, rather than its own entity. This false belief was perpetuated by the high-profile Sicilian pentito, Tommaso Buscetta, and it was not until the beginning of the 21st century that the 'Ndrangheta came into the public eye due to two dramatic killings, the assassination of a politician and the "Duisburg massacre."

Delincuencia organizada

The organized crime group that dominates much of the socioeconomic life of contemporary Naples, the Camorra, is organized by kin and geography, and it is notoriously the most violent, fractious, and disorganized mafia in Italy. The Camorra controls local extortion rackets, the drug and counterfeit trades, and other legal and illicit activities as well as wielding substantial political influence throughout Naples and its environs. Felia Allum has been researching the Camorra for twenty years, and in *The Invisible Camorra* she reveals a surprising alteration in Camorra behavior when operatives live outside the Neapolitan base. When gang members move away from Naples, having been forced out by intense policing and gang competition, they are attracted by business opportunities that, on the whole, fit in with their usual activities. When they move to other parts of Western Europe and are therefore no longer criminals simply by virtue of "mafia association" as they are in Italy, they become largely invisible. Gang members avoid the spectacular deployment of violence, they merge quietly into local life, they keep themselves to themselves, and, when necessary, use legitimate local actors such as lawyers and accountants to further their economic well-being. Allum has constructed a meticulous description and analysis of Camorra activities abroad. To build accounts of the Camorra in Germany and the Netherlands, France, Spain, and the United Kingdom, she has interviewed investigating magistrates, police officers, and confessed criminals; done substantial mining of Italian and European police data; and made extensive use of judicial investigations, court records and transcripts as well as of journalistic accounts. The result is the first systematic analysis of the overseas activities of this major criminal organization.

The Invisible Camorra

El rigor profesional de magistrados e investigadores es el factor esencial para que la mafia comprenda que Sicilia no es el patio de su casa y servirá por tanto para neutralizar la insolencia y arrogancia del mafioso ante la autoridad del Estado. Puedo afirmar que el mejor resultado alcanzado a partir de las investigaciones practicadas en Palermo en los últimos diez años se ha fundado precisamente en privar a la mafia de su aura de impunidad e imbatibilidad. Incluso aunque los condenados del macrojuicio sean puestos en libertad, se habrá logrado un resultado: que la mafia sepa que puede ser conducida a los tribunales y que sus capos pueden ser condenados. Los resultados sólo llegan con un compromiso férreo, constante, diario. Sin jactancias ni diletantismo. En la medida en que la batalla que libramos es una guerra auténtica con sus muertos y heridos, debe combatirse con el mayor empeño y seriedad. Los que han frivolidado o querido pasar por luchadores sin serlo han acabado pagándolo, en muchos casos dejándose la vida en ello. El juez Giovanni Falcone nació el 18 de mayo de 1939 en el seno de una familia de la burguesía palermitana que residía en el centro histórico de la capital siciliana. Allí creció respirando la misma atmósfera de clientelismo, favores, extorsión y tacitismo en la que se formaron muchos de los hombres a los que se vería obligado a interrogar y encarcelar a lo largo de su carrera judicial. Esta carrera judicial, pues, y el éxito con que completó algunos de los procesos más importantes en la lucha contra la criminalidad organizada en Italia arraigaban en la familiaridad que compartía con sus enemigos por los códigos y sobreentendidos mafiosos, por las señales y los silencios, y que le permitió investigar el fenómeno mafioso con una acuidad e ingenio (y capacidad de trabajo) sin parangón. Después de sus primeras experiencias profesionales en Lentini y Trapani, fue trasladado a Palermo tras el atentado contra el juez Cesare Terranova (25 de septiembre de 1979). Su actividad en la capital le fue progresivamente concienciando de la necesidad de acometer investigaciones patrimoniales y bancarias que completasen una visión orgánica de la Cosa Nostra —su funcionamiento, enlaces, jerarquía— para llevar a buen puerto indagaciones que no pocas veces terminaban con un veredicto absolutorio. Tras su integración en el llamado pool antimafia, junto con su colega Paolo Borsellino, en 1984 se produce un vuelco en las investigaciones sobre la mafia siciliana: Tommaso Buscetta, «el rey de los dos mundos», se entrega a la justicia para colaborar en el desmantelamiento de la organización. Gracias a sus declaraciones y a las de otros «arrepentidos», el 16 de diciembre de 1987 el tribunal de Palermo culmina con éxito el llamado «macrojuicio» contra la cúpula de la mafia isleña. Con todo, el juez no deja de recordar las palabras de advertencia que en su día le dirigiera Buscetta: «Usted acaba de abrir una cuenta con la Cosa Nostra que sólo se cerrará con su muerte». Durante las vacaciones veraniegas de 1989 sufre un atentado sin consecuencias en una villa alquilada junto al mar en el pueblo de Addaura. Ello no impide que en esos años y en los sucesivos trabaje de manera fructífera, tanto en Italia como en EE.UU. (en alguna ocasión con el

entonces fiscal Rudolph Giuliani), para desbaratar el tráfico de heroína en manos de familias sicilianas, que en la segunda mitad de los ochenta controlaban el treinta y cinco por ciento de dicho comercio, y, en consecuencia, el frenético enriquecimiento ilegal del crimen organizado en Sicilia durante aquellos años. Sus logros y buenos resultados vuelan con él por los aires el 23 de mayo de 1992 con el estallido de mil kilos de explosivo detonados a distancia en el tramo de Capaci de la autopista entre Messina y Palermo.

Cosas de la Cosa Nostra

Using in-depth field research and analysis of case studies, *Mafia Violence: Political, Symbolic, and Economic Forms of Violence in Camorra Clans* focuses attention on the phenomenon of violence performed by Italian organised crime groups, devoting specific attention to the Camorra, which has been responsible since the mid-1980s for almost half of all mafia homicides documented in Italy. The Camorra has acquired increased visibility at an international level due to its intense use of violence and high level of dangerousness, but until now, the study of the different forms of violence implemented by mafias has not received systematic attention at the scientific level. Hence, this book fills this gap by providing a both theoretical and empirical contribution toward the analysis of one of the most unknown – although highly visible and dangerous – dimension of mafias' action. This collection of work by distinguished scholars provides a unique overview of the multifaceted characteristics of violence currently performed by mafia groups in Italy by focusing on specific actors – i.e., Camorra clans – but also other traditional mafia organisations such as Cosa Nostra and 'Ndrangheta; specific contexts – i.e., different territories and different markets, both legal and illegal; and specific practices and performances. Part I takes a diachronic and comparative perspective to provide an overview of mafias' violence during the past 30 years, focusing on the three most prominent criminal organisations active in Italy: Camorra, Cosa Nostra, and 'Ndrangheta. Based on the outcomes of a major project carried out by a research group at the University of Naples Federico II from 2015 to 2017, Part II looks at the use of violence by Camorra clans, incorporating information from case studies, judicial files, law enforcement investigations, wiretappings, interviews with privileged observers, firsthand empirical data, and historical documents and social sciences literature. Using a multi-disciplinary approach drawing from criminology, sociology, history, anthropology, economics, political science, and geography, this book is essential reading for international researchers and practitioners interested in piecing together the full picture of modern organised crime.

Journaliste spécialisé dans les affaires criminelles et la corruption dans le sud de la France, Jean-Michel Verne a notamment publié *Main basse sur Marseille et la Corse* (Nouveau Monde, 2012) et contribué à *l'Histoire secrète de la corruption sous la V^e République* (Nouveau Monde poche, 2016). Il est l'auteur du documentaire "Riviera Nostra" (France 3 Méditerranée, 2017).

Mafias du monde

Over the last twenty years the Camorra of Naples and the surrounding region has risen to a level of strength which rivals that of the Sicilian mafia. "The Camorra" traces the Camorra from its origins in Naples in the mid-nineteenth century to its present dominance of both Naples and the Campania region. "The Camorra" examines the transformation of small time cigarette smugglers of the 1960s into modern international businessmen, often through the use of trial documents and interviews with some key protagonists. Tom Behan places great emphasis on the fact that all major political parties have been involved with the camorra, along with the police, the judiciary, the business community and administrators. Behan argues that the solution to the problem of the Camorra lies not with these forces but with those ordinary people who suffer the consequences of a political and economic system defined as "political criminality."

Riviera Nostra

In *The globalization of crime: a transnational organized crime threat assessment*, UNODC analyses a range of key transnational crime threats, including human trafficking, migrant smuggling, the illicit heroin and cocaine trades, cybercrime, maritime piracy and trafficking in environmental resources, firearms and counterfeit goods. The Camorra

This book provides a comprehensive analysis of the illegal extraction of metals and minerals from the perspectives of organized crime theory, green criminology, anti-corruption studies, and victimology. It includes contributions that focus on organized crime-related offences, such as drug trafficking and trafficking in persons, extortion, corruption and money laundering and sheds light on the serious environmental harms caused by illegal mining. Based on a wide range of case studies from the Amazon rainforest through the Ukrainian flatlands to the desert-like savanna of Central African Republic and Australia's elevated plateaus, this book offers a unique insight into the illegal mining business and the complex relationship between organized crime, corruption, and ecocide. This is the first book-length publication on illegal extraction, trafficking in mined commodities, and ecocide associated with mining. It will appeal to scholars working on organized crime and green crime, including criminologists, sociologists, anthropologists, and legal scholars. Practitioners and the general public may welcome this comprehensive and timely publication to contemplate on resource-scarcity, security, and crime in a rapidly changing world.

The Globalization of Crime

The report seeks to provide an overview of the recent trends in organised crime and the countermeasures taken against it throughout the world. Chapter One gives a general overview of the tendencies and changes displayed by criminal enterprises. The purpose of Chapter Two is to provide an overview of the recent trends of illicit activities within organised crime in various areas in the world (North America, Central and South America, Western Europe, Eastern Europe, Africa and the Gulf States, Asia and Oceania) and the changes in criminal groups which operate at the international level. Chapter Three describes the recent main initiatives taken internationally against organised transnational crime by both governmental and non-governmental organisations (the United Nations, the Council of Europe, the G7/P8, the European Union, the Organisation for Economic Co-operation and Development, the Organisation of American States) as well as other forms of action, such as bilateral agreements. The aim of Chapter Four is to describe national legislation against organised crime, in terms of both substantive legislation and procedural legislation.

Illegal Mining

This volume represents the first attempt to systematically compare organised crime concepts, as well as historical and contemporary patterns and control policies in thirteen European countries. These include seven 'old' EU Member States, two 'new' members, a candidate country, and three non-EU countries. Based on a standardised research protocol, thirty-three experts from different legal and social disciplines provide insight through detailed country reports. On this basis, the editors compare organised crime patterns and policies in Europe and assess EU initiatives against organised crime.

Organised Crime Around the World

Drug Trafficking, Corruption and States is cutting edge research. Garay Salamanca and Salcedo-Albarán, along with their contributing authors help document the transition from economic to political imperatives within transnational drug cartels. The break from the Zetas by La Familia Michoacana is one example contained in their empirical survey. Social Network Analysis is their tool for illuminating the varying dynamics of cartel-state inter-penetration and reconfiguration. In doing so they clearly discern between State Capture (StC) and Co-opted State Reconfiguration (CStR). As the drug wars and criminal insurgencies rage in the Americas and beyond, this seminal framework will facilitate efforts by scholars, law enforcement officials, intelligence analysts and policymakers to understand shifts in sovereignty, and to illuminate the mechanisms of transnational illicit networks and their interaction with the state.

Drug Trafficking, Corruption and States

A "dissident of the gender-sex binary system" reflects on gender transitioning and political and cultural transitions in technoscientific capitalism. Uranus, the frozen giant, is the coldest planet in the solar system as well as a deity in Greek mythology. It is also the inspiration for uranism, a concept coined by the writer Karl Heinrich Ulrich in 1864 to define the "third sex" and the rights of those who "love differently." Following Ulrich, Paul B. Preciado dreams of an apartment on Uranus where he might live beyond existing power, gender and racial strictures invented by modernity. "My trans condition is a new form of uranism," he writes. "I am not a man. I am not a woman. I am not heterosexual. I am not homosexual. I am not bisexual. I am a dissident of the gender-sex binary system. I am the multiplicity of the cosmos trapped in a binary political and epistemological system, shouting in front of you. I am a uranist confined inside the limits of technoscientific capitalism." This book recounts Preciado's transformation from Beatriz into Paul B., but it is not only an account of gender transitioning. Preciado also considers political, cultural, and sexual transition, reflecting on issues that range from the rise of neo-fascism in Europe to the technological appropriation of the uterus, from the harassment of trans children to the role museums might play in the cultural revolution to come. *An Apartment on Uranus* is a bold, transgressive, and necessary book.
