The present volume of the DCLY collects the contributions of the International Conference of the a oeInternational Society for the Study of Deuterocanonical and Cognate Literaturea (ISDCL), held in TA1/4bingen/Germany. The articles on the reception and function of Biblical figures in Deuterocanonical and other Early Jewish Literature are devoted to the question of how the meaning of individual biblical figures changed in Hellenistic times. In a variety of approaches, the religious function of these figures in a period of vast political and cultural changes is analyzed, as well as their role in the process of re-establishing Jewish identity in a time, in which the Jewish people suffered from harsh oppression and lived scattered throughout the world. The attempt to address the question of changing perceptions of Biblical figures as well theologically and historically is a first step on the way towards an integration of the topic in the larger framework of a systematic reviewing of post-Biblical theological developments.

Biblical Figures in Deuterocanonical and Cognate Literature

The volume contains papers read at the International Conference of the ISDCL, held in Budapest in 2015. The contributors explore various aspects of worship as reflected in the literature of Judaism from the Second Temple period to Late Antiquity. The volume provides a fresh reading of various crucial

issues especially within Old Testament Apocrypha and Pseudepigrapha, Rabbinic literature, Gnostic traditions, and the emerging synagogue. Emotions from Ben Sira to Paul

The series Deuterocanonical and Cognate Literature Studies (DCLS) is concerned principally with research into those books of the Greek Bible (Septuagint) which are not contained in the Hebrew canon, and into intertestamentary and early Jewish literature from the period around the 3rd century BCE to the 2nd century CE. The series was launched in 2007 in collaboration with the ""International Society for the Study of Deuterocanonical and Cognate Literature". It provides a logical extension to the Deuterocanonical and Cognate Literature Yearbook, which has been published since 2004.

Human Body in Death and Resurrection

The discovery of Hebrew manuscripts of Ben Sira in the Cairo Genizah has shaped and transformed the interpretation of the book. It is argued here that a proper appreciation of the manuscripts themselves is also essential for understanding this ancient work. Since their discovery 120 years ago and subsequent identification of leaves, attention has been directed to the interpretation of the ancient book, the Wisdom of Ben Sira. Serious consideration should also be given to the Hebrew manuscripts themselves and their particular contributions to understanding the language and transmission of the book. The surprising appearance of a work that was preserved by Christians and denounced by some Rabbis raises questions over the preservation of the book. At the same time, diversity among the manuscripts means that exegesis has to be built on an appreciation of the individual manuscripts. The contributors examine the manuscripts in this light, examining their discovery, the codicology and reception of the manuscripts within rabbinic and medieval Judaism, and the light they throw on the Hebrew language and poetic techniques. The book is essential reading for those working on Ben Sira, the reception of the deuterocanon, and Medieval Hebrew manuscripts.

Prayer from Tobit to Qumran

In our present-day society a oeAngelsa are being talked about more frequently again. But where are the roots of these discourses to be found? How have they developed? The present volume focuses on important sources for the investigation of angelic images within the ancient Near East, Old Testament, early Judaism and early Christianity. Particular emphasis is given to deuterocanonical Old Testament writings. In addition, significant developments with regard to iconography and piety are examined within the fields of Judaism, Christianity and Islam.

Wisdom Poured Out Like Water

This volume contains essays by some of the leading scholars in the study of the Jewish religious ideas in the Second Temple period, that led up to the development of early forms of Rabbinic Judaism and Christianity. Close attention is paid to the cosmological ideas to be found in the Ancient Near East and in the Hebrew Bible and to the manner in which the translators of the Hebrew Bible into Greek reflected the creativity with which Judaism engaged Hellenistic ideas about the cosmos and the creation. The concepts of heaven and divine power, human mortality, the forces of nature, combat myths, and the philosophy of wisdom, as they occur in 2 Maccabees, Ben Sira, Wisdom of Solomon and Tobit, are carefully analysed and compared with Greek and Roman world-views. There are also critical examinations of Dead Sea scroll texts, early Jewish prayers and Hebrew liturgical poetry and how they these adopt, adapt and alter earlier ideas. The editors have included appreciations of two major figures who played important roles in the study of the Second Temple period and in the history and development of the ISDCL, namely, Otto Kaiser and Alexander Di Lella, who died recently and are greatly missed by those in the field.

Discovering, Deciphering and Dissenting

This set of varied and stimulating papers, by an international group of younger as well as senior scholars, examines the manner in which peoplehood was understood by the Jewish communities of the Second Temple period and by the religious traditions that emerged from those communities and later flourished in Christianity and Rabbinic Judaism. The Hebrew and Greek terms for "people" and "nation" and the name "Israel" are closely analyzed, especially in forays into wisdom literature, Jewish apologetic and the Dead Sea Scrolls, and their uses are related to geographical, political and theological developments, as well as statehood, authority and rulership in the Persian world, Hasmonean times and Ptolemaic Egypt. Cosmos and Creation

What Makes a People?

This research requires a review of its a oeenjeux mA(c)thodologiquesa and a more ample and complete a oehistorical approacha seems to be necessary in order to comprehend to which extent the author might have been influenced by his social background. This study presents a comparison between scholars from different areas and with diverse approaches. It paves the way for a thematic assessment of the historical and theological aspects of the Book of Wisdom in order to research its structural unity, its particular historical value and the specific, not granted, theological importance.

Visions of Peace and Tales of War

There has been widespread neglect by scholars of deuterocanonical books, especially those (e.g., Baruch) that are thought to lack originality. This book seeks to address this lacuna by investigating some of the major interpretive issues in Baruchan scholarship. The volume comprises a collection of essays from an international team of scholars who specialise in Second Temple Judaism and Old Testament pseudepigrapha. The Book of Wisdom in Modern Research

Judith tells the story of a beautiful Jewish woman who enters the tent of an invading general, gets him drunk, and then slices off his head, thus saving her village and Jerusalem. This short novella was somewhat surprisingly included in the early Christian versions of the Old Testament and has played an important role in the Western tradition ever since. This commentary provides a detailed analysis of the text's composition and its meaning in its original historical context, and thoroughly surveys the history of Judith scholarship. Lawrence M. Wills not only considers Judith's relation to earlier biblical texts--how the author played upon previous biblical motifs and interpreted important biblical passages--but also addresses the rise of Judith and other Jewish novellas in the context of ancient Near Eastern and

Greek literature, as well as their relation to cross-cultural folk motifs. Because of the popularity of Judith in art and culture, this volume also addresses the book's history of interpretation in paintings, sculpture, music, drama, and literature. A number of images of artistic depictions of Judith are included and discussed in detail.

Studies on Baruch

This volume collects papers written during the past two decades that explore various aspects of late Second Temple period Jewish literature and the figurative art of the Late Antique synagogues. Most of the papers have a special emphasis on the reinterpretation of biblical figures in early Judaism or demonstrate how various biblical traditions converged into early Jewish theologies. The structure of the volume reflects the main directions of the author's scholarly interest, examining the Dead Sea Scrolls, the Apocrypha and Pseudepigrapha, and Late Antique synagogues. The book is edited for the interest of scholars of Second Temple Judaism, biblical interpretation, synagogue studies and the effective history of Scripture.

Deuterocanonical and Cognate Literature - Yearbook 2009

Texts like Genesis 16, 22 and 31 mention an enigmatic figure, the messenger/angel of the Lord'. The identity of God and this angel is merged. The angel is anonymous and speaks with divine authority as if he is God Himself, there being no clear distinction between sender and messenger. The angel accepts being worshipped by men and is acknowledged as divine. This book explores the ambiguous relationship between God and his angel in early Jewish interpretations of Genesis. The study is set in a wider context as part of the development of angelology and concepts of God in early Judaism.

The Orion Center Bibliography of the Dead Sea Scrolls and Associated Literature

In a collection of essays, former students, colleagues and friends of Prof Elna Mouton honour her life, career and scholarly contributions upon her retirement from Stellenbosch University. The various essays interact with Prof Mouton's concern for biblical hermeneutics, ethics and the interactions and connections between the two, ultimately illustrating the width and variety of interest that her work stimulated and which it interacted with.

Turmoil, Trauma and Tenacity in Early Jewish Literature

Mika S. Pajunen contributes both to the understanding of manuscript 4Q381 from the Dead Sea Scrolls and to broader issues related to the reconstruction of damaged scrolls and to the reading of psalms in late Second Temple Judaism. The author focuses especially on the collection of "apocryphal" psalms in 4Q381 and other similar psalm collections, but it is also of interest to the ongoing search for the functions of psalmody in this period. A material reconstruction of manuscript 4Q381 has been made to determine the original placement of all the substantial fragments within the scroll. The reconstruction shows there to be eight psalms in the preserved scroll. A thorough analysis of all of them is incorporated in this study, including a critical Hebrew text and the first English translation of the psalms, a basic outline of the psalms' content with comments on their details, and a presentation of their overall message. All the psalms in 4Q381 discuss specific periods of time. The first three psalms cover a period from the Creation to the expected future of a group identified as God's chosen ones. These are followed by five pseudepigraphic psalms that are named in this study as Praise of the Man of God (David), Praise of Hezekiah, Penitential Prayer of Manasseh, Lament of Josiah, and Penitential Prayer of Jehoiachin. The psalms in 4Q381 make up a consistent whole that is shown to function as a unified lesson on the justice of God toward his elect. In this investigation 4Q381 is placed into its proper place inside some of the larger developments and ideologies perceivable within late Second Temple Judaism. For instance, 4Q381 is part of the general trends discernible in psalmody of this period, namely, a general increase in reflection upon the past and the use of wisdom motifs. But in addition, 4Q381 also gives evidence of a perception of psalms as sources of history that is in the end found to be a much broader phenomenon.

Judith

Hebrews in Contexts, edited by Gabriella Gelardini and Harold W. Attridge, gathers authors who explore extensively on Hebrews' neglected contexts, its relations to other early traditions and texts (Jewish, Hellenistic, and Roman) in order to map Hebrews' historical, cultural, and religious identity in greater, and perhaps surprising detail.

From Qumran to the Synagogues

Given the recent interest in the emotions presupposed in early religious literature, it has been thought useful to examine in this volume how the Jews and early Christians expressed their feelings within the prayers recorded in some of their literature. Specialists in their fields from academic institutions around the world have analysed important texts relating to this overall theme and to what is revealed with regard to such diverse topics as relations with God, exegesis, education, prophecy, linguistic expression, feminism, happiness, grief, cult, suicide, non-Jews, Hellenism, Qumran and Jerusalem. The texts discussed are in Greek, Hebrew and Aramaic and are important for a scientific understanding of how Rabbinic Judaism and Early Christianity developed their approaches to worship, to the construction of their theology and to the feelings that lay behind their religious ideas and practices. The articles contribute significantly to an historical understanding of how Jews maintained their earlier traditions but also came to terms with the ideology of the dominant Hellenistic culture that surrounded them.
