Philip II of Macedonia (382–336 BCE), unifier of Greece, author of Greece's first federal constitution, founder of the first territorial state with a centralized administrative structure in Europe, forger of the first Western national army, first great general of the Greek imperial age, strategic and tactical genius, and military reformer who revolutionized warfare in Greece and the West, was one of the greatest captains in the military history of the West. Philip prepared the ground, assembled the resources, conceived the strategic vision, and launched the first modern, tactically sophisticated and strategically capable army in Western military history, making the later victories of his son Alexander possible. Philip's death marked the passing of the classical age of Greek history and warfare and the beginning of its imperial age. To Philip belongs the title of the first great general of a new age of warfare in the West, an age that he initiated with his introduction of a new instrument of war, the Macedonian phalanx, and the

tactical doctrines to ensure its success. As a practitioner of the political art, Philip also had no equal. In all these things, Philip exceeded Alexander's triumphs. This book establishes Philip's legitimate and deserved place in military history, which, until now, has been largely minimized in favor of his son by the classicist writers who have dominated the field of ancient biography. ## A History of Civilizations

This book recounts the World War II journeys of a soldier, a ship, and a bottle of spirits through, and around, five great turning-point battles. It is the history of the North Atlantic sea basin and its extensions at war: the story of the lulls between battles, when America's teenage warriors often watched war movies (Humphrey Bogart made and Warner Brothers released seven during the war), sang or listened to popular tunes by songsmiths like Irving Berlin, and drank rum-and-Coke (while listening to Dick Haymes sing the hit "Rum & Coca-Cola"). While accessible and vastly entertaining, this is a serious work of history. By treating World War II in Europe much as Fernand Braudel treated the origins of Western civilization in his masterpiece The Mediterranean and the Mediterranean World in the Age of Philip II, Hatcher brings Braudelian detachment to his narrative.

#### Empires of the Sea

By examining in detail the material life of pre-industrial peoples around the world, Fernand Braudel significantly changed the way historians view their subject. Originally published in the early 1980s, Civilization traces the social and economic history of the world from the Middle Ages to the Industrial Revolution, although his primary focus is Europe. Braudel skims over politics, wars, etc., in favor of examining life at the grass roots: food, drink, clothing, housing, town markets, money, credit, technology, the growth of towns and cities, and more. Volume I describes food and drink, dress and housing, demography and family structure, energy and technology, money and credit, and the growth of towns.

#### A Companion to Mediterranean History

## Family Life in the Ottoman Mediterranean

International trade was of great importance for the Ottomans in the construction of their empire. Kate Fleet's book examines the trade links which existed between European merchants and their Muslim counterparts from the beginnings of the Ottoman empire in 1300 to the fall of Constantinople in 1453.
