The Tarawa class Amphibious Assault Ship served as the inspiration for the Wasp class.

Wasp class ships are the first designed to operate AV-8B Harrier II planes and LCAC hovercraft.

The USS Wasp, the class's first ship, was commissioned on July 29, 1989.

The fifth ship of the class, USS Bataan, was constructed through a process of modular assembly. Bataan was the first LHD (Landing Helicopter Dock) designed with accommodation for female sailors.

The LCAC (Landing Craft Air Cushion) is signaled to disembark from the well deck.

The SLEP (Service Life Extension Program) electronics suite is more reliable and less expensive.

LCACs have the ability to approach completely unimproved beaches and transport big loads ashore quickly.

The design of the LCAC enables them to land on 80% of the world's beaches.

The side skirts inflate to create a cushion of escaping air upon which the craft rides.

The LCAC has four gas turbine engines, two for lift and two for propulsion.

The LCAC controls like a helicopter with six dimensions of motion.

Several Combat Rubber Raiding Crafts (CRRC) can be launched from the deck of the LCAC.

The coxswain sitting at the rear of the CRRC is responsible for the boat operation.

The craft's skirt now incorporates spray suppression to improve the driver's vision.

Because the LCAC hovers above the water, it is susceptible to wind influence

A B-1B is being repositioned with the help of a tow tractor.

The B-1B is also known as the 'Bone' deducted from the word B One.

An Aircraft Commander, Pilot, Offensive Systems Officer, and Defensive Systems Officer make up the crew.

The crew chief communicates via wired headset with the pilots.

The four turbofan engines generate 17,390 pounds of thrust each without afterburner.

The forward-swept wing configuration is used during takeoff and landing.

The scratches around the refueling port is a testament to the difficulty in performing aerial refueling.

After refueling is concluded, the Lancer leaves the safe refueling envelope.

The C-12 is a twin-engine turboprop cargo aircraft based on Beechcraft models.

The C-12 is used for embassy support, medical evacuation, and passenger and light cargo transport.

The C-12 has a maximum takeoff weight of 12,500 pounds.

The pilot tries to align the aircraft's fuselage with the runway during a crosswind landing.
