Zu diesen Bereichen zählen eine transparente Vergabe, Organisation und Durchführung. Des Weiteren müssen die ethischen und moralischen Werte, welche bei einem solchen Event ohnehin von der Presse genauer beobachtet werden, stets gewahrt werden. Zum ersten Mal in der Geschichte wurde die Fußballweltmeisterschaft an einen Emirat vergeben. Neben den Olympischen Spielen gehört dieses Event zu den am meisten verfolgten Sportereignissen der Welt. Wird die Vergabe der Fußballweltmeisterschaft an Katar betrachtet, ergeben sich diverse Korruptionsvorwürfe gegen die Funktionäre, was oftmals dazu führte, dass die Vergabe durch die Federation Internationale de Football Association, kurz FIFA, in Frage gestellt wurde. Des Weiteren kritisiert die internationale Presse vermehrt die menschenunwürdigen Arbeitsbedingungen auf den Baustellen, die Ausbeutung der Arbeiter sowie die Zwangsarbeit. Auch viele namenhafte Sportfunktionäre, wie zum Beispiel der ehemalige Präsident des Deutschen Fußball Bundes, Theo Zwanziger, kritisierten die Vergabe aufs Schärfste und nannten diese einen der größten Fehler, die es im Sport jemals gab. Aus diesen Gründen wird im Laufe meiner Arbeit eine unternehmerische Betrachtung der Vergabe, Durchführung und Organisation im Rahmen des CSR-Managements und ethischer Aspekte durchgeführt. Unter dem Begriff Corporate Social Responsibility, kurz CSR, ist eine verantwortungsvolle Unternehmensführung zu verstehen. Die FIFA soll im Rahmen dieser Arbeit als Unternehmen angesehen werden, da sie durchschnittlich einen Jahresumsatz von mehr als 1,3 Milliarden Dollar durch Übertragungs-, Sponsorings- und Lizenzrechte generiert und somit international wirtschaftet. Mittels einer unternehmerischen Betrachtung könnte es möglich sein, CSR als Managementansatz im Kontext der Vergabe, Organisation und Durchführung zu nutzen.

German Buenos Aires, 1900-1933

This study of the German community of early twentieth-century Buenos Aires is a major contribution to the literature on Argentine history and on the New World immigrant experience. Beginning with the first wave of immigration in the late nineteenth century and continuing to the outbreak of World War II, Ronald C. Newton reconstructs the growth, development, and influence of a powerful foreign population in what was then the largest city in South America. In the three decades before World War I, Argentina became a major food-producing and exporting country. Through the port of Buenos Aires was funneled the bulk of the Pampas' foodstuff and fiber in one direction and Europe's capital, technology, and surplus labor in the other. The German speakers made up one of the smaller Western European communities within the Argentine metropolis, but their cultural and economic influence was far out of proportion to their numbers. Based in a large and occupationally diverse middle class, the German community was represented at all social levels. Newton analyzes the experience of this well-demarcated group during a period of rapid demographic growth and increasing pressure to assimilate. He constructs working hypotheses that may be applied and refined in further investigations. The book draws substantially on materials from within the Buenos Aires German community—newspapers, memoirs, the records of associations and welfare agencies—to reconstruct its intense daily life. The author highlights, for instance, the sharp economic reversals German-speaking residents suffered during World War I and shows how their fortunes declined further after continued Germanic immigration in the 1920s. Especially significant is his finding that the German community, which until 1914 had seemed impervious to the currents of Argentine nationalism, became susceptible to assimilation into Argentine society. In concluding chapters Newton demonstrates the way the German economic elite came to terms with the Nazis for opportunistic reasons; thus, the volume also serves as an introduction to the question of Nazism's diffusion in Argentina.

Democratic Brazil Revisited

As the world's fifth-largest country, Brazil presents a compelling example of democracy in action. In this sequel to their landmark study Democratic Brazil, editors Peter Kingstone and Timothy Power have assembled a distinguished group of U.S.- and Brazilian-based scholars to assess the impact of competitive politics on Brazilian government, institutions, economics, and society. The 2002 election of Lula da Silva and his Worker's Party promised a radical shift toward progressive reform, transparency, and accountability, opposing the earlier centrist and market-oriented policies of the Cardoso government. But despite the popular support reflected in his 2006 reelection, many observers claim that Lula and his party have fallen short of their platform promises. They have moved to the center in their policies, done little to change the elitist political culture of the past, and have engaged in "politics as usual" in executive-legislative relations, leading to allegations of corruption. Under these conditions, democracy in Brazil remains an enigma. Progress in some areas is offset by stagnation and regression in others: while the country has seen renewed economic growth and significant progress in areas of health care and education, the gap between rich and poor remains vast. Rampant crime, racial inequality, and a pandemic lack of personal security taint the vision of progress. These dilemmas make Brazil a particularly striking case for those interested in Latin America and democratization in general.

Ikpiarjuk

We travel to India to see the Taj Mahal, Egypt to see Pyramids, Turkey to see Blue Mosque, Italy to see Colosseum, South America in quest of Inca civilization, and so on. But very few travel to Nunavut – A Land of Inuit. Md Abdus Salam – the author, had a chance to travel, live, and work in Arctic Bay – a small Nunavut community, for 12 years. Not many people in the world know about life in Nunavut. Many people in the southern part of Canada have no idea where and what Nunavut is, no question to speak about Arctic Bay, where Salam landed to teach in 2007. As he learned to survive the harsh winters and other challenges unique to the North, the Arctic also provided him amazing experiences, from polar bears to the aurora borealis, snowmobiles, and potable water problems. Used to living in a large community with many amenities, Salam faced some unique predicaments while living and teaching in the land of Inuit. In the North, he learned of Inuit culture, heritage, and hunting practices while learning to live in a land of extremes—including -60C cold, three months of complete darkness in the winter, and 24/7 daylight for three months in the summer. The memoir Highlights Md Abdus Salam's experiences first as an immigrant teacher and then as a principal in the community of Arctic Bay. Ikpiarjuk: My Challenges Teaching in a Land of Inuit speaks to the experiences of a talented educator's time spent living and teaching in a place that was utterly unknown to him.

The American Employer

For more than one hundred years, tourists and residents alike have flocked to Ye Olde Curiosity Shop, located on Seattle's waterfront. Here a mummy nicknamed Sylvester, a collection of shrunken heads from Ecuador, a two-headed calf, and a mermaid preside over walls and cases crammed with an incredible jumble of souvenirs and trinkets, intermixed with authentic Northwest Coast and Alaskan Eskimo carvings, baskets, blankets, and other artworks. The guestbook records visits by Theodore Roosevelt, Will Rogers, Jack Dempsey, Charlie Chaplin, J. Edgar Hoover, Katherine Hepburn, John Wayne, Sylvester Stallone, and Queen Marie of Rumania, among many others. Ye Olde Curiosity Shop was founded in 1899 by Joseph E. "Daddy" Standley, an Ohio-born curio collector who came to Seattle in the late 1890s during the Yukon gold rush. Although Native American material vied for space with exotica from all corners of the globe, it soon grew to be the mainstay of the shop, which became identified with the whalebones displayed outside and the "piles of old Eskimo relics" within. Also to be found were baskets, moccasins, ivory carving from Alaska, Tlingit spruce root baskets, Haida "jadeite" totem poles, masks, paddles, and other curiosities from the Northwest Coast. Indians from the Olympic Peninsula brought baskets, coming up to the back door of the shop in their canoes. Others, originally from British Columbia but now living on the flats not far from the shop, carved miniature totem poles by the hundreds and full-size poles on commission. Trading companies supplied Indian curios from the Plains, Southwest, and California. An art historian trained in the classic arts of the Northwest Coast, Kate Duncan became interested in the history of the shop when she learned that it had not only been an active participant in Seattle's 1909 Alaska-Yukon-Pacific Exposition but had also been a major source of important Northwest Coast collections in many museums, including, among others, the Royal Ontario Museum, the George G. Heye Collection (now in the Smithsonian's Museum of the American Indian), the Washington State Museum, the Newark Museum, the Portland Art Museum, and the American Museum of Natural History. Granted full access by the present owners - grandson and great-grandson of "Daddy" Standley - to the remarkably complete archives maintained from the time the shop opened, Duncan has provided a fascinating chapter in the history of Seattle, especially in its early years, as well as a significant contribution to the literature on tourist arts and collecting. Kate Duncan, professor of art at Arizona State University, is also the author of Northern Athapaskan Art: A Beadwork Tradition, and coauthor of A Special Gift: The Kutchin Beadwork Tradition and Out of the North: The Subarctic Collection of the Haffenreffer Museum of Anthropology.
