The checklist provided at the end of each chapter can serve as a ready-reckoner to the Police Officers at various stages of the investigation. A trainee and a veteran equally will find this book a useful aid. To cite an example, under chapter 14, "Arrest", he has cited 37 landmark judgements. By reading these fourteen pages alone one can avert many a pitfall. While writing this book, the academic pursuit of the author is in full bloom, as he has drawn valuable and authenticated data from various enactments, official documents, court iudgements and a vast domain of related literature of national and international significance.
