Marvin S. Minsky, Ph.D. Father of Artificial Intelligence

Marvin Minsky was a Junior Fellow at Harvard when he laid the groundwork for the emerging science of artificial intelligence.

Marvin Minsky's 1986 book The Society of Mind shared the scientist's evolving thoughts on the nature of human intelligence, consciousness, memory, language and free will.

In addition to rejecting the concept of "consciousness" per se, Marvin Minsky had little use for the idea of intuition.

Marvin Minsky's interest in science began in childhood.

The field of artificial intelligence continues to grow and develop.

The theories of Marvin Minsky and his colleague Seymour Papert continue to influence our study of the human mind, while having their greatest impact in computer science.
