But empowered intelligence services require adequate supervision and oversight, which must be about more than the narrow (if still precarious) task of ensuring the legality of covert operations and surveillance activities. Global Intelligence Oversight is a comparative investigation of how democratic countries can govern their intelligence services so that they are effective, but operate within frameworks that are acceptable to their people in an interconnected world. The book demonstrates how the institutions that oversee intelligence agencies participate in the protection of national security while safeguarding civil liberties, balancing among competing national interests, and building public trust in inherently secret activities. It does so by analyzing the role of courts and independent oversight bodies as they operate in countries with robust constitutional frameworks and powerful intelligence services. The book also illuminates a new transnational oversight dynamic that is shaping and constraining security services in new ways. It describes how global technology companies and litigation in transnational forums constitute a new form of oversight whose contours are still undefined. As rapid changes in technology bring the world closer together, these forces will complement their more traditional counterparts in ensuring that intelligence activities remain effective, legitimate, and sustainable.

## Global Intelligence Oversight

This book analyzes intelligence relations in an unsecure world and provides contributions on intelligence processes, interstate intelligence relations and hybrid warfare. Tactical, operational and strategic intelligence relations, both within and between intelligence agencies, and between states, are essential to support decision makers. This book ties together how intelligence adapts to security changes, global power shifts and the trend from globalization to a more nationalistic approach. During such changes, there is a need to analyze intelligence sharing relationships. Bringing together practitioners and academics, the book presents a plurality of approaches relative to intelligence relations that seek to advance the debate in the field.

#### Arms Control in the 21st Century

This volume evaluates the impact of coercive arms control efforts to curb the spread of weapons of mass destruction in the twenty-first century. A new paradigm in arms control is gradually replacing the idea that mutually agreed restrictions on armaments can improve international security. Thus, Hedley Bull's classic definition of arms control as the "cooperation between antagonistic pairs of states in military affairs" needs to be amended by a new notion of coercive arms control as the set of non-cooperative and non-reciprocal measures to restrict the weapons or military capabilities of certain states. This volume addresses the topic of how this ongoing paradigmatic shift will affect the effectiveness of arms control as a conflict management instrument. # Nuclear Weapons and Cooperative Security in the 21st Century

This book looks at the prospects for international cooperation over nuclear weapons proliferation in the 21st century. Nuclear weapons served as stabilizing forces during the Cold War, or the First Nuclear Age, on account of their capability for destruction, the fear that this created among politicians and publics, and the domination of the nuclear world order by two superpowers: the United States and the Soviet Union. The end of the Cold War, the dissolution of the Soviet Union, and the potential for nuclear weapons acquisition among revisionist states, or even non-state actors including terrorists, creates the possibility of a 'wolves eat dogs' phenomenon in the present century. In the 21st century, three forces threaten to undo or weaken the long nuclear peace and fast-forward states into a new and more dangerous situation: the existence of large US and Russian nuclear weapons arsenals; the potential for new technologies, including missile defenses and long-range, precision conventional weapons, and a collapse or atrophy of the nuclear nonproliferation regime, and the opening of the door for nuclear weapons to spread among more than the currently acknowledged nuclear states. This book explains how these three 'weakening' forces interact with one another and with US and Russian policy-making in order to create an environment of large possibilities for cooperative security - but also

of considerable danger. Instead, the choices made by military planners and policy-makers will create an early twenty-first century story privileging nuclear stability or chaos. The US and Russia can, and should, make incremental progress in arms control and nonproliferation. This book will be of much interest to students of nuclear proliferation and arms control, strategic studies, international security and IR in general. Stephen J. Cimbala is Distinguished Professor of Political Science at Pennsylvania State University. The work juxtaposes a sober review of progress made during the last decade with a proactive agenda of proposals for new disarmament initiatives in the next decade. Taken together, the contributions to this volume suggest that, contrary to current conventional wisdom, the increasing global cache of nuclear weapons and the waning progress on nuclear disarmament of recent years need not become the defining features of the post-Cold War era. Rather, by examining the new conditions that have emerged at the dawn of the of the 21st century through both national and issue-based perspectives, this work reveals how the likelihood of continuing uncertainty and change in world affairs creates opportunities, as well as the need, for renewed progress toward significant nuclear disarmament.

#### Nuclear Proliferation and the Dilemma of Peace in the Twenty-First Century

On September 27, 2007, Quinnipiac University and the Albert Schweitzer Institute hosted former US President Jimmy Carter and several internationally-known experts at a forum to discuss nuclear disarmament. This book includes papers and transcripts of talks delivered at that conference. It contains the transcript of President Carter's keynote address, in which he discusses his experiences in the White House when he and Soviet premier Leonid Brezhnev tangled over the size of their respective nuclear arsenals. Carter relates, "I knew the entire time I was president, that 26 minutes after we detected the launching of an intercontinental ballistic missile, that that missile would strike Washington DC or New York or any other target that the Soviets had chosen." This imminent nuclear threat, Carter notes, strengthened his commitment to peace after he left the White House; the very first conference he scheduled at the Carter Center in Atlanta was on nuclear disarmament. Other papers include talks by Jonathan Granoff, President of the Global Security Institute, who discusses the collective denial that the world seems to have toward nuclear weapons; Ira Helfand, who describes the physical, medical and biological impacts of a massive nuclear explosion should such a disaster occur in or near an urban center; Hirotami Yamada offers a heart-wrenching account of how, as a boy, he survived the atomic bomb blast in his hometown of Nagasaki in August 1945 while the rest of his family perished; Dr. Neil Araya, of the Nobel Peace Prize-winning International Physicians for the Prevention of Nuclear War, discusses the connection between public health and nuclear weapons. Other papers consider historical, philosophical, linguistic and educational issues related to nuclear weapons and the ongoing struggle for peace.

# Deterrence in the Twenty-first Century

This anthology argues that facing the diverse threats in the 'new world disorder' requires a new look and new approaches. The requirement is to establish that contemporary deterrence demands replacing the old 'nuclear theology' with new policy and strategy to deal with the myriad state, non-state, and trans-national nuclear and non-nuclear menaces that have heretofore been ignored or wished away.

#### Preventive Defense

William J. Perry and Ashton B. Carter, two of the world's foremost defense authorities, draw on their experience as leaders of the U.S. Defense Department to propose a new American security strategy for the twenty-first century. After a century in which aggression had to be defeated in two world wars and then deterred through a prolonged cold war, the authors argue for a strategy centered on prevention. Now that the cold war is over, it is necessary to rethink the risks to U.S. security. The A list--threats to U.S. survival--is empty today. The B list--the two major regional contingencies in the Persian Gulf and on the Korean peninsula that dominate Pentagon planning and budgeting--pose imminent threats to U.S. interests but not to survival. And the C list--such headline-grabbing places as Kosovo, Bosnia, Somalia, Rwanda, and Haiti--includes important contingencies that indirectly affect U.S. security but do not directly threaten U.S. interests. Thus the United States is enjoying a period of unprecedented peace and influence; but foreign policy and defense leaders cannot afford to be complacent. The authors' preventive defense strategy concentrates on the dangers that, if mismanaged, have the potential to grow into true A-list threats to U.S. survival in the next century. These include Weimar Russia: failure to establish a self-respecting place for the new Russia in the post-cold war world, allowing it to descend into chaos, isolation, and aggression as Germany did after World War I; Loose Nukes: failure to reduce and secure the deadly legacy of the cold war--nuclear, chemical, and biological weapons in Russia and the rest of the former Soviet Union; A Rising China Turned Hostile: failure to shape China's rise to Asian superpower status so that it emerges as a partner rather than an adversary; Proliferation; spread of weapons of mass destruction; and Catastrophic Terrorism: increase in the scope and intensity of transnational terrorism. They also argue for better management of the defense establishment so the United States will retain a strong military prepared to cope with all contingencies, deter aggressors, and win a conflict if deterrence fails.

# The Nuclear Non-Proliferation Regime

Leading international security scholars and policy advisors from universities, think-tanks, and nuclear weapons laboratories in the United States analyze the future of nuclear weapons proliferation. In April 1995, the earlier 1970 Nuclear Non-Proliferation Treaty was renewed indefinitely and without change to the original clauses of the treaty. The authors examine the continuing relevance or irrelevance of the old treaty, the role of coercive sanctions in enforcing restraint, and the impact of biological, chemical and missile proliferation on the nuclear motives and ambitions of various states. Attention is given to proliferation conditions in the former Soviet republics, East and South Asia and the Middle East.

#### Battlefield of the Future

This is a book about strategy and war fighting in the midst of a revolution in military affairs as the world moves into the twenty-first century. Its 11 essays examine topics such as military operations against a well-armed rogue state or NASTT (NBC-arming sponsor of terrorism and intervention) state; the potential of parallel warfare strategy for different kinds of states; the revolutionary potential of information warfare; the lethal possibilities of biological warfare; and the elements of an ongoing

revolution in military affairs (RMA). The book's purpose is to focus attention on the operational problems, enemy strategies, and threats that will confront US national security decision makers in the twenty-first century. The participating authors are either professional military officers or civilian professionals who specialize in national security issues. Two of the architects of the US air campaign in the 1991 Gulf War have contributed essays that discuss the evolving utility of airpower to achieve decisive results and the lessons that might portend for the future of warfare. In "Principles of War on the Battlefield of the Future," which sets the tone for the book, Dr. Barry Schneider examines how traditional principles of war may have to be reassessed in light of a proliferation of weapons of mass destruction (WMD) among third world states. Regarding the principle of "mass," traditional theory dictated that forces be massed for an offensive breakthrough. But Schneider argues that, against an enemy armed with WMD, dispersed of one's forces may, in fact, be more prudent, and fighting by means of "disengaged combat" prior to a decisive strike may be necessary. This requires high coordination and "superior targeting and damage assessment intelligence, combined with superior high-tech weapons." Still, the United States and its allies would not likely be able to dominate a future battlefield even with advanced conventional arms if they did not have close-in air bases to operate from and thereby to achieve air dominance over the battle space. Therefore, while it sounds good, striking from outside the enemy's range is not a real option for long if the enemy is mounting a ground campaign that is closing in on vital areas. Local air, sea, and ground power will be needed to contain the adversary forces and roll them back. This means local air bases and seaports must be available and protected. ## Developing a Theoretical Model of Counterproliferation for the 21st Century

Examining counterproliferation as a global phenomenon, the authors use an in-depth analysis of the Counterproliferation Initiative to develop a theoretical model of counterproliferation for the 21st century. Arguing that existing counterproliferation policy is the product of bureaucratic competition, the authors propose several modifications of existing policy. In the second half of the book, they use four case studies (Cuban Missile Crisis, Persian Gulf War, Osirak Reactor Raid, and Sudan) to identify factors that might contribute to an effective counterproliferation strategy. The study concludes with observations and limited predictions regarding the future of counterproliferation.

# Technology and Security in the 21st Century

Topics covered include the legacy of the Cold War's proliferation of weapons of mass destruction; the impact of human activity on the fragile ecosystem; the growth of hypercapitalism and resulting poverty and insecurity; the competition for energy resources and strategic minerals; biological warfare programs; and paramilitary actions against centers of power.
