The Human Rights Act is a law that protects people's rights in Scotland and across the UK.

It means that the rights set out in the European Convention on Human Rights are brought directly into Scotland's own laws.

Sometimes called "Convention rights" these include rights like the right to life, the right to privacy, to freedom from torture, the right to a fair trial, and the right to equality.

The Human Rights Act gives people a direct route to justice right here in Scotland's own courts.

Before the Act came into law, people had to take their human rights case all the way to the European Court of Human Rights.

The Act makes it unlawful for public bodies to act in a way that is not compatible with these rights.

The Human Rights Act also underpinned the setting up of the Scottish Parliament.

Laws passed in Scotland must be compatible with the Convention rights set out in the Human Rights Act.

It provides a foundation, and a model, for continued work to put other international human rights directly into Scotland's laws.
