The human health benefits derived from relationships with companion animals has attracted an abundance of scientific interest and research. However, there is a need for theoretical conceptualizations in order to understand the healing benefits of human-animal interactions. The goal of this book is to seek these answers and the *OC* how *OCO* and *OC* why *OCO* companion animals play a role in counseling and psychology. In-depth semi-structured interviews were conducted with three psychologists who use animals in their therapy settings. The focus of these interviews was to determine the experiences of having a companion animal present during therapy sessions. The results revealed that pets in therapy: (1) enhanced the therapeutic alliance/relationship, (2) revived the therapeutic environment, (3) improved professional practice, and (4) created a sense of sacredness. The therapy animals seemed to

provide the trust and safety needed for clients to work within the transitional space and that the animals may act as transitional objects for some clients. This book suggests that therapy animals are extremely helpful in providing a sense of safety for traumatized clients and could act as catalysts, especially with defensive and/or detached clients. Unique features include: discussion of the domestication of companion animals; research into the human-animal bond; social and psychological support theory; descriptions of methods used; object relations theory and Winnicott's Concepts; implications for the practice of counseling and psychology; professional and ethical considerations; and suggestions for future research. The Dog

This book provides a multidisciplinary overview of the impact of human–animal interaction on well-being from childhood to later life. It presents a life course perspective to the study of human–animal interaction, addressing concepts of family and the role of pets therein, as well as the impact of companion animals on child development and successful aging. This book fills a gap in the existing literature by framing the study of human–animal interaction, including the role of animal-assisted interventions on well-being, in a broader social and behavioral context.

How Animals Affect Us

Animal maltreatment includes physical or sexual abuse, neglect, or hoarding of animals, and all states have laws prohibiting various forms of animal maltreatment. About one-half have statutory provisions mandating or allowing courts to order forensic mental health assessments of individuals convicted of animal maltreatment offenses. Yet there are few resources on this topic for mental health and legal professionals and none that offer guidance for evaluations in animal maltreatment cases. *Animal Maltreatment* is the first book to provide an overview of animal maltreatment as a legal, clinical, and forensic issue. It offers guidance for mental health and legal professionals involved in the adjudication of animal maltreatment offenses, with a special focus on forensic mental health assessments in such cases. The book reviews the legal and social contexts of animal maltreatment and then describes research-based and clinical knowledge within the area. It offers perspectives on social and clinical responses in animal maltreatment cases and describes prospects for an area of forensic mental health assessment focused specifically on the forensic evaluation in cases of animal maltreatment. This is the first book that brings together descriptions of the characteristics of those who maltreat animals, factors associated with animal maltreatment behaviors, information about the impact on the animals themselves, and evaluations of offenders to assist courts in decisions about their rehabilitation. *Animal Maltreatment* will be of great benefit and interest to general and forensic psychologists, psychiatrists, and social workers, as well as lawyers, legal scholars and students, veterinarians, humane law enforcement professionals, and others involved in animal welfare advocacy.

Well-Being Over the Life Course

The integration of animals into the therapy setting by psychotherapists has been a growing trend. Psychological problems treated include emotional and behavioral problems, attachment issues, trauma, and developmental disorders. An influential 1970s survey suggests that over 20 percent of therapists in the psychotherapy division of the American Psychological Association incorporated animals into their treatment in some fashion. Anecdotal evidence suggests that the number is much higher today. Since Yeshiva University psychologist Boris Levinson popularized the involvement of animals in psychotherapy in the 1960s, Israel has come to be perhaps the most advanced country in the world in the area of animal-assisted psychotherapy (AAP). This is true especially in the areas of academic training programs, theory-building, and clinical practice. Great effort has been put into understanding the mechanisms behind AAP, as well as into developing ethical guidelines that take into account the therapist's responsibility toward both client and animal. This book exposes the world to the theory and practice of AAP as conceived and used in Israel. It emphasizes evidence-based and clinically sound applications with psychotherapeutic goals, as differentiated from other animal-assisted interventions, such as AAE (animal-assisted education) and AAA (animal-assisted activities), which may have education or skills-oriented goals. Not just anyone with a dog can call him- or herself an animal-assisted therapist. This volume demonstrates not only the promise of animal-assisted psychotherapeutic approaches, but also some of the challenges the field still needs to overcome to gain widespread legitimacy.

Animal Maltreatment

This book was the end product of life experiences, thoughts and intellectual wanderings of the author, who through his career and for the last twenty years was always serving all the three aspects of a Psychiatrist: He is a clinician, a researcher and an academic teacher. The book includes a comprehensive history of Psychiatry since antiquity and until today, with an emphasis not only on main events but also specifically and with much detail and explanations, on the chain of events that led to a particular development. At the center of this work is the question 'What is mental illness?' and 'Does free will exist?'. These are questions which tantalize Psychiatrists, neuroscientists, psychologists, philosophers, patients and their families and the sensitive and educated lay persons alike. Thus, the book includes a comprehensive review and systematic elaboration on the definition and the concept of mental illness, a detailed discussion on the issue of free will as well as the state of the art of contemporary Psychiatry and the socio-political currents it has provoked. Finally the book includes a description of the academic, social and professional status of Psychiatry and Psychiatrists and a view of future needs and possible developments. A last moment addition was the chapter on conspiracy theories, as a consequence of the experience with the social media and the public response to the COVID-19 outbreak which coincided with the final stage of the preparation of the book. Their study is an excellent opportunity to dig deep into the relation among human psychology, mental health, the society and politics and to swim in intellectually dangerous waters.

Human-Animal Interaction (HAI) Research: A Decade of Progress

Social workers play a critical role in the wellbeing of communities – trained to help individuals, families, and groups effect positive change and address barriers that stand in the way of optimal life and wellbeing. In addition to a focus on people, many social workers include animals in their definition of systems and family units, leading to endless ways they have successfully incorporated animals into their work. Animal-Assisted Psychotherapy

Exactly how do animals affect their companion humans' quality of life? The 7th International Conference on Animals, Health, and Quality of Life set out to explore this question. A major result of this quest was *Companion Animals in Human Health*, a careful selection of jurored and invited papers from that conference. The articles address human animal interaction (HAI) according to the elements that define quality of life: physical, mental/emotional, and social health; functional health; and general well-being. Beginning with an overview of human animal interaction from historical and value perspectives, the authors develop a conceptual framework for HAI research and quality of life measurement. They then go on to explore the psychosocial and physiological impact of HAI. The concluding sections address the role of companion animals in human development and the training and welfare of animals in therapeutic programs. As a state-of-the-science document, *Companion Animals in Human Health* is must reading for all health and social science professionals caring for clients who already have companion animals or for clients who might benefit from such interaction and thus will be of interest to those in the fields of clinical psychology, cognition, developmental psychology, family studies, gerontology, nursing, patient care, psychology, public health, and sociology.

Psychiatry
