She documents the historical development of Islamic thought and describes how Muslim males have arrived at the prevailing exclusionary positions. She considers the issues of dependent morality and of modesty, especially in attire -- a polarizing subject for many Muslim women. She integrates her analysis with interviews she conducted with Muslim women in the United States and Canada, comparing that data with information from a parallel group in Syria and with historical cases. She concludes that the majority of Muslim women today are not educated even for a complementary role in society. The book offers a curricular framework for self-learning that could prepare Muslim women for an active role in citizenship and policy making in a pluralistic society and may serve as a guideline for moving toward a 'gender revolution.' Her main thesis, if carried out in the lives of Muslims in America or elsewhere, would be so radical and liberating that her discourse is more powerful than those of many Muslim feminists.
