Women Participation in Panchayati Raj (with Special Reference to Anantnag Dist. of Jammu & Kashmir)

Research Paper (postgraduate) from the year 2017 in the subject Politics - International Politics - General and Theories, grade: 1, course: Political Science, language: English, abstract: This study is carried out in district Anantnag, South Province, of Kashmir during 2015. The basic purpose of the study is to analyze the role of women in Panchayati Raj system in the research area. The hypothesis is that, despite radical policy, participation of women in local governance is still constrained by social and religious structure. The data was collected from 399 respondents selected through systematic random sampling method from nine polling stations of Anantnag district. A majority of women take part in political activities only during elections. They think that casting vote is the ultimate exercise in political power. They are not aware of the reality that the elections are just an initiation of real powers. The higher level of participation is "taking part in decision making process" which they generally tend to ignore. Actually it is because of election campaigns run by contesting parties, which drives women to participate in voting and feel that their demands will be fulfilled, but after the election is over, it all books befooling activities.

## A Long Journey Ahead, Women in Panchayati Raj

The UN Millennium Development Goals (MDGs) reflect widespread international acknowledgement that empowerment of women and the achievement of gender equality are matters of human rights and social justice. Today gender disparity and empowerment have come to occupy the centre stage of development debate. Since, independence a number of legislative enactments have helped alleviate the status of women in India but still a lot remains to be achieved. The place and status of women in decision making apparatus needs to be evaluated and empowerment strategies formulated. The enactment of 73rd Amendment Act was a major step towards women s empowerment. The problem of participatory management of welfare schemes can be solved only when the marginalised section of the society come to play a major role in decision making. The scheduled castes in general and the scheduled castes women in particular, continue to lead a life of misery and deprivation. Even though seats have been reserved in favour of SCs women but very little has changed at the ground level. This book is an outcome of a study conducted in Haryana and focuses on the status and participation of scheduled castes women in decision making institutions at the local level i.e. Panchayati Raj Institutions. A number of factors have been identified, which help in understanding the problems in a proper perspective. The case studies, which form part of the book, have made this book very valuable. In short this bok helps in undestanding the various issues at stake due to which the scheduled castes women continue to remain out of decision making institutions at the local level. This book is useful to policy planners, administrators, researchers and students of Decentralized Governance and Gender Justice.

## Women's Participation in Panchayati Raj

This volume represents a collection of life histories of women who live in rural Haryana. It looks at the impact of the 73rd Amendment to India's constitution, which introduced reservations in the political arena for women. The Panchayati Raj Act of 1992 reserved one third of all Sarpanch positions for women, and granted constitutional status to the Panchayat system, outlining its specific functions and jurisdiction. This book enhances existing scholarship on the impact of these changes in that it provides the opportunity for women Sarpanches from Haryana to speak for themselves and reflect upon their journey. Ten elected women Sarpanches share their stories about their lives, from childhood to adolescence to adulthood. Their life histories address the following questions: Who are these women who agreed to run for a reserved seat in the elections? What motivated them? Why were they asked to run? What barriers do they face? Do they feel they are making a difference? Indeed, these stories reflect the lived realities of the women impacted by the changes in legislation.

## New Issues in Panchayati Raj

Panchayats are local governments mandated in the Constitution of India. As per the Constitution, a three-tier structure of panchayats is in place across the country, excepting areas where Part IX of the Constitution does not apply. Panchayats are to be instituted, through elections every five years, except in States with a population of less than 20 lakh, where panchayats at two tiers may be created. The Constitution recognizes the gram sabha, i.e. all the electors in a village panchayat. The Constitution provides that seats and offices of chairpersons be reserved for scheduled castes (SCs) and scheduled tribes (STs) in proportion to their respective population, and not less than one-third seats and offices of the chairpersons be reserved for women, including within the SC and ST reservations. Women's increased political participation has yielded positive results. Issues central to development-including health, nutrition, family income and education-have taken center stage as women participate in panchayati raj institutions (PRIs), village development boards, and other governance structures. India has primarily relied upon this method of reservation to ensure women's presence in decision-making bodies. This has increased de jure, but not necessarily de facto, participation. There is a need to encourage women's participation in other kinds of groups and associations which contribute to an atmosphere of leadership by women. ## Changing Status and Role of Women in Indian Society

The role of women in India has changed significantly over the past few years. Globalization, urbanization, industrialization and privatization all played an important role in this development. After India became independent, several provisions for women were added to the Constitution of India, which is now one of the most rights-based constitutions in the world. Drafted around the same time as the Universal Declaration of Human Rights- UNO (1948), the Indian Constitution captures the essence of human rights in its Preamble, and elaborates these rights further in the sections on Fundamental Rights and on the Directive Principles of State Policy. The protection of women's rights and the enhancement of their social and economic possibilities have become important political issues. Due to these socio-political changes, women have already gotten the opportunity to take important offices in India, including that of president, prime minister, speaker of the Lok Sabha and leader of the opposition. With the 73rd Constitutional Amendment Act from 1992 and the 74th Constitutional Amendment Act from 1993, women are furthermore empowered in local level government bodies. Apart from the political changes, women in India now also participate in all social activities and take part in sports, media, art and culture, science and technology. This book takes a look at every aspect of a woman's life, such as education, marriage, family and health, in order to give a thorough and accurate account of the role of women in today's India.

#### Women in Local Government
