Corporate resolutions include most formal actions and decisions approved by your board of directors. Corporate Resolutions are valuable as they establish the actions taken by, and on behalf of, the corporation.

As a general rule all records, resolutions, and meeting minutes of your corporation should be kept in your Corporate Minute Book as preserving these official documents long term is useful in the event that the actions of the Board of Directors are ever challenged or need to be proven.
