Then he was brought to Marshall (albeit not the Supreme Court) at which point it was discovered that the most damning evidence against him had been forged by his would-be co-conspirator.

Actually, some of the democratic-republicans had recently turned into democrats, the parties were undergoing a big shift at the time, but there was nary a federalist in sight.
