Developing Frontier Cities

The Unique Nature of Frontier Cities and their Development Challenge Harvey Lithwick and Yehuda Grad us The advent of government downsizing, and globalization has led to enormous competitive pressures as well as the opening of new opportunities. How cities in remote frontier areas might cope with what for them might appear to be a devastating challenge is the subject of this book. Our concern is with frontier cities in particular. In our earlier study, *Frontiers in Regional Development* (Rowman and Littlefield, 1996), we examined the distinction between frontiers and peripheries. The terms are often used interchangeably, but we believe that in fact, both in scholarly works and in popular usage, very different connotations are conveyed by these concepts. Frontiers evoke a strong positive image, of sparsely settled territories, offering challenges, adventure, unspoiled natural landscapes, and a different, and for many an attractive life style. Frontiers are lands of opportunity. Peripheries conjure up negative images, of inaccessibility, inadequate services and political and economic marginality. They are places to escape from, rather than frontiers, which is where people escape to. Peripheries are places of and for losers.

Frontiers in Regional Development

The case studies investigate livability issues in such cities as Austin, Texas; Helsinki, Finland; London, United Kingdom; Warsaw, Poland; Tehran, Iran; Salt Lake City, United States; Rio de Janeiro, Brazil; Sydney, Australia; and Cape Town, South Africa. The chapters are organized into such themes as livability in capital city regions, livability and growth and development, livability and equity concerns, livability and metrics, and creating livability. Each chapter provides unique insights into how a specific area has responded to calls for livable cities. In doing so, the book adds to the existing literature in the field of livable cities and provides policy makers and other organizations with information and alternative strategies that have been developed and implemented in an effort to become a livable city.

Multimodal Experiences Across Cultures, Spaces and Identities

Border Ecologies

Some of the fold structures observed on passive continental margins appear to be related to regional stresses transmitted through basement rocks, whereas others are related to gravitational sliding and toe-thrusting. This special publication concentrates on the first of these categories. The morphology and distribution of such folds, together with potential mechanisms for generation of regional stress, are

described in a series of papers. As well as being an enigmatic feature of passive margin geology, the compressive folds have significance in the exploration for petroleum.

New Regional Development Paradigms: New regions

This book presents the work of Gianfranco Battisti, on Geopolitics and Border Geographies in north-eastern Italy, Europeanization, and Globalization, contributing to debates on the inclusion of non-English speaking scholars in international geography. It highlights the institutions and cultures that shaped more than fifty years of his writing, as they emerged through his biography, theoretical contributions, and methods. Battisti uses historical geographies as tools to explain contemporary geopolitics while maintaining a high attentiveness to data-driven research. He applies these tools to investigate 'geographical facts' at the local, regional and global scale, viewed from the distinctive viewpoint of the city of Trieste, a laboratory of geopolitical change for more than two centuries. To better understand the importance of place in the production of geographical theories and methods, this book discusses Battisti's biography in the context of the Triestino School of geography that started from the same French and German classics that shaped Anglo-American geography in the 19th century to later express original features. This book explains such features by introducing the concept of Geography as an industry that operates in a local and global context. It then deploys the methods Battisti developed within his school to discuss the realities and problems of borderlands in a historic and local context during the first and second World Wars and the geopolitical rationale that shaped the times between. The book continues to give an outlook, on how Europe reconstructed itself geopolitically, the implications thereof, and a comparison of how this fits in with geopolitical agendas on a global scale.

City, Space + Globalization

Although China is now the 'factory of the world', there is no reason to expect that it will always be content with manufacturing labor-intensive goods for foreign corporations. Scholars must now ask: What is the current level of innovation in China? And how can we face this challenge and renovate industrial production and innovation capacities in developed countries? This edited volume investigates the unique characteristics of Chinese innovation and regional development, China's policy framework, and the role that transnational corporations play in China's increasing innovation activities.
