This book also sets the Orthodox church in a new light; often described as 'Eastern', a large diaspora is found today throughout the world, and especially in Western Europe and North America.

Women and the Church

Since the re-introduction of the permanent diaconate for men after the Second Vatican Council there has been debate over whether women should be included. Would diaconal ordination be a support in the charitable and ecclesiastical tasks women are already performing? Is it necessary? Would it be a help or a hindrance in women's attaining the priesthood? In A New Phoebe, women in the U.S. and German--the two countries with the most deacons--write about their ideas and experiences of ministry: some would seek the diaconate if it were open, others would not. The concluding essays, including an interview with Bishop Ernest Unterkoefler, the first chair of the U.S. Bishops' Committee on the Permanent Diaconate, provide additional historical background.

The Struggle to Serve

The main objective for this study is to analyze the various theological arguments surrounding the ordination of women in the Church and why people choose a particular line of argument, with a particular attention to the three main views or arguments on women in ministry, namely; egalitarianism, patriarchalism and complementarianism. History has proven that all theological debates concerning women in ministry have followed these three patterns or views. So to accomplish this, the historical research method was deployed to help us analyze these views. In this research, I found out that, the differences in these views is what I call "Scripture-view". All three line of argument claim Biblical backing and authenticity. They all tend to lean on a particular or some particular Biblical texts for their

argument, most of these texts are Pauline. It is therefore recommended that anyone taking a stand on women ordination should do so intelligently and not be sentimental about it. Taking into consideration more what the Bible has to say, since that is our manual or guide as Evangelical Christians, rather than depending on the philosophies of men and modernism.

Women in Ministry and Ordination

Drawing from interviews of fifty ordained and seminary-trained women, Frederick W. Schmidt, Jr. explores the bureaucratic and cultural underpinnings of the church that continues to bar women from positions of authority. Writing as a seminary-trained sociologist, Schmidt concentrates on the roles of clergywomen in five denominations - Episcopal, United Methodist, Evangelical Lutheran, Southern Baptist, and Roman Catholic. He maintains that behind the facade of equanimity, women are often relegated to the outskirts of church hierarchy. In compelling stories, we learn about the Episcopal woman denied a job because she was too short; the Methodist women burdened by the old saw of women preachers being like dogs walking on their hind legs; the Evangelical Lutheran who, in protest to her denomination's trickle-down reform, camped outside her bishop's office; and Roman Catholic women who, frustrated and beleaguered by their church's refusal to ordain them, become active reformers. To substantiate his assertion that churches are cultures as well as organizations, Schmidt examines both official policies regarding women's ordination in each denomination and the cultural context in which those policies must play out. Through their stories, the clergywomen remind us that the church influences society whether society acknowledges it or not.
