Die Erfindung des modernen Architekten

Le type de formation polytechnique et industriel pour ingénieurs et architectes a été mis au point par les scientifiques, ingénieurs et architectes qui, suivant la philosophie et la pédagogie des Lumières et dans la voie de la Révolution française, fondèrent pour la première fois un modèle d'enseignement basé sur la science, institutionnalisé en tant que curriculum à leur initiative. Alors que l'Ecole polytechnique, fondée en 1794-1795, assura la formation principalement d'officiers, d'ingénieurs et d'architectes pour le secteur militaire et civil du jeune Etat républicain, l'Ecole centrale des arts et manufactures, institution privée, fondée en 1829, se chargea de former des architectes et des ingénieurs pour le développement industriel moderne, et créa la nouvelle profession d'"ingénieur industriel". Dans les deux types d'écoles, polytechnique et industrielle, l'enseignement fut organisé de manière globale, complète et uniforme. L'école polytechnique de Karlsruhe, après s'être orientée, lors de sa fondation en 1825, d'après l'Ecole polytechnique de Paris, puis, en 1832, d'après le modèle de l'Ecole centrale, introduisit en 1841 des cours professionnels spécifiques. Le modèle de Karlsruhe fut suivi à Zurich lors de la fondation, en 1855, du "Eidgenössisches Polytechnikum".

Ways to Study and Research Urban, Architectural and Technical Design

How can we develop a scientific basis for architectural, urban and technical design? When can a design be labelled as scientific output, comparable with a scientific report? What are the similarities and dis-similarities between design and empirical research, and between design research, typological research, design study and study by design? Is there a need for a particular methodology for design driven study and research? With these questions in mind, more than forty members of the Faculty of

Architecture of the Delft University of Technology have described their ways of study and research. Each chapter shows the objectives, the methodology and its implementation in search for a deeper knowledge of design processes and an optimal quality of the design itself. The authors - among them architects, urban planners, social scientists, lawyers, technicians and information scientists – have widely differing backgrounds. Nevertheless, they share a great deal. The central focus is a better understanding of design processes, design tools and the effects of design interventions on issues such as utility, aesthetics meaning, sustainability and feasibility.

Tools for Ideas

Architects today must position themselves within an extremely wide-ranging field of qualifications. This makes it all the more important to have a fresh introduction to the field that makes up one of their core competences, the field of design. This introductory presentation describes and analyzes the theories, strategies, and tools of creative design for the purposes of practical work. With thoughtfulness and expertise, it opens the reader's eyes to the processes that underlie design and demonstrates different ways of communicating about complex design work. The first section focuses on the much-discussed relationship between design and research, between architecture and the sciences. The second section describes basic design approaches, from Vitruvius and Alberti through Erwin Panofsky and Wolfgang Kemp to Otl Aicher and Vilém Flusser. The third and largest section presents the elementary tools of design, from gestures and words through drawings, models, and simulations to critique, all as instruments of creative design in architecture and its related fields.

Designers

Modern product development means problem solving by teams in complex working environments. Thereby, the design process is influenced by factors from various fields, the task, the individual, the team, and the organisational context. This complex network of influences turns product development into a challenge with requirements for the designers aside from technical problems. This book contains the proceedings of the international symposium Designers - The Key to Successful Product Development held in Darmstadt, Germany, December 1997. During this meeting exponents from different leading research groups in engineering design came together to present and discuss their results. Within this volume different aims, issues and methods of design research are addressed in 23 contributions by different research groups. Structured in six sections according to the main fields of influence, it provides a survey of the state of scientifically-based knowledge and the trends of engineering design research on the influences leading to successful product development.

Die Grand Tour in Moderne und Nachmoderne

The 19th and 20th centuries witnessed a change in the attitude of artists travelling to Italy towards the canon of Classical art. There is now an increased interest in whatever is contemporary –there is a reception of the Futurists, arte povera or Italian design, artists turn to Marcello Piacentini, the “Superstudio” or Aldo Rossi. This book on The Grand Tour in the Modern and Post-Modern Age enquires into the necessity of the “Italian Experience” in the present-day training of artists and architects in the face of historical developments.

Reparieren und Repräsentieren

Reparieren und Repräsentieren - dies umschreibt das Aufgabenspektrum der 1804 gegründeten Münchner Hofbauintendanz. Zum einen hatte sie die Räume zu inszenieren, in denen die bayerischen Monarchen im 19. Jahrhundert auftraten, zum anderen mußte sie ganz profan die königlichen Immobilien instandhalten. Während sie in den ersten Jahrzehnten ihres Bestehens großartige ephemere Festarchitekturen für höfische Feste erfand und vor allem unter der Intendanz Leo von Klenzes (1818 bis 1864) an der Errichtung bedeutender Bauten wie der Alten Pinakothek, dem Odeon und dem Festsaalbau beteiligt war, reduzierte sich ihre Tätigkeit in der 2. Hälfte des 19. Jahrhunderts zunehmend auf Reparaturaufgaben. Die vorliegende Studie zeichnet detailliert Organisation, Aufgaben, Personalentwicklung und Finanzierung der zeitweise größten bayerischen Baubehörde nach. Darüber hinaus verschafft sie einen Überblick über das staatliche Bauwesen in Bayern, geht in einem Exkurs auf Theorie und Praxis der Architekturausbildung zwischen 1780 und 1870 sowie die Entwicklung des Berufsbilds des Architekten im 19. Jahrhundert ein und berührt am Beispiel von Auseinandersetzungen um den Wittelsbachischen Immobilienbesitz politische und rechtliche Grundprobleme der Verfassung von 1818. Franziska Dunkel studierte Architektur, Germanistik und Geschichte in München. Seit 2000

ist sie wissenschaftliche Mitarbeiterin am Projekt „Edition des Briefwechsels zwischen König Ludwig I. und Leo von Klenze“ an der Ludwig-Maximilians-Universität München.

Die Erfindung des modernen Architekten

Diese Einführung vermittelt in drei Großkapiteln die Grundlagen einer Soziologie der Architektur, liefert einen Überblick über die Epochen seit 1800 und beschreibt die Themen- und Praxisfelder. Dies ist der erste Band der zweibändigen Soziologie der Architektur und der Stadt.

Der Architekt

Anders als im Westen knüpften russische Philosophen, Literaten, Musiker und bildende Künstler im 19. und frühen 20. Jahrhundert an die Kunst messianische Erwartungen und erklären sie in phantastischer Übersteigerung zum historischen Subjekt einer universellen Neuschöpfung. Frühromantische Bildungsideale radikalisierend, ersetzt die russische Moderne die aufklärerische Wirkungsästhetik durch eine Wirklichkeitsästhetik, die letztlich eine Anti-Ästhetik ist: Kunst soll nicht allein auf die Gemüter wirken, sondern selbst eine neue ideale Wirklichkeit hervorbringen. Verena Krieger analysiert die Entwicklung dieser utopischen Idee anhand ihrer wichtigsten Repräsentanten: Aleksandr Ivanov, Fedor Dostoevskij, Nikolaj Cernysevskij, Vladimir Solov'ev, Aleksandr Skrjabin, Vjaceslav Ivanov, Nikolaj Berdjajev, Kazimir Malevic, Pavel Filonov, Aleksandr Rodcenko und die Konstruktivistengruppe. Sie legt mit diesem Buch eine grundlegende Untersuchung der russischen Moderne und der Entfaltung ihres ästhetischen Paradigmas in einer rund 100-jährigen Entwicklung vor.

Architektursoziologie

The story of modernist architects in East Central Europe The first half of the twentieth century witnessed the rise of modernist architects. *Brokers of Modernity* reveals how East Central Europe turned into one of the pre-eminent testing grounds of the new belief system of modernism. By combining the internationalism of the CIAM organization and the modernising aspirations of the new states built after 1918, the reach of modernist architects extended far beyond their established fields. Yet, these architects paid a price when Europe's age of extremes intensified. Mainly drawing on Polish, but also wider Central and Eastern European cases, this book delivers a pioneering study of the dynamics of modernist architects as a group, including how they became qualified, how they organized, communicated and attempted to live the modernist lifestyle themselves. Kunst als Neuschöpfung der Wirklichkeit

Der Beruf ist ein Grundelement gesellschaftlichen Lebens und gesellschaftlicher Strukturen. Viele Menschen definieren sich stark über ihr berufliches Wirken, die gesellschaftliche Stellung ist eng mit dem ausgeübten Beruf verknüpft. Siebzig Expertinnen und Experten aus verschiedenen wissenschaftlichen Disziplinen haben an dem vorliegenden Band mitgewirkt und leisten damit ihren Beitrag zum multidisziplinären Ansatz einer umfassenden Berufsforschung.

Brokers of Modernity

The industrialization of the nineteenth-century European city facilitated developing conceptions of the model city, and allowed for large scale urban transformations. The urban discourse in the latter half of the nineteenth century was consequently dominated by a dialectic exchange between the ideal and the practical, a debate played out in the formation of the modern metropolis. *Manifestoes and Transformations* is the first work to deal with urban utopias and their relationship with actual urban interventions. Bringing together a carefully chosen, wide-ranging team of experts, the book provides a broad, contextual exploration of the ideas and urban practices which are the foundations of our conception of the contemporary city. As such, it is a valuable resource for students interested in the formation of the modernist city.

Handbuch Berufsforschung

Niederösterreich beherbergt eine der ältesten Industrielandschaften Europas und besitzt ein reiches industrielles Erbe. Dieses zu erforschen ist Aufgabe der Industriearchäologie, die sich mit den Überresten des Industriezeitalters befasst und aus den Spuren sowie der Hinterlassenschaft industrieller Tätigkeit, die vielgestaltige Industriegesellschaft zu rekonstruieren versucht. Seit dem sich abzeichnenden Wandel von der Industrie- zur Kommunikationsgesellschaft erhielt die Industriekulturforschung einen besonderen Stellenwert im Rahmen der Geschichtsschreibung. Als für die Industriearchäologie und Industriedenkmalpflege grundlegender Aufgabenbereich erfasst die Inventarisierung die materiellen Überreste, die als Dokumente des Industriezeitalters das Verständnis für seinerzeitige Produktionsvorgänge und Arbeitsbedingungen überliefern. Die vorliegende Publikation ist das Ergebnis einer flächendeckenden Inventarisierung von Industriebauten und verkehrstechnischen Anlagen im Bundesland Niederösterreich. Einführend wird die Entwicklung der Industriedenkmalpflege in Österreich skizziert, der Geschichte und Methode der Industriearchäologie nachgegangen. In dem als Handbuch konzipierten Katalog werden etwa 1.000 Objekte des industriellen Erbes von A (wie Absberg) bis Z (wie Zwettl), und zwar von der mittelalterlichen Getreidemühle bis hin zum modernen Walzwerk in Wort und Bild vorgestellt.

Manifestoes and Transformations in the Early Modernist City

Alle Wissenschaft sammelt. Alle Wissenschaft ordnet und bildet Kategorien. Fächer und Wissens-Systematiken, in deren Rahmen wir uns heute bewegen, sind tradiert, seit die Enzyklopädisten des 18. Jahrhunderts von Universalordnungen des Weltwissens träumten. Die ETH Zürich verdankt ihre Form und Entstehung jener Denktradition; bereits mit der Schulgründung im 19. Jahrhundert wurden Sammlungen für alle Fächer geschaffen. Fast alle haben bis heute in der einen oder anderen Weise Bestand. Diese Publikation untersucht die historische und künftige Bedeutung der Sammlungen als "Orte des Wissens" sowie deren epistemische Relevanz als Manifestationen von Wissensordnungen. Sie fragt nach den Transfermöglichkeiten von Sammlungen, den Möglichkeiten der Generierung neuen Wissens und neuer Interpretationen wie auch der Erweiterung tradierter Kategorien. Dazu gehört auch ein Blick in die Zukunft zu den "geplanten Sammlungen".

Das industrielle Erbe Niederösterreichs

Das "Handbuch Spezielle Soziologien" gibt einen umfassenden Überblick über die weit verzweigte Landschaft soziologischer Teilgebiete und Praxisfelder. Im Gegensatz zu vergleichbaren Buchprojekten versammelt der Band in über vierzig Einzelbeiträgen neben den einschlägigen Gegenstands- und Forschungsfeldern der Soziologie wie etwa der Familien-, Kultur- und Religionssoziologie auch oftmals vernachlässigte Bereiche wie etwa die Architektursoziologie, die Musiksoziologie und die Soziologie des Sterbens und des Todes. Damit wird sowohl dem interessierten Laien, den Studierenden von Bachelor- und Masterstudiengängen als auch den professionellen Lehrern und Forschern der Soziologie ein Gesamtbild des Faches vermittelt. Die jeweiligen Artikel führen grundlegend in die einzelnen Teilbereiche der Soziologie ein und informieren über Genese, Entwicklung und den gegenwärtigen Stand des Forschungsfeldes. Das "Handbuch Spezielle Soziologien" bietet durch die konzeptionelle Ausrichtung, die Breite der dargestellten Teilbereichssoziologien sowie die Qualität und Lesbarkeit der Einzelbeiträge bekannter Autorinnen und Autoren eine profunde Einführung in die grundlegenden Themenbereiche der Soziologie.

Kategorien des Wissens

Die Kunstgeschichte tendiert dazu, Artefakte einzelnen Künstlerpersönlichkeiten zuzuschreiben und als "eigenhändig" zu qualifizieren. Dabei sind sie seit jeher das Produkt mehrerer Akteure, die einer Werkstatt angehören, in temporären Konstellationen zusammenarbeiten oder auf einzelne Arbeitsschritte spezialisiert sein können. Der Band nimmt die Hierarchisierung der arbeitsteiligen Produktion aus historischer und aktueller Perspektive kritisch in den Blick. Er stellt unterschiedliche Formen geteilter Arbeit vor, von den Werkstattkooperationen des Mittelalters bis hin zu den partizipatorischen Konzepten unserer Tage, und fragt nach den Akteuren, der Organisation des Zusammenarbeitens und dem kreativen Potenzial der Teamarbeit.

Handbuch Spezielle Soziologien

Jan-Hendrik Passoth rekonstruiert die Entwicklung sozialwissenschaftlicher Techniktheorien von der frühen Moderne bis zur Gegenwart. Ziel ist es, eine Verfestigung von zwei Erklärungsmustern zu untersuchen, die sich während der Entwicklung gebildet hat. Diese Erklärungsmuster unterscheiden sich im Kern darin, dass sie entweder der Technik oder der Gesellschaft ein besonderes Gewicht einräumen. Die Varianten der Erklärungsmuster ändern sich mit den Veränderungen der modernen Technik und Gesellschaft. Der Umgang mit den Herausforderungen der Moderne hat auch zu einer Dichotomie in Bezug auf Begriffe und Grundannahmen geführt. In Auseinandersetzung mit drei zeitgenössischen Alternativen formuliert der Autor zudem Grundfragen einer sozialwissenschaftlichen Techniktheorie, die die Trennung von Technizismus und Kulturalismus zu vermeiden versucht.

Geteilte Arbeit

Jedes Gebäude besteht aus Teilen, die vielfältig organisiert werden können. Wände etwa lassen sich auf unterschiedliche Weise anordnen, um ihre Hauptfunktionen – Tragen, Trennen und Schützen – optimal wahrzunehmen. Das Buch stellt die gängigen Tragsysteme wie Scheiben-, Massiv- oder Skelettbauweise vor und zeigt deren Auswirkung auf das Gesamtgefüge. Es erklärt, wie Räume vertikal oder horizontal verbunden und zu einem Ganzen zusammengesetzt werden können. Die einzelnen Elemente wie Geschossdecken, Dächer, Öffnungen oder Fundamente werden in ihren Funktionen und mit ihren Verbindungsmöglichkeiten dargestellt. Das Buch zeigt hinter der Fülle der möglichen Details die Prinzipien der Detaillierung. Zahlreiche, eigens angefertigte Zeichnungen erklären die Prinzipien der Bauteile und verdeutlichen diese dann an realisierten Projekten.

Technik und Gesellschaft

Das Buch bietet einen wichtigen und fundierten Beitrag zur aktuellen Integrationsdebatte. Der Autor untersucht türkische Moscheen und Cafés als "Ethnische Kolonien". Dabei gelingt ein einmaliger Einblick in eine unbekannte Welt mitten in Deutschland.

Bauteile und Verbindungen

Der Tagungsband versammelt Beiträge des 3. Forums Architekturwissenschaft zum Thema der historischen und gegenwärtigen Architekturausbildung – vom Baumeister zum Master –, das vom 25. bis 27. November 2016 an der Freien Universität Berlin in Kooperation mit der Brandenburgischen Technischen Universität Cottbus-Senftenberg stattfand. Die Aufsätze verhandeln Fallbeispiele der Architekturlehre vom 19. bis ins 21. Jahrhundert entlang von konstant bedenkenswerten Querschnittsfragen – wie jene nach Akteursperspektiven, nach Lehrformatem oder auch Institutionenpolitiken. Dabei werden Geschichte, Gegenwart und Zukunft der besonderen Ausbildungsdisziplin Architektur in einen Austausch gebracht. Es stehen auf diese Weise wissenschaftlich reflektierende Stimmen neben jenen, die aus der Unterrichtspraxis berichten. Die Sortierung innerhalb des Bandes bindet die Texte jeweils mit Hilfe einer überzeitlichen also systematischen Fragestellung aneinander. The conference proceedings publishes contributions to the 3rd Forum Architekturwissenschaft on the topic of historic and contemporary architectural education – from master builder to master – that was held 25.-27. November 2016 at Freie Universität Berlin in cooperation with Brandenburg University of Technology Cottbus-Senftenberg. The papers discuss case studies of architectural education from the 19th to the 21st century along questions of continuous relevance – such as the notion of actors' perspectives, teaching formats or institutional politics. Thus, history, present and future of architecture as a particular educational field are brought into a joint discourse. Academic research is joined with voices from the practice of teaching. The publication's structure binds the individual contributions in the narrative of these transtemporal questions.

Ethnische Kolonien

Ausgehend von der Metapher der «Werkzeuge des Entwerfens», behandelt das Buch die Wechselwirkungen zwischen den Entwerfenden, den ihnen zur Verfügung stehenden Mitteln und den im Entwurf verwendeten Materialien. Die Darstellung verschafft einen Überblick über das heutige Wissen vom Entwerfen, umreißt die wesentlichen Begriffe und Definitionen als Grundlage für die Verständigung und beschreibt den Entwurfsprozess in seinen Grundzügen. Im zweiten Teil werden die grundlegenden Werkzeuge des Entwerfens in ihrem Gebrauch beschrieben und in ihrer Bedeutung analysiert. Zu ihnen zählen u.a.: Geste, Skizze und Sprache, Zeichnung, Perspektive und Modell, Foto, Film und Video, Computer, Programm und Simulation, Theorie und Kritik. «Weil ein komplexer Begriff des Entwerfens im Alltag des Architekten alles andere als selbstverständlich ist, hält Gänshirt beharrlich

Kunst, Zeichen, Technik

Archäologische Universitätssammlungen finden sich heute zunehmend in einer Situation zwischen universitärem Alltag von Forschung und Lehre und den Ansprüchen, welche eine interessierte Öffentlichkeit stellt. Im vorliegenden Band berichten Mitarbeiter, Leiter und Kuratoren, aber auch Restauratoren, Kulturvermittler und Museumspädagogen, und decken dabei eine große fachliche Breite an unterschiedlichen archäologischen Disziplinen ab. Ziel ist es, erstmalig sowohl einen umfassenden Überblick über die Geschichte dieser Institutionen zu bieten als auch die Situation archäologischer Universitätssammlungen im deutschsprachigen Raum zu Beginn des 21. Jahrhunderts näher zu betrachten.

Vom Baumeister zum Master. Formen der Architekturlehre vom 19. bis ins 21. Jahrhundert

Der Tagungsband versammelt erstmals Beiträge internationaler AutorInnen zum Thema "Kunstgeschichte an Polytechniken, Technischen Hochschulen und Technischen Universitäten" im deutschen Sprachraum. Inhaltlich reicht der Bogen von der Frühzeit des Fachs zu Beginn des 19. Jahrhunderts bis zur Gegenwart. Kunstgeschichte ist ein Grundlagenfach für eine zeitgemäße Architekturausbildung. Angesichts ihrer zentralen Bedeutung überrascht es, dass die Geschichte, die Positionen und die Perspektiven des Fachs an den Polytechniken, an den Technischen Hochschulen und an den Technischen Universitäten bis heute unzureichend erforscht sind. Dies gilt für den Stellenwert im wissenschaftlichen Fachdiskurs, der in den letzten Jahrzehnten fast ausschließlich auf die universitäre Kunstgeschichte beschränkt blieb. Dies trifft ebenso für die besondere Rolle des Faches an den Architekturfakultäten zu. Im Tagungsband werden die Vergangenheit und Gegenwart der Kunstgeschichte im deutschsprachigen Raum untersucht und international kontextualisiert, um daraus Positionen für die Zukunft zu entwickeln: Was sind heute und was waren seit mehr als 150 Jahren die Aufgaben des Fachs an den genannten Institutionen, und was werden sie in Zukunft sein?

Werkzeuge für Ideen

Bei der Kommunikation zwischen Experten und Laien kommt es immer wieder - trotz bester Absichten auf beiden Seiten - zu grundlegenden Verständigungsschwierigkeiten. Mit den Gründen und möglichen Lösungen dieses Phänomens beschäftigt sich der psychologische Ansatz der Experten-Laien-Kommunikation. Dieser Ansatz wird in dem vorliegenden Buch auf das Gebiet der Architektur angewandt. Anhand einer empirischen Untersuchungsreihe werden die Sichtweisen von Architekten und Laien detailliert beschrieben und miteinander verglichen. Es wird gezeigt, welche Unterschiede im Wissen, in der Wahrnehmung und im ästhetischen Urteil die Kommunikation erschweren. Der Entwurf eines Trainingskonzepts zur Verbesserung der Experten-Laien-Kommunikation rundet das Buch ab. Dr. phil. nat. Riklef Rambow (Jhg. 1964) beschäftigt sich seit zehn Jahren in Forschung, Lehre und Beratung mit der Wahrnehmung und der Vermittlung von Architektur. Er ist Wissenschaftlicher Angestellter am Psychologischen Institut III der Universität Münster und Geschäftsführer von PSY:PLAN, Institut für Architektur- und Umweltpsychologie, Frankfurt/Main.

Archäologische Universitätsmuseen und -sammlungen im Spannungsfeld von Forschung, Lehre und Öffentlichkeit

Dieser Band stellt Konzepte für eine Theorie und Lehre der Architektur von der Antike bis zur Gegenwart vor. Bis ins späte 19. Jahrhundert änderten sich Bauprozesse und -techniken evolutionär. Das 19. Jahrhundert ist auch im Bauwesen geprägt vom Glauben an Fortschritt durch Wissenschaft: Ausgehend vom revolutionären Frankreich, entwickelte sich eine akademische Ausbildung für Bauberufe. Morality and the Human Goods

A concise and accessible introduction to natural law ethics, this book introduces readers to the mainstream tradition of Western moral philosophy. Building on philosophers from Plato through Aquinas to John Finnis, Alfonso Gómez-Lobo links morality to the protection of basic human goods — life, family, friendship, work and play, the experience of beauty, knowledge, and integrity — elements essential to a flourishing, happy human life. Gómez-Lobo begins with a discussion of Plato's *Crito* as an introduction to the practice of moral philosophy, showing that it requires that its participants treat each other as equals and offer rational arguments to persuade each other. The human goods form the basis for moral norms that provide a standard by which actions can be evaluated: do they support or harm the human goods? He argues that moral norms should be understood as a system of rules whose rationale is the protection and enhancement of human goods. A moral norm that does not enjoin the preservation or enhancement of a specific good is unjustifiable. Shifting to a case study approach, Gómez-Lobo applies these principles to a discussion of abortion and euthanasia. The book ends with a brief treatment of rival positions, including utilitarianism and libertarianism, and of conscience as our ultimate moral guide. Written as an introductory text for students of ethics and natural law, *Morality and the Human Goods* makes arguments consistent with Catholic teaching but is not based on theological considerations.
