Philosophy manual: a South-South perspective

Five Great Odes

This French medieval text is now published in its entirety, accompanied by an introduction and extensive synopses in English. Philippe de Mezieres (1327-1405) was a French soldier, publicist and statesman who travelled widely through much of the Christian world and served a number of rulers, particularly the King of Cyprus and Charles V and VI of France. Throughout his life Philippe de Mezieres was obsessed by the ideal that the West must reform itself in the light of the Christian view of the good life and he urged all Christian rulers to join together in a final crusade to liberate the Holy Land and the eastern Christian empires. This is the underlying theme of *Le Songe du Vieil Pelerin*, Philippe de Mezieres' major work. It is divided into three parts: the first is a wide-ranging survey of the Christian world, the second an examination of the state of France and the third a study of the duties and requirements of authority. The style is highly allegorical but contains much personal observation and historical fact.

Being and Nothingness

Under the pseudonym Eza Boto, Mongo Beti wrote *Ville cruelle* (Cruel City) in 1954 before he came to the world's attention with the publication of *Le pauvre Christ de Bomba* (The Poor Christ of Bomba). *Cruel City* tells the story of a young man's attempt to cope with capitalism and the rapid urbanization of his country. Banda, the protagonist, sets off to sell the year's cocoa harvest to earn the bride price for the woman he has chosen to wed. Due to a series of misfortunes, Banda loses both his crop and his bride to be. Making his way to the city, Banda is witness to a changing Africa, and as his journey progresses, the novel mirrors these changes in its style and language. Published here with the author's essay "Romancing Africa," the novel signifies a pivotal moment in African literature, a deliberate challenge to colonialism, and a new kind of African writing.

Arabic literature sprang into existence in the sixth and seventh centuries AD with an outburst of poetry. Across northern Arabia, poets recited qasidas (odes), in which a series of themes is elaborated with vivid, imaginative language and cast in complex rhythmic and rhyming schemes. These seven odes are known collectively as the Mu'allaqat, the "suspended" poems, because they were transcribed in letters of gold on linen and suspended in the shrine of the Kaaba at Mecca as masterpieces of the qasida form. Desmond O'Grady's verse renderings of the odes capture the rhythm and spirit of this vibrant art. The known facts of the poets' lives serve as brief introductions.

A Cannibal and Melancholy Mourning

Continues religious view of Quest for Historical Jesus. Immediately after the Gospels, the New Testament takes up the history of the early Christian Church, describing the works of the twelve disciples, and introducing Paul, the man whose influence on the history of Christianity is beyond calculation. Teacher, preacher, conciliator, diplomat, theologian, rule giver, consoler, and martyr, his life and writings became foundations for Christianity. Paul inspired a vast, serious, and intelligent literature that seeks to recapture his meaning, his thinking, and his purpose. In his letters to early Christian communities, Paul gave much practical advice about organization and orthodoxy. These treated the early Christian communities as something more than a group of people who believed in the same faith: they were people bound together by a common spirit unknown before. The significance of that common spirit occupied the greatest of Christian theologians from Athanasius and Augustine through Luther and Calvin. In *The Mysticism of Paul the Apostle* Albert Schweitzer goes against Luther and the Protestant tradition to look at what Paul actually writes in the Epistles to the Romans and Galatians: an emphasis upon the personal experience of the believer with the divine. Paul's mysticism was not like the mysticism elsewhere described as a soul being at one with God. In the mysticism he felt and encouraged, there is

no loss of self but an enriching of it; no erasure of time or place but a comprehension of how time and place fit within the eternal. Schweitzer writes that Paul's mysticism is especially profound, liberating, and precise. Typical of Schweitzer, he introduces readers to his point of view at once, then describes in detail how he came to it, its scholarly antecedents, what its implications are, what objections have been raised, and why all of this matters. To students of the New Testament, this book opens up Paul by presenting him as offering an entirely new kind of mysticism, necessarily and exclusively Christian.
