An Introduction to Antonio Gramsci

This sociological critique of the 'philosophy of praxis' looks at the importance of the concept in the social theory of leading influential Western Marxists such as Lukács, Gramsci, Korsch, Horkheimer, Marcuse and Adorno in the inter-war period. It offers a detailed critique of Marx and Hegel, and explores the validity and implications for sociology of two of Marx's ideas which the later theorists made the centre

piece of their social theory: first, that true theory is authenticated by praxis, and second, its corollary that certain major social transformations should and would in practice render sociology redundant.

Praxis and Method (RLE: Gramsci)

This volume provides evidence for the argument of a central place of pedagogy in the interpretation of Gramsci's political theory. Gramsci's view that 'every relationship of hegemony is necessarily a pedagogical relationship' makes it imperative to dismiss narrow and formal interpretations of his educational theories as applying to schooling only. This book argues that what is required rather is an inquiry into the Italian thinker's broad conceptualisation of pedagogy, which he thought of as a quintessential political activity, central to understanding and transforming society. Preceded by a broad introduction that positions Gramsci in his context and in the literature, the essays in this book critically revisit the many passages of the Prison Notebooks and pre-prison writings where Gramsci addresses the nexus between politics and pedagogy. Some essays apply those concepts to specific contexts. Critical Theory and the Challenge of Praxis

Leon Trotsky and Antonio Gramsci are two of the most important Marxist thinkers of the 20th century. The first and second chapters deal with a still under-investigated aspect of Trotsky's thought, i.e. his reflections on the issue of hegemony. The result is an investigation that offers new insight into both Trotsky's and Gramsci's thought, while proposing a new point of view from which to interpret revolutionary theory and strategy in the contemporary scenario. One of the main topics addressed throughout the three essays is the specific position of the problem of hegemony in a theory of permanent revolution, demonstrating that Trotsky had a particular understanding of the question of hegemony and that Gramsci, in turn, introduced a concept of hegemony that is closely associated with an idea of permanent revolution, such that the dynamics of the relationship between democratic struggles and socialist struggles presented in both theories are very similar.

Perspectives on Gramsci

Antonio Gramsci is one of the few Marxist theoreticians to have considered the role and nature of education, yet paradoxically his revolutionary, political and social theory seems at odds with his conservative approach to the content and processes of schooling. This book, originally published in 1979, examines his educational, political and cultural writings in an effort to resolve this apparent discrepancy. Gramsci's relevance lies in his treatment, in the context of his radical political theory, of themes which currently exercise modern radical educationists. Rethinking Gramsci

Past studies have discussed antebellum and early national sentimental literature by and about women as a retreat from, or criticism of, the burgeoning market. In this landmark study, Joseph Fichtelberg examines how this literature actually helped to bring market behaviors into maturity. Between 1780 and 1870, Americans endured no fewer than seventeen economic depressions. Each one generated sentimental outpourings in which women came to personify the travails of the marketplace. In the early national period, novels like Martha Meredith Read's Margaretta and Isaac Mitchell's The

Asylum depicted resolute heroines who soothed national ills with virtuous vulnerability. While men often languished in such novels, women thrived. Antebellum fictions extend the argument; bankrupt husbands dissolved in sentimental despair, while their wives used a different sensibility to understand, and adapt to, the market itself. These fictions used women characters to think through the problems of economic crisis and growth--a process completed by the Civil War, when popular fictions began to depict merchants and clerks as feminine. To master the market was to act like a woman--virtuous, immune to commercial temptation, and thus pure. This notion, Fichtelberg argues, was crucial to the onset of liberalism and the emergence of the American middle class. In addition to his discussions of popular, though noncanonical, writers such as Read and Mitchell, Fichtelberg also covers well-known authors such as Hector St. John de Crèvecoeur, Olaudah Equiano, and Walt Whitman. He brings to bear neglected sources (including the ledgers of Ralph Waldo Emerson) and interweaves best-selling novels and pamphlets with political debates and contemporary economic analyses to create rich descriptions of the era. A crucial addition to American literary criticism on sentimental literature, Critical Fictions is a groundbreaking analysis of the relations between commercial and sentimental discourses in early American literature as well as a history of early American economics. It will appeal to specialists as well as to the general reader interested in how American culture has portrayed women in ways that express its deepest needs.

Gramsci's Marxism

Housing and Social Theory

Based in a holistic exposition and appraisal of Gramsci's writings that are of relevance to education in neoliberal times, this book--rather than simply applying Gramsci's theories to issues in education--argues that education constitutes the leitmotif of his entire oeuvre and lies at the heart of his conceptualization of the ancient Greek term hegemony that was used by other political theorists before him. Starting from this understanding, the book goes on to compare Gramsci's theories with those of later thinkers in the development of a critical pedagogy that can confront neoliberalism in all its forms.

Gramsci and the History of Dialectical Thought

This anthology brings together key articles translated into English for the first time from Italian debates concerning Antonio Gramsci's writings on language and translation as central to his entire social and political thought. It includes recent scholarship by Italian, German and English-speaking scholars providing important contributions to debates concerning culture, language, Marxism, post-Marxism, and identity as well as the many fields in which Gramsci's notion of hegemony has been influential. Given the growing literature on the role of language and so-called 'global English' within process of globalisation or cultural and economic imperialism, this is a timely collection. Franco Lo Piparo is often cited as the key source for how Gramsci's university studies in linguistics is at the core of his entire political theory, and yet none of this work has been translated into English nor have the debates that it spawned. Lo Piparo's specific thesis concerning the 'non-Marxist roots' of Gramsci's originality and the critical responses to it have been almost unknown to non-Italian readers. These debates paved the way for important recent Italian work on the role of the concept of 'translation' in Gramsci's thought. While translation has become a staple metaphor in discussions of multiculturalism, globalization, and the politics of recognition, until now, Gramsci's focus on it has been undeveloped. What is at stake in this literature is more than Gramsci's understanding of language as one of the many themes in his writings, but the core of his central ideas including hegemony, culture, the philosophy of praxis, and Marxism in general. This volume presents the most important arguments of these debates in

English in conjunction with the latest research on these central aspects of Gramsci's thought. The essays this volume rectify lacunae concerning language and translation in Gramsci's writings. They open dialogue and connections between Gramscian approaches to the relationships among language, culture, political economy, and historical materialism with other Marxist and non-Marxist thinkers such as Walter Benjamin, Valentin Volosinov, Mikhail Bakhtin, Ludwig Wittgenstein, Jurgen Habermas, Pierre Bourdieu, Michel Foucault, and Jacques Derrida. It provides novel arguments concerning Gramsci's theories and the relationships among power, politics, language, consciousness, and capitalism.

Hegemony and Education Under Neoliberalism

This book will offer a full reconstruction of the history of Theoretical Marxism in Italy between 1895 and 1935, based on a rigorous philological method. The starting term (1895) is marked by the publication of Antonio Labriola's first essay on historical materialism (In memory of Communist Manifesto); the final term coincides with the conclusion of the "Prison Notebooks" written by Antonio Gramsci. This book analyses the original character of the Marxist philosophy in Italy, which emerged by distinguishing itself from the "orthodoxy" of the Second and Third International. By delineating a significant chapter in the history of Marxism, the book will also propose a specific contribution to the history of Italian Philosophy, which is here studied in relation to the developments of European philosophy, beyond the traditional subdivisions of Positivism, Idealism and Marxism.

Gramsci, Language, and Translation
