### **Epochs in Buddhist History**

Since 1911 it has been my privilege to make four journeys into Korea, so long known as "The Hermit Kingdom." To-day Korea has ceased to be an independent nation; she has been completely absorbed by Japan and forms part of the Japanese Empire. I found much of interest in the country. I studied the people and their daily life; I visited many of the famous points of interest and beauty; I have studied somewhat into Korean history. Nothing, however, has more interested me than the study of Korean religions, particularly Buddhism. When asked to give some public lectures this summer, I consented gladly to speak for three evenings on the subject of Korean Buddhism. My three lectures will deal with History—Condition—Art. The history of Korea falls into three sharply marked periods. The first

is known as the era of the Three Kingdoms—it ended with the year 918, a year easy to remember because exactly one thousand years ago. The second is the period of the Koryu Dynasty; it began with the year 918 and ended in 1392, a date easy for us to remember because precisely a century before the discovery of America by Columbus. The third period, known as the period of the Yi Dynasty, began with 1392 and continued until 1910, when the independent history of Korea ended with its absorption by Japan. The history of Buddhism in Korea is divided into the same three periods, as the things which caused breaks in the national history were related to the religion. We shall then speak of the Buddhism of the Three Kingdoms, of the Koryu Dynasty and of the Yi Dynasty.

# **Epochs in Buddhist History**

The study of Cambodian religion has long been hampered by a lack of easily accessible scholarship. Historical sections cover the dominant role of tantric Mahayana concepts and rituals under the last great king of Angkor, Jayavarman VII (1181–c. 1220); the rise of Theravada traditions after the collapse of the Angkorian civilization; the impact of foreign influences on the development of the nineteenth-century monastic order; and politicized Buddhism and the Buddhist contribution to an emerging sense of Khmer nationhood. The Buddhism practiced in Cambodia has much in common with parallel traditions in Thailand and Sri Lanka, yet there are also significant differences. The book concentrates on these and illustrates how a distinctly Cambodian Theravada developed by accommodating itself to premodern Khmer modes of thought. Following the overthrow of Prince Sihanouk in 1970, Cambodia slid rapidly into disorder and violence. Later chapters chart the elimination of institutional Buddhism under the Khmer Rouge and its gradual reemergence after Pol Pot, the restoration of the monastic order's prerevolutionary institutional forms, and the emergence of contemporary Buddhist groupings.

# Korean Buddhism: History, Condition and Art

# The DîpavaCsa

The Tripitaka Master Xuanzang (A.D. 600-64), whose deeds and career as a Buddhist monk are described in this biography, was a prominent figure not only in the history of Buddhist learning but also in other fields of culture. He played a role in the establishment of friendly contacts between China and the countries through which he traveled in search of more knowledge of Buddhism and incidentally but not insignificantly provided posterity with data of historical value in his detailed records about regions in central Asia and particularly in ancient India. He is thus respected not only by the Buddhists and people of China but also by the peoples of other eastern Asian countries who have benefited from the Buddhist lore that he acquired through many hardships and perils during his seventeen-year journey, from 629 to 645, in foreign lands. Because of his translation of Buddhist text into Chinese, Xuanzang was an epoch-making figure in the history of Buddhism in China. Huili, the author of this biography, was born in 614 and became a monk at the age of fifteen. Out of his admiration for the Venerable Xuanzang, he wrote this biography about how the Master went to India to seek Buddhist texts and translate them into Chinese. The biography relates events up to the Master's arrival in the capital at the conclusion of his return journey from India and was compiled and edited by the monk Yancong, who added five fascicles to the original to relate the Master's activities after his return to China up to his death. He thus produced a more complete biography of the Venerable Tripitaka Master Xuanzang, which is presented here in the English version.

#### **Buddhism**

Asiatic art and culture went hand in hand, and how well Okakura wrote about both!

### The Bodhisattva Doctrine in Buddhist Sanskrit Literature

This extraordinary book is the only authentic document of its kind. With irrefutable arguments and considerable ratiocinative skill does the writer conclude that the Mahasanghikas were evidently the earliest school of the Hinayanists to show a tendency towards conceiving Buddha docetically.
